प्रिय सभासदमित्रांनो,

२० जून २०१२ ला आषाढी एकादशी निमित्त पंढरपूर गाव विठ्ठल भक्तांनो गजबजून गेले होते. या वारीची खासियत तशीच आहे. गावोगावातून, खेड्यातून लोक या वारीत मोठ्या उत्साहाने सामील होतात. वारीचा मनसोक्तआनंद लुटतात. १९ जुलै २०१२ रोजी आपल्या असोसिएशनची वार्षिक सर्वसाधारण सभा पुण्यात संपन्न झाली. आपली ही दरवर्षीची सभा म्हणजे एक वारीच असते. निरनिराळ्या गावातून आलेले आपले उत्साही स्त्री-पुरुष सभासद या वारीत हजेरी लावतात. विठ्ठलाचे नाही परंतु बऱ्याच जुन्या सहकाऱ्यांचे, मित्रांचे-मैत्रिणींचे दर्शन, भेट या वारीत नक्कीच होते. येथेही आपले ४/५ सभासद प्रसंगी त्याही पेक्षा जास्त जण रिंगण करून गप्पा गोष्टी, हास्य विनोद करून संवाद साधत होते, जो आजकाल दुर्मिळ होत चालला आहे.

लहानपणी मुलांची खेळता खेळता भांडणे झाली की मुले एकमेकांशी 'गट्टी फू' करत. मग लहानग्यांची आईकडे तक्रार, 'मुलांनी माइयाशी गट्टी फू केली.' थोडक्यात मुले आता आपल्याशी बोलणार नाहीत ही एक प्रकारे त्यांना शिक्षाच वाटे. मग मोठी माणसे मुलांची समजूत काढून भांडणे मिटवत असत आणि त्यांना बोलके करत. लहानपणातच संवादाचे महत्त्व किती आहे हे अजाण मुलांच्या छोट्या तक्रारी वरून आपणास दिसून येते.

लग्न समारंभ, मुंज, वाढदिवस आणि इतर अशाच काही महत्त्वाच्या प्रसंगी आपण एकत्र येतो आणि या दुर्मिळ संधीचा फायदा घेतो. संवादाला भरती येते, हास्य विनोद होतात, वेळ मजेत, आनंदात जातो. एक मात्र खरे की ज्यांच्याशी आपण संवाद करीत असतो त्यांच्याशी विनम्रतेने संवाद केल्यास कार्यातील सकारात्मक वाढीस तो प्रेरक ठरतो तसेच बोलणाऱ्यालाही आणि ऐकणाऱ्यालाही आनंद, समाधान प्राप्त होते. संवादात इतरांची निंदा, कुचेष्टा, टिंगल नसावी. स्वत:विषयी कमीच बोलावे. काय बोलावे, कुठे बोलावे, कसे बोलावे, किती बोलावे, कुठे थांबावे इ. गोष्टी जाणीवपूर्वक आपण सांभाळल्या पाहिजेत. नाहीतर संवादाचे बडबडीत रूपांतर होते आणि असा संवाद आनंददायक न होता नीरस, कंटाळवाणा होतो व त्यातील निकोपता हरवून जाते.

Proceedings of the 25th Annual General Meeting held at Shri Shivaji Mandir (Natya Gruha), Dadar (W) on Wednesday the 27th March, 2012

The Meeting began at 11.30 a.m. as scheduled. Shri P.A. Lopes was to anchor the Meeting. He extended a warm welcome to each and everyone attending the Meeting Sitting on the dais were :

- 1) Shri V.M. Gokhale President SBIPA Mumbai Circle
- 2) Shri S.B. Gokhale President SBIPA Mumbai ZSC
- 3) Shri P.M. Narkar Vice President SBIPA Mumbai Circle & President SBIPA Goa ZSC

Shri Lopes invited the following dignitaries to occupy the chairs on the dais.

- 1) Shri M.M. Sirdeshmukh Jt. Secretary SBIPA, Mumbai Circle
- 2) Shri J.S. Vakil Secretary SBIPA Nagpur ZSC
- 3) Shri D.A. Kulkarni Treasurer SBIPA Mumbai Circle

Shri Lopes read out the messages received from the followingpersons giving Best Wishes for the Annual General Meeting of Mumbai Zonal Sub-Centre.

Shri N.K. Jain - President SBIPA Bhopal Circle Shri R.N. Lalingkar - Secretary SBIPA Mumbai Circle Shri K.D. Paradkar - Senior Member of the Association Shri Rammurthy - DGM Adm. Office, Worli, Mumbai Dr. J.N. Mishra - CGM Mumbai Circle

Shri Lopes then requested Smt.Charulata Save and her team from Dahisar to sing the 'Saraswati-Vandana' and 'Ganesh-Vandana'. After the melodious songs Shri.Lopes continued the proceedings by requesting Shri.V.M. Gokhale, President of the Circle Association, to unveil the publication of the following book/booklet:

- i) An autobiography of a Bank's Pensioner Shri Hari Sadashiv Bhate 'ਧਟ आठवणींचा'. Shri Bhate was unable to attend the function due to ill health. Shri.Gokhale informed the house that the book written by Shri.Bhate describes as to how a person can achieve the desired success through utter hardwork.
- ii) A booklet published by SBI Pensioners' Cultural Mandal. Shri.Gokhale announced that the booklet is very handy for everyone to record own data regarding investments, PF Index
- No, Pension details, etc.

Both the books were distributed to all the Pensioners who attended the Meeting. Shri Lopes thereafter handed over the charge of the dais to Shri.S.B.Gokhale, President, SBIPA Mumbai ZSC for conducting the Meeting as per the Agenda already published in Samvad issue for the month of February 2012.

Shri.S.B.Gokhale took over the charge and began the proceeding as per Agenda.

Agenda item No.1 : To condole the death of Bank's Pensioners / Family Pensioners / Associate Memebrs whose names have been reported to us after 11th February 2011 :

Members were requested to advise the names and date of death of members, if not in the list. Shri.S.B.Gokhale read out the list containing 46 names of the members reported to have been passed

away after the 11th February 2011. Since no more names were advised by the members attending the Meeting, Shri.Gokhale requested the gathering to stand in silence for 2 minutes to pay respect to the departed souls. The gathering stood in silence to pay their respect.

Agenda item No. 2 : To confirm the minutes of the AGM held on 11th February 2011 (Minutes published in May 2011 issue of Samvad) :

The minutes were confirmed without any query.

Agenda Item No.3 : To honour the senior members who have completed 75 years of age between 12th February 2011 and 21st March 2012 (both days inclusive) :

Shri.Gokhale announced that this item of Agenda would be taken up after lunch session since the Bank's Pensioners' Meet may be required to be taken up any time which would interrupt the felicitation of senior members. So, he proceeded to the Agenda item No. 4.

Agenda Item No. 4 : Committee's report for the year 2011 to be read, discussed and adopted. (A copy of the report was published in Samvad issue for February 2012) :

Shri Gokhale made a mention of the following important points of the Report :

a) Review of R.E.M.B.Scheme :- He informed the members that it involved payment of tax on the interest earned on the Corpus Fund of the Scheme. Hence Bank has decided to review the Scheme in 2013 and thereafter take a final decision on various queries / requests raised by the members particularly from VRS and Exit Optee retirees.

b) He informed the gathering / members about the Structured Meeting held by the Mumbai Circle Management with SBIPA Mumbai.

c) Filing of a Writ by the Federation of SBIPA in the Supreme Court of India for squashing of Rule No.23 (ii) in the SBI Pension Fund Rules and payment of Pension @ 50% of last drawn salary.

He clarified that the hearing of the Petition could have begun on 12th March 2012 but Government of India requested time of 4 weeks to file their reply and hence the hearing is now expected to start from the 2nd July 2012.

d) Shri.Gokhale advised the house about the cases filed by different Circle Associations on the matters related to Pensionary benefits in Bangalore, Hyderabad and Kerala High Courts. He however informed the gathering that there was no progress in any of these cases.

After hearing Shri. Gokhale, the gathering adopted the Committee's Report without any discussion.

Agenda Item No. 5 : To discuss the recent developments :

Shri.V.M.Gokhale who was requested to address the gathering about recent developments, began by saying that Shri.S.B.Gokhale has already informed almost everything. However, he would like to enlighten the members on the Supreme Court case etc. He made a mention that Mumbai Circle Association have played a very important role in drafting the petition under the leadership of Shri.B.G.Dandekar. He further said that Shri.Dandekar was unable to attend the meeting due to illness of his wife. Had he attended this Meeting it would have been his 25th continuous appearance at the Annual General Meeting of Mumbai Zonal Sub-Centre.

Shri.V.M.Gokhale further said that the progress of the Supreme Court case was very satisfactory and the Advocates appointed by the Federation, namely Sarvashri K.K.Venugopal and E.C.Vidyasagar, both are confident that the case would go in favour of the Federation. He further clarified that our prayer which asks for 50% Pension of the last drawn salary from 1987 onwards takes care of all the retirees and it also will end our wait for a long time.

Shri.Gokhale further narrated how Government of India played delaying tactics in this Writ Petition.

Firstly, GOI did not appoint their Advocate and when appointed he asked for further time. The court was very much annoyed at these methods and hence passed very harsh strictures on them. Shri. Gokhale read out the latest order of the Hon. Supreme Court in this regard. He hoped that the case would go in our favour before Diwali 2012 since now GOI has no scope for further delay. He said that the situation prevailing presently was a very sad affair. Our Pension appears to have be increased but only due to increase in D.A. Shri. Gokhale explained to the members that our decision to go to the Supreme Court has been taken only after all other avenues of breaking the deadlock created by the GOI were closed. Moreover, the Supreme Court is the only authority who can show proper way to the GOI. Incidently, the GOI was all the while harping on 3 benefits to us. But we have explained in our Writ Petition that 3 benefits is a myth and hence the GOI's stand is not acceptable. He therefore appealed to the members to continue their support to the Association / Federation in the case. In fact, he thanked the members for the overwhelming support to his appeal for a minimum of Rs.100/- as Donation to the 'Legal Fund' since expenses of the Supreme Court case are very high (almost Rs.5.00 Lacs per hearing). Mumbai Circle alone had collected more than Rs.14.00 lacs. He specially thanked the retired Senior Officers of the Bank (AGM & above) for contributing a minimum of Rs.5000/- for the purpose. Shri.V.M.Gokhale further told that we also have filed cases for different pensionary benefits in other High Courts in the country, but the case in Supreme Court for 50% pension, when won, will give solace to all of us. While concluding his speech Shri.V.M.Gokhale said that there are many pitfalls in the REMBScheme, for example -

- i) Those who retired after attaining 50,55,58 years of age i.e. after attaining superannuation age as per Bank's the then existing rules, have not been given permission to join this scheme.
- ii) VRS & Exit optees have been left out.

However all these issues would be resolved only after 2013 when the Bank will take a review of the scheme.

Agenda Item No. 9 : Any other matter with the permission of the chair :

Shri.S.B.Gokhale thereafter read out a plea from some VRS optee lady members from Thane who were doubtful that as per our Writ 30 years of pensionable service could be the criteria for getting 50% pension and hence if they had put in less than 30 years of Pensionable Service, then what could be the position? Shri.Gokhale explained that their pension would be calculated on the pro-rata basis and will be fixed accordingly.

Shri.Kiran Jog was given time to explain about career counseling. Then Shri.Joshi appealed to the gathering for 'Donation of their bodies (देहदान) after the death'. Shri.V.M.Gokhale requested Shri.Joshi to furnish a write up on the matter which will be published in 'Samvad' for appeal to all the members.

At this juncture, Shri.N.S.Kujur, CGM (HR), Corporate Centre, arrived and it marked the beginning of "Bank's Pensioners' Meet". Just after arrival of Shri.Kujur, the following dignitaries also arrived for the meeting.

- 1) Shri.O.P.Punia, Dy.GM & CDO, Mumbai Circle
- 2) Smt.Dr.V.M.Ajinkya, Chief Medical Officer, Corporate Centre
- 3) Smt.Dr.Manjusha Padhye, Medical Officer
- 4) Smt.Madhuri Sathe, Welfare Officer, Mumbai LHO

All were offered a welcome with flowers. Shri.Kujur, CGM, congratulated the gathering for remaining present at the Meeting in a large numbers and thanked everyone for giving him opportunity to speak. Shri.Kujur expressed anxiety on the various complaints from the customers and mentioned

that these should be viewed in the correct perspective. He mentioned that while SBI is doing very well on business front, other Public Sector Banks are offering better service. He, therefore, appealed to all the Pensioners of the Bank that whenever they visit any Branch and if they notice any complaint from any customers, they should inform the concerned authorities at the Branch and get the complaint redressed. This, he said, was very necessary since every pensioner of the Bank still happens to be a part of the Bank. If the Bank is to be the leader in the business, then the best customer service is the key and all the pensioners can help the Bank in achieving this goal. Shri.Kujur once again thanked everyone for the platform provided to him for addressing such a good gathering of pensioners.

Shri.V.M.Gokhale, President, who spoke thereafter mentioned that Shri.Kujur has very recently arrived at Corporate Centre, but he is very receptive to our problems. In fact all the Corporate Centre officials are very co-operative and are keen to solve our problems. He met Shri.Kujur recently when he called on him to give him the invitation of this Meeting. As Shri.Kujur had recently assumed charge as CGM, he was not expecting that he will grace the Meeting by his presence. But now he feels pleasantly surprised when he could see the attendance of our CGM at a very short notice and therefore profusely thanked him for his gesture.

Shri.O.P.Punia, Dy.GM & CDO, Mumbai LHO, expressed high regards about contribution of every one present in the meeting to the Bank and thanked them. He thereafter mentioned that nearly 7 dispensaries have been opened in the last six months. However he was aware that more dispensaries could be opened, but several problems like space, availability of Medical Staff etc. were required to be overcome. He mentioned that for any of your problems he was always available and he would try to give solution to it.

A lady pensioner from Mahim Branch came up on the dais and told about her problem about submission of Life certificate every year, since she had settled in New Zealand. Shri.Punia noted down her problem and promised her of a solution shortly.

Shri Lopes who was on the dais mentioned to the Dy.GM & CDO that we are not here with complaints alone, but we also want to appreciate the excellent service offered to us by the Branch Managers and the Staff members who are looking after the work pertaining to the pensioners at the following branches :

Vile Parle (W); Thane (Main); Naupada Thane; Mulund East & West; MIDC Dombivli; Kandivali (W); Vakola (Santacruz).

Several questions were put before the Bank's Medical officers attending the Meeting and most of the queries were replied properly by them. Thereafter, a Lunch Break was taken.

After the lunch break, the Meeting again began with the Felicitation of the Pensioners who have completed 75 years of age during the period since last meeting. Out of such (96) pensioner members, nearly 40 pensioner members were present and were felicitated.

One of the Family Pensioner Smt.Naik was very appreciative of the efforts of the office-bearers of the Association and lauded their work and enthusiasm even after retirement. She congratulated the Association for sending birthday greeting card every year without fail. She was very pleased with the work of the Association. Shri.V.M.Gokhale in a quick response thanked Smt.Naik for her praise and invited Shri.Chate on the dais, our member from Pune HQ who manages the work relating to dispatch of Birthday Greetings. Shri.Gokhale expressed extreme satisfaction at his work. Shri.Chate in his reply thanked the members for appreciation of his work and mentioned that he would continue to do similar work in future also. He was felicitated with flowers.

Shri.D.R.Gururao was the only pensioner who was present at the Meeting whose birthday had fallen on the day of the Meeting. He was also felicitated. Shri.J.B.Pusalkar, Treasurer of Mumbai

Zonal Sub-centre thanked everyone for giving Donations to the Association and declared that the Donations received during the day were to the tune of Rs.1,47,000/-. Shri.V.M.Kanhere, who works as a Librarian at Thane Office was also felicitated for his excellent work.

STAFF PENSION PROCESSING CELL

We refer to Circular No.CDO/P&HRD-P/2009-10 dt. 4th April 2009 and Circular No.CDO/P&HRD-HRMS/2011-12 dt. 30th March 2012.

2. Pension and family pension pertaining to employees of State Bank of India and Imperial Bank of India was being processed and paid through HRMS portal. Centralised Staff Pension Processing Cell (CSPPC) has now been set-up at Central Accounts Office, Kolkata. From May 2012, pension / family is being processed and paid by CSPPC.

3. **PAYMENT CALENDER :** During the financial year 2012-13, pension / family pension will be paid on the dates given in Annexure-I.

4. DATA ENTRY : Existing data has been migrated from HRMS to CSPPC portal. Local Head Offices will now send all new cases of pension / family pension and cases of modifications in existing data to CSPPC for entry in the new portal. All such advices are to be signed by an officer not below the rank of Assistant General Manager. CSPPC will be responsible for entry and authorisation of the data in the portal. Processing of pension will be done one day (not being a Saturday or holiday) prior to the payment date. All data entry made and authorised upto the processing time will be taken into account while processing the pension for the month. Modifications / updation of data such as address, phone No, e-mail address, PAN No. etc. are to be advised by branches to CSPPC through the respective Local Head Offices. Data Entry is to be advised to CSPPC in format given in Annexure-II. (Not reproduced since it is meant for Bank staff)

5. **COMMUTATION :** Commutation amount of pension will now be paid through CSPPC. The amount and date of payment of Commuted amount is to be advised to CSPPC by the LHO. Recovery on account of commutation will be made for 15 years from the date of disbursement of the commuted amount. Depending on the date of payment of commuted amount, recovery will be made proportionately in the start and end month of this 15 year period.

6. **ENQUIRY :** Enquiry rights are available at all branches and Local Head Offices. The branches can access the portal through Channel G portal using the user ID and password as used for accessing Channel G (portal for payment of Central / State Government pension). In case of any creation / modification of user ID, the branches are to contact the Circle CPPC. For Local Head Offices, user administration is with CSPPC.

7. **PENSION SLIP**: The rights to view and print monthly pension statement of individual pensioners are available with the branches and Local Head Offices.

8. LIFE CERTIFICATE / NON-MARRIAGE CERTIFICATE : The branch, where the certificate is submitted is to enter the details in the CSPPC portal. All entries are to be authorised.

9. DEATH OF PENSIONER / FAMILY PENSIONER : On receipt of report of death of the pensioner / family pensioner, the pension paying branch is to record the date of death in the portal and authorize the entry. This will temporarily suspend the pension payment. Death certificate is to be sent to CSPPC through the respective LHO. CSPPC will accept the entry of the branch and initiate further action such as conversion to family pension, closing the account on making

balance payment or effect recovery, if any. In cases where death of the pensioner is reported late, reporting of recovery of excess pension paid will remain the responsibility of the pension paying branch / PPG Dept. at LHO. Branches are to calculate the excess amount paid and advise CSPPC Kolkata. CSPPC Kolkata will recover the amount and refund it to CAO Kolkata and maintain the record of refund for each pensioner.

10. INVESTMENT DECLARATION FORM / FORM 16 : Investment declaration form is to be submitted by the pensioners / family pensioners at their respective pension paying branch. The branch will input the details in the CSPPC portal and authorise the data. Form 16 will be made available to the pension paying branches at the end of the financial year. Pension paying branches are to download and print the Form 16 and provide a duly signed copy to the pensioner. The pension paying branches will be responsible for verifying the proof of investments made by the pensioner for tax purposes.

11. ONLINE FACILITY: Facility for online submission of Investment Declaration and for viewing and printing of pension slip is also available at the url www.sbi.co.in/sbipension/user.htm. Online submission of Investment Declaration Form does not require any authentication and data submitted by the pensioner will be taken into account as such while computing TDS. A link to the url is also being made available through the HRMS website.

12. TAX DEDUCTED AT SOURCE : Income tax on pension paid will be recovered by CSPPC in terms of the Income Tax Act. TDS will be credited to the Sundry Deposit Account - TDS i.e. BGL 98747 bbbbbc ('bbbbb' being the 5 digit branch code and 'c' being check digit) at the pension paying branches every month. The branches will be responsible for deposit of the income tax with Income Tax Department in terms of Circular No.CDO/P&HRD-HRMS/20/2011-12 dated 30th March 2012.

13. REPORTS: Various reports such those on Certificate submission, Commutation details, discontinued users, new accounts opened, pension transactions etc. are available to the branches.

14. NON-MIGRATION OF ACCOUNTS : In cases where, for some reason, pension accounts have not been migrated from HRMS, the proposal for fresh data entry is to be sent to CSPPC through the respective LHO.

असोसिएशनतर्फे १९९९ सालापासून असोसिएशनचे उत्चृष्ट कार्य अनेक वर्षे सातत्याने करणाऱ्या कार्यकर्त्याचा 'कै.ल.ना.पाबळकर स्मृति सुवर्णापदक' देऊन गौरव करण्यात येतो. यंदा हे 'सुवर्णपदक' पुणे येथील श्री.माधव बापट यांना प्रदान करण्यात आले. असोसिएशनच्या सर्व सभासदांना (म्हणजे जवळ जवळ १७००० चे वर सभासदांना) त्यांचे वाढदिवसाचे दिवशी शुभेच्छाकार्ड पाठविण्याचे काम श्री.बापट गेली १९ वर्षे अरवंडपणे करीत होते. याबद्दल सर्व सभासदांचे मनात त्यांचेबद्दल कृतज्ञता वादन असे व पर्यायाने असोसिएशनचे प्रती आपुलकी वाठून ते असोसिएशनला देणगी देत असत. त्यांच्या या कार्याचा गौरव करण्याचे असोसिएशनच्या मॅनेजिंग कमिटीने ठरविले व यावर्षीच्या या वार्षिक सभेत अध्यक्षांचे हस्ते त्यांचा व त्यांच्या पत्नि सौ.विजयाताई यांचा यथोचित सत्कार करण्यात आला. या कार्यक्रमाचे सूत्रसंचालन श्री.मधुकर पालकर यांनी वेत्रे. सुरूवातीस श्री.पालकरांनी श्री.बापट यांना देण्यात येणाऱ्या मानपत्राचे वाचन वेत्रे. यानंतर अध्यक्ष श्री.गोरवले यांचे हस्ते श्री.बापट यांना 'कै.ल.ना.पाबळकर स्मृती सुवर्णपदक' व मानपत्र प्रदान करण्यात आले आणि शाल व श्रीपळ देऊन त्यांचा बहुमान करण्यात आता. त्याचबरोबर, सौ.विजयाताई बापट यांचाही पुष्पगुच्छव श्रीपळ्य देऊन श्रीमती रेखा कुरक्यर्णी यांनी सत्कार वेत्र्या. टळ्यांच्या कड्यक्ष आता. त्याचबरोबर, सौ.विजयाताई बापट यांचाही पुष्पगुच्छव श्रीपळ्य देऊन श्रीमती रेखा कुरक्यर्णी यांनी सत्कार केला. डाळ्यांच्या कडक्डाटात हा सत्कार सोहळा पार पडला. अध्यक्ष श्री.गोरवले यांनी आपल्या भाषणात श्री.बापट यांच्या उत्कृष्ट कार्याचा गौरव वेत्रा. श्री.बापट यांनी सत्कारास उत्तर देतांना आपल्या सत्काराबद्दल असोसिएशनचे मनःपूर्वक आभार मानले व या कामात त्यांच्या घरातील सर्वांनी, विशेषत: सून सौ.वेष्णवीने केलेल्या मदतीचा, तसेच त्यांच्या सोसायटीतील दोन सहकाऱ्यांच्या मदतीचा आवर्जून उल्लेय.

त्यानंतर असोसिएशनचे रवजिनदार श्री.डी.ए.कुलकर्णी यांनी सन २०११–२०१२ या वर्षचि नफन–तोव पत्रकव ताळेबंद पत्रकसभागृहापुढे मंजुरीसाठी ठेवले. ते सभागृहाने एकमताने मंजूर केले. यानंतर नागपूर झोनल सब् सेटरचे नवनिर्वाचित अध्यक्ष श्री.व्ही.डी.देशपांडे यांनी असोसिएशनच्या पदाधिकाऱ्यांच्या द्वैवार्षिक निवडणूकीच्या संदर्भात आपले मनोगत व्यक्त केले. ते म्हणाले की, फक्त अध्यक्षपदासाठीच दोन नॉमिनेशन्स आल्यामुळे त्या पदासाठी ते स्वतः व श्री.व्ही.एम.गोरवले यांचे मध्येच निवडणूक होणार आहे व बाकी पदांसाठी एकेकच नॉमिनेशन आल्याने त्या पदांची बिनविरोध निवड होणार आहे. हे समजल्यावर त्यांनी फेरविचार करून, श्री.गोरवले हे वयाने व असोसिएशनच्या कामामध्ये त्यांच्यापेक्षा ज्येष्ठ आहेत म्हणून त्यांच्यासाठी, तसेच संघठनेची ताकद वाढावी म्हणून ते आपले नॉमिनेशन मागे घेत असून ते श्री.गोरवले यांना मन:पूर्वक पाठिबा देत आहेत असे सांगितले. त्यांच्या या निर्णयाचे वळ्यांच्या प्रचंड कडकडावत स्वागत करण्यात आले. श्री.देशपांडे यांनी हा जो मनाचा मोठेपणा दाखविला त्याबद्दल श्री.रबडे यांनी त्यांचे अभिनंदन केले.

यानंतर, पुणे येथील पौडरोड शारवेतील बॅंकेच्या डिस्पेन्सरीतील मेडिकल ऑफिसर डॉ.वैशाली नाईक या आपल्या निमंत्रणावरून सभेस हजर होत्या. त्यांनी आपले मनोगत यावेळी व्यक्त करून आपला परिचय करून दिला व पौडरोड परिसरात राहणाऱ्या सर्व सभासदांनी या डिस्पेन्सरीचा लाभ घ्यावा अशी विनंती केली. यानंतर डॉ.वैशाली नाईक यांचा मा.अध्यक्षांचे हस्ते पुष्पगुच्छ देऊन सत्कार करण्यात आला. यानंतर श्री.नारकर व श्री.साहेबराव देसाई यांनी श्री.व्ही.डी.देशपांडे यांच्या निर्णयाचे स्वागत करून त्यांचे त्याबदल अभिनंदन केले. श्री.गोरवले यांनीही या प्रसंगी आपले मनोगत व्यक्त करतांना असे सांगितले की, रवरं म्हणजे ते अध्यक्षपदावरून निवृत्त होणार होते. पण आपल्या सुप्रीम कोर्वतील केसच्या संदर्भात श्री.दांडेकर व श्री.एस.बी.गोरवले यांचे बरोबरीने त्यांचा ही केस दारवल केल्यापासूनचा असलेला सहभाग लक्षात घेतां, आणि केस निर्णायक अशा अवस्थेत आल्याने आणि मुंबई सर्वत्लचा फेडरेशनच्या कामामध्ये असलेला सहभाग लक्षात घेता, त्यांनी सध्या निवृत्ती घेऊ नये अशी इच्छा श्री.दांडेकरांसारख्या अजूलही कार्यरत असलेल्या व्यक्तीने केल्यामुळेच त्यांनी नॉमिनेशन दारवल केले आहे. पण आत् श्री.व्ही.डी.देशपांडे यांनी नॉमिनेशन मोठ्या मनाने मागे घेऊन अध्यक्षपदाची निवडणूकसुद्धा बिनविरोध व्हावी अशी इच्छा प्रदर्शत केली, त्याबद्दल त्यांनी श्री.देशपांडे यांचे अभिनंदन केले.

त्यानंतर निवडणूक अधिकारी श्री.एस.जी.रबडे यांनी निवडणूक प्रक्रिया सुरू केली. ते म्हणाले की श्री.व्ही.डी.देशपांडे यांनी आपले नॉमिनेशन मागे घेतले असल्याने व बाकीच्या पदांपैकी जॉइंट सेक्रेटरी पदासाठी श्री.विलास गंधे व ट्रेझरर पदासाठी श्री.डी.ए.कुलकर्णी यांचेच फक्त नॉमिनेशन्स आले आहेत. पण सेक्रेटरी पदासाठी कोणाचेच नॉमिनेशन न आल्याने व त्यासाठी आपले अध्यक्ष श्री.गोरवले व इतर पदाधिकाऱ्यांनी प्रयत्न करूनसुद्धा, कोणीही सेक्रेटरी म्हणून काम करावयास पुढे आलेले नाही व नॉमिनेशन भरले नाही. त्यामुळे अशा परिस्थितीत सध्याच्याच सेक्रेटरींना, त्यांनी पुढील दोन वर्षे सेक्रेटरी म्हणून काम पहावे, अशी सूचना आपण करणार आहोत. या सूचनेला सभागृहाची मान्यता असेल, तर त्यांचे नॉमिनेशन नसतांनासुद्धा त्यांचे नाव सेक्रेटरीपदासाठी जाहीर करू असे सांगितले व असे सुचवले की,

सभागृहाने सेक्रेटरीपदासाठी लळिंगकर यांच्या नावाला मान्यता द्यावी. अशा तन्हेने अध्यक्ष म्हणून श्री.व्ही.एम.गोरवले, सेक्रेटरी म्हणून श्री.रा.ना.लळिंगकर, जॉइंट सेक्रेटरी म्हणून श्री.विलास गंधे व ट्रेझरर म्हणून श्री.डी.ए.कुलकर्णी हे बिनविरोध निवडून आले असे शेवटी श्री.रबडेयांनी घोषित केले व त्यास सभागृहाने टळ्या वाजवून अनुमोदन दिले. श्री.रबडेयांनी अशी अपेक्षा व्यक्त केली की सेक्रेटरींच्या कामाचा भार हलका करण्यासाठी सभासदांनी स्वयंस्पूर्त्तीने पुढेयावे व त्यांचे काम वाठून घ्यावे. त्यानंतर श्री.लळिंगकर यांनी या विषयासंबंधी आपले मनोगत व्यक्त केले. ते म्हणाले की, ते जून ९८ मध्ये निवृत्त झाल्यापासून गेली १४ वर्षे असोसिएशनच्या कामात आहेत. त्यापैकी गेली ६ वर्षेते सेक्रेटरी म्हणून काम पाहत आहेत. पण १० महिल्यापूर्वी सुरू झालेल्या गंभीर आजारामुळे इच्छा असूनही ते काम करू शकत नाहीत. सेक्रेटरी हे महत्त्वाचे पद आहे. शिवाय संवाद मासिकाचे संपादन, संगणाकाद्वारे सभासदांचे दैनंदिन रेकॉर्ड ठेवणे व तदनुषांगिक लागणारो रिपोर्टस् बनविणे इ. कामे सातत्याने करावयाची असतात. परंतु आजारपणामुळे त्यास न्याय देता येत नाही. अशा अवस्थेत नवीन सभासदांनी आपणहून पुढेयेञ्च काम करावे अशा अपेक्षेने यावेळेस त्यांनी नॉमिनेशन भरला नव्हता. परंतु सर्वांनी पाहिले की आण्णहून कोणी सेक्रेटरी म्हणून काम करावयास पुढेआलेले नाही. तसेच बाकीच्या पदांसाठीसुद्धा एकेक्वच नॉमिनेशन आले आहे. यावरून असोसिएशनला नवीन रत्साही कर्यकर्त्यांची किती वानवा आहे हे लक्षात येईल. असोसिएशनची सभासद संख्या दिवसेंदिवस वाढत चालली आहे. अपेक्षाही वाढत चालल्या आहेत. त्यामुळे जबाबदारी घेण्यासाठी कोणीतरी पुढे येणे आवश्यक आहे. सध्या ऑफिस्साध्ये जे काम करावयास नियमित येत असतात त्या सर्वंच आभार मानल्यावर, त्यांचे सहकार्य यापुरेही मिळत राहील अशी अपेक्षा त्यांनी व्यक्त केली.

त्यानंतर जून २०१२ च्या संवादमध्ये प्रसिद्ध झालेला मॅनेजिंग कमिटीचा २०११-१२ या वर्षाचा अहवाल सभेपुढे मंजुरीसाठी ठेवण्यात आला. त्यामधे श्री.दांडेकर यांनी सेक्रेटरींना एक दुरूस्ती सुचवली. पान क्र.१५ वर 'फेडरेशन प्रंच्ट' या परिच्छेदात सुप्रीम कोर्टाच्या केसबदद्ल माहिती दिली आहे. त्यात 'फेडरेशनने प्रतिज्ञापत्राद्वारे सादर केलेल्या उत्तराला प्रत्युत्तर म्हणून केंद्र सरकारने ४ आठवड्यात प्रतिज्ञापत्र सादर करावे' असे पाहिजे होते, ते चुकूच ४ महिने असे छापले आहे. सेक्रेटरींनी या दुरुस्तीसह मॅनेजिंग कमिटीचा अहवाल सभेपुढे मंजूरीसाठी ठेवला. त्यास सभेने एकमताने मंजुरी दिली. त्यानंतर असोसिएशनला वेगवेगळ्या कामात जे बॅकेचे संबंधित अधिकारी व कर्मचारी मदत करीत असतात त्यांचे, तसेच ऑडिटर्स हिशेब तपासणी करत असतात अशा सर्वांचे आभार मानण्यासाठीचे, असे एकूण ५ ठराव, जे प्रत्येक वार्षिक सभेत मंजूर करत असतो, ते सभेने एकमताने मंजूर केले.

यानंतर श्री.दांडेकर यांनी सुप्रीम कोर्टात दाखल केलेल्या केस विषयी सविस्तर माहिती सांगितली व सुप्रीम कोर्टात केस लढविणे ही अत्यंत रवर्चिक बाब असल्याचे सांगितले. आपल्या केससाठी अंदाजे ६० ते ७० लाख रूपयापर्यंत एकूण खर्च अपेक्षित आहे. म्हणून प्रत्येक सभासदाने किमान रु. १००/- लीगल पंच्डासाठी देणगी देणे अपेक्षित आहे असे सांगितले. केसचा निकाल येत्या ४-५ महिन्यात आपल्या बाजूने लागण्याची दाट शक्यता आहे असे सांगितले. नेहमीप्रमाणे आपल्या भाषणाचे शेवटी श्री.दांडेकरांनी सर्वांना नेत्रदान करण्याचे आवाहन केले.

भोजनाच्या सुटीनंतर बँकेची 'पेन्शनर्स मीट' झाली. बँकेतर्फे पुणे झोनल ऑफिसमधील डेप्युटी जनरल मॅनेजर श्री.वैजिनाथ, चीफ मॅनेजर (एच्.आर.) श्री.गुद्धे चीफ मॅनेजर श्री.कत्ररवानीस व संबंधित डेस्क ऑफिसर श्री.वाघमारे, तसेच संबंधित क्लार्क श्रीमती शिल्पा वारिक हे हजर होते. हेड ऑफिसकडून मात्र कोणीही न आल्याने सभासदांनी नाराजी व्यक्त केली. या सभेत बऱ्याच सभासदांनी प्रामुख्याने पुढील विषयांवर चर्चा केली व प्रश्न विचारले. १) रिव्हाईज्ड फॅमिली पेन्शन ॲडव्हाईस अजूनपर्यंत मिळालेच नाहीत किंवा जे मिळालेत त्यात न्रुटी आहेत. २) बँकेच्या दवारवान्यातील औषधांचा अपुरा पुरवठा. ३) पुणे येथील डायग्नॉस्टिक सेंटर्स कार्यान्वित नाहीत. ४) मेडिकल बिलांच्या मंजुरीस विलंब लागतो. या प्रश्नांना बँकेच्या अधिकाऱ्यांकडून यथोचित उत्तरें देण्यात आली. बँकेचे अधिकारी श्री.वाघमारे व श्रीमती वारिक यांनी केळोवेळी दिलेल्या व देत असलेल्या सहकार्यांबद्दल त्यांचे जाहीर कैतुक करण्यात आले. श्री.वैजिनाथसाहेबांनी आपल्या भाषणात सर्व सभासदांच्या अड्चणींची दरवल घेऊन त्यांचे निराकरण करण्याचे सर्वतोपरी प्रयत्न केले जातील असे आश्वासन दिले. श्री.वाघमारे यांनी आभार मानल्यावर बँकेची पेन्शनर्स मीट समाप्त झाली.

वार्षिक सभेच्या दुपारच्या सत्रात सभासदांच्या प्रश्नोत्तराचा कार्यक्रम झाला. बऱ्याच सभासदांच्या फॅमिली पेन्शन ॲडव्हाईसेस मधील त्रुटींबद्दलच्या प्रश्नांबद्दल श्री.लळिंगकरांनी खुलासा केला की, जुन्या व नवीन ॲडव्हाईसेसच्या प्रती जोडून एक अर्ज आपल्या पेन्शन जमा होणाऱ्या ब्रॅंच मार्फत पी.पी.जी.डिपार्टमेंटला पाठवावा. म्हणजे बॅकेकडून योग्य ती कार्यवाही होईल. सभासदांच्या इतर सर्व प्रश्नांना सर्वश्री व्ही.डी.देशपांडे, पी.एम.नारकर. एस.बी.गोरवले इत्यादी पदाधिकऱ्यांनी यथोचित उत्तरे देऊन सभासदांना मार्गदर्शन केले. श्री.चंद्रकांत कुलकर्णी यांनी शेवटी सर्वांचे आभार मानले व श्री.एस.पी.बर्वे यांनी 'पसायदान' म्हटल्यावर सायं. 4 वाजता ह्या वार्षिक सभेची सांगता झाली. बाहेरगावाहून आलेल्या सभासदांची निवास व्यवस्था उत्तम टेवल्याबद्दल तसेच भोजन व्यवस्थेबद्दल सर्व सभासदांनी समाधान व्यक्त केले.

Contribution of Mind to Disease and Health

Stress is there for everybody in different degrees like pain. It is important as to how we respond to stress. Some people remain calm in most of the situations and hence stress has almost no impact on their physical or emotional health. In fact, heart disease, cancer, etc enter through mind.

Louise L. Hay states in her book, 'You can heal your life "all diseases come from a state of unforgiveness." In other words, if any body has acted against us we should forgive him for the act. We can keep distance from such persons, if need be. She believes that some persons are accident prone due to expression of anger. Those who have forgiven and removed hurt from the mind have no anger and hence they are free from even getting scratches. Sickness, accidents etc are the result of hurt in mind.

Researchers have estimated that almost 90% major illnesses including backache are consequences of disturbed mind. During illness caused by mind there is further contamination with chemicals of drugs resulting into increased secretion of adrenaline, acceleration of heart beats, greater tension in muscles, slower digestion etc. Blood pressure & blood cholesterol may rise, the blood thickens and is more prone to clot formation. The stress hormones affect the immune system.

Those who are not satisfied in life and lack harmonizing relationships are more likely to catch diseases. A positive mental attitude goes a along way in promoting health and remaining free from diseases. Harry Harlow, Psychologist at the University of Wisconsin believed fifty years ago that affection and connection with friends and relatives were the foundation of life. He experimented with baby monkeys by separating some from their mothers giving them wire 'moms' and established that monkeys with bare wire models did not thrive. Subsequently it has been established that ties of friendship with family, friends, neighbours and in general provides health and happiness. Social support also prolongs life but social isolation increases risk of early death.

It is true that we genetically inherit certain traits. Medical experts have acknowledged that the power of thought can tackle this by developing immune system. It is important to remember that those who lived over ninety years or crossed hundred years of age did not have parents with such longevity.

Spirituality helps connecting body, mind and soul while doctors can cure which can be temporary unless the mind heals the disease. To cure chronic disease mental affirmations go a long way. Paramahansa Yogananda said that it is necessary for an individual to dissociate from the concept of limitations of body. God is the creator of the universe and he can do which is apparently impossible. Faith makes us receptive to God's guidance if whatever happens is accepted as God's answer to the unconditional prayer to make us strong. Paramahansa Yogananda had told Sri Sri Daya Mata, his disciple and President for over 55 years of the spiritual organization created by the former and spread world over, "He who is the creator of this universe has power to put into effect any law...... He can resolve any situation for those who appeal to Him (unconditionally) saying "let thy will be done, not mine. I trust thee".

Rather than the reasoning we should more depend upon intuitive factors which awaken if we have control on five senses when sixth sense i.e. intuition awakens. People keeping themselves more or less free from lust, greed, hatred, anger etc have better intuitive powers. Therefore, their interpretation of the same medical report or the same facts findings can result into better realistic diagnosis or conclusion. This is the reason why astrologer has to be pious to make correct interpretation of planetary position of the individual horoscopes by effective intuitive interpretation.

Werner Erhard's Est training was attended by me over 30 years back. He says, "You and I possess at every moment of our lives, under all circumstances the power to transform the quality of our lives". The training sessions which used to be 15/16 hours long had irregular timings of break. This used to cause aches in necks or head or some other body parts. He would say, "Do not resist the

pain, feel it and experience it and it would disappear. We followed the technique with success. This was a method of sending healing energy by mind power for natural soothing effect.

"Soul always knows what should be done to heal itself. The challenge is to silence the mind" says Caroline Myss. Spiritual technique connects body, mind and soul. Meditation & chanting which is the essence of spirituality helps silence the mind and consequently heal.

One method of meditation is a 'Soham' technique. While inhaling & exhaling the practitioner says 'Saha Aham' i.e. I am He. Thus he tries to identify with soul i.e. God and attains peace over a period of practice Transcendental Meditation, or Vipassana or Kriya Yoga are other techniques of meditation; one should learn meditation from an authorized person.

Similarly japa ie inwardly chanting holy words and imagining some symbol in mind ie any object like God or prophet or sacred word like Om/Aum can help in developing detachment from ego, fear, greed, restlessness etc. Japa enables the practitioner in settling the mind and derive peace.

The Times of India, Mumbai of 31st Oct 2011 carried news datelined Washington 'Spirituality helps cure illness'. Stephanie Reid-Arndt, researcher at University of Missouri in the US said, "The new findings reinforce the idea that religion or spirituality may help buffer the negative consequences of chronic health conditions. "It has been established that spirituality can help in getting rid of chronic diseases.

Although, religion and spirituality are considered identical in common parlance, spirituality is different from religion. Religious persons from any religion could be fanatic but spirituality results into peace of mind and hence derives benefit of good health.

The Upanishads say, "When that Supreme Being, immanent and transcendent, is seen, is realized then all knots of the heart are cut asunder, all doubts are dispelled, the deposit of past karma is also eliminated, and man attains freedom in every sense. "Moral observances, humanitarian deeds, meditation and japa as a continued discipline can bring a person close to God and frees from problems to a large extent.

This is based on teachings of Paramahansa Yogananda, articles in SRF/YSS magazines and issues of Tattvaloka.
