

श्री.विनयकुमार रामचंद्र पुणेकर कै.ल.ना.पाबळकर स्मृती सुवर्णपदकाचे मानकरी

दि.६ जून २०११ ला ठाणे येथे आपल्या सर्कल असोसिएशनच्या कार्यकारिणीच्या त्रैमासिक बैठकीत या वर्षीचे 'कै.ल.ना.पाबळकर स्मृती सुवर्णपदक' हे श्री.वि.रा.पुणेकर यांना देण्याचे सर्वानुमते ठरल्याचे कळल्यावर त्यांच्या असंख्य मित्रपरिवारास खूप आनंद झाला आणि गेली १७/१८ वर्षे सातत्याने त्यांनी केलेल्या 'सभासद नोंदणी' या कार्याचे व परिश्रमाचे योग्य ते फळ त्यांना मिळाले ही भावना सर्वांच्या मनात आली.

'पुणेकर' आणि सुवर्णपदकाचे मानकरी – म्हणजे आश्चर्य नव्हे – तर सत्य आहे. कारण पुणेकर म्हणजे पुण्याचे सदाशिव– नारायण पेठी रहिवासी नाहीत, तर ते आडनावाने 'पुणेकर' व आमचे उत्साही सहकारी आहेत. त्यांचे नाव जरी विनयकुमार असले तरी ते वयाने 'कुमार' नाहीत. ते वयानुसार 'सहस्रचंद्रदर्शनाचे' वाटेवर आहेत आणि ते विनयशील आहेत हे नक्की.

9९५६ साली में महिन्यात ते कॅशिअर म्हणून पुणे येथे बँकेत रूजू झाले व ३७ वर्षे इमाने-इतबारे सेवा करून ३१ जुलै १९९३ रोजी वयाची ६० वर्षे पूर्ण होऊन निवृत्त झाले. पुण्याशिवाय पुरंधर-सासवड, तडवळ, सोलापूर व नाशिक येथील शाखांमध्ये त्यांनी विविध प्रदांवर उत्कृष्ट कार्य केलेले आहे. सेवानिवृत्त होण्यापूर्वी कांही वर्षे ते बँकेच्या मुंबई सर्कलच्या 'सर्कल ऑडिट' डिपार्टमेंटमध्ये कार्यरत होते. त्यासुमारास पुणे विभागातील जवळजवळ ६०-६५ शाखांचे लेखा-परिक्षण त्यांनी केल्यामुळे पुणे विभागातील असंख्य सहकारी वर्गाचे ते मार्गदर्शक व हितचिंतक होते असे म्हटल्यास अतिशयोक्ति होणार नाही. कारण 'इन्स्पेक्टर' किंवा 'ऑडिटर' हे शब्द उच्चारले की चुकाच निदर्शनास आणून देणारा अधिकारी असे चित्र सर्वांचे मनात असते. पण हे पुणेकर, तसे सर्वांना नांवे ठेवणारे 'पुणेकर' नाहीत हे नक्की. ते सर्वांना मार्गदर्शन करणारे 'ऑडिटर' निघाले.

सुरूवातीचे काळात आपले असोसिएशनचे सभासद नोंदणीचे कार्य कै.एस्.जी.रास्ते हे करीत होते व ते प्रत्येक पेन्शनर/फॅमिली पेन्शनरचे घरी सायकलवरून जाऊन त्यांना सभासद करून घेत असत. त्यामुळे असोसिएशन स्थापनेनंतरच्या सुरूवातीच्या काळातली पुण्यातील बहुतांश सभासद नोंदणी श्री.रास्ते यांचे प्रयत्नाने झालेली आहे. ही गोष्ट श्री.पुणेकर यांनी अनेक वेळा पाहिली होती आणि स्वतःच्या निवृत्तीनंतर हे कार्य करण्याचे त्यांनी मनाशी ठरविले. योगायोगाने आपले माजी अध्यक्ष कै.भास्करराव गद्रे यांचे प्रोत्साहन देणारे मार्गदर्शन, तसेच माजी अध्यक्ष श्री.बाळासाहेब दांडेकर यांचे प्रेमळ मार्गदर्शन व माजी सेक्रेटरी श्री.एच्.आर.नानिवडेकर यांचे संपूर्ण सहकार्य यामुळे त्यांनी सभासद नोंदणी करण्याचा विडा उचलला. आणि आश्चर्य वाटण्यासारखी गोष्ट म्हणजे आतापर्यंत १३७० चे वर पेन्शनर्सना त्यांनी सभासद करून घेतले आहे आणि सभासद फी म्हणून एक्रूण रु.१३,५०,०००/ –चे वर रक्कम जमा केली आहे, तसेच कांही हजारांच्यावर देणग्याही असोसिएशनकडे जमा केल्या आहेत. त्यांचेशी चर्चा करतांना त्यांनी कांही सभासदांच्या स्वभावाचे मार्मिक किस्से सांगितले. त्यात सभासदाचा चिकटपणा, विक्षिप्तपणा, उदारपणा, वेळकाढूपणा, विचार करून घेतांना त्याला असोसिएशनने केलेले कार्य, आजपर्यंत पेन्शनर्साठी मिळवलेल्या गोष्टी, सवलती, पुढील योजना व त्यासाठी चालू असलेली आपल्या वरिष्ठ नेत्यांची धडपड-निष्ठा इ. माहिती देऊन प्रबोधनाचे महत्त्वाचे काम ते करीत असत. याशिवाय २००५ नंतर फॅमिली पेन्शनर्सक्र आसीरिएशनसाठी रक्कम मिळवून देण्यासाठी श्री.पराडकरांचे बरोबर त्यांनी केलेले कार्य खूप मोठे आहे. तसेच अशा फॅमिली पेन्शनर्सक्रून असोसिएशनसाठी देणग्या मिळवून देवली.



Report of the Managing Committee for the Year 2010-2011

Dear Members,

1. On behalf of the Managing Committee I am glad to place before you the Annual Report of the Association for the year ended 31st March 2011.

2. Membership:-

The Managing Committee is very much thankful to those members who have put in sincere efforts to enroll 815 new members during the year. It may also be observed that the number of employees who retire (i.e. retirees) is less. However, more efforts need to be made to achieve the target of 75% membership (of total pensioners/family pensioners of Mumbai Circle) during the current year. At present our total membership as on 31-03-2011 is 10,336 (excluding Associates). While taking review of efforts made for enrolling new members during the year, it will be worth noting that Shri. Rajiwadekar, Organising Secretary of our Mumbai Zonal Sub-Centre, secured Branch-wise lists of 'would be' retirees

from PPG Department which were distributed to all the Zonal Sub-Centres with a request to contact them on time and enroll them as our members. In turn, all the district representatives were entrusted the work by the Zonal Secretaries. All such efforts resulted in enrolling maximum number of retirees as our members. We take this opportunity and request our Benefactor/Life members to upgrade their present membership to Patron membership by paying the difference in membership fees. We also appeal to each member of the Association to enroll at least one new member as is being stressed by our President Shri.V.M.Gokhale in every meeting.

Resources:

All of us are aware that it is our constant endeavour to meet the expenses out of our income i.e.

- (a) Interest earned on Deposits;
- (b) Income on investments in Govt. Bonds:
- (c) Donations received from the members;
- (d) Admission fee, and
- (e) Dividends received

Membership fees are retained as 'Trust Fund' and are being invested mainly in Govt. Bonds/ Bank Deposits etc. On Liabilities side, it will be observed that our 'corpus' has increased by Rs.7,69,500/- taking the amount of Trust Fund to Rs.1,71,99,933/-. 'Building Fund' has been increased by Rs.17,501/- mainly due to the contributions received from the members from Mumbai ZSC towards their share in acquiring Association's Thane Office own premises. Legal Fund has been increased by Rs.13,18,205/- and we have sent our contribution of Rs.2,50,150/- to the Federation towards Legal expenses. There are additions to the Distress Relief Fund of Rs.9,307/-. Members are requested to contribute generously towards Distress Relief Fund. In view of Writ petition filed in Supreme Court members are also requested to contribute generously towards Legal Fund to enable us to make our Association financially self-sufficient to meet the legal expenses for getting our legitimate demands accepted through courts. We wish to draw your attention to our appeal for Legal fund published in 'SAMVAD' issues from time to time as also appeal made by our President Shri.V.M.Gokhale in various meetings.

The expenses for 'Printing & Stationery', 'Traveling', 'Meeting Expenses', etc. are gradually increasing as per present market trend. As regards 'Postages', we are getting a concession in postal tariff for mailing up to 13000 copies of "Samvad" @ 25 paise upto 50 grammes weight per copy and Rs 2/- if weight exceeds 50 grammes per copy. Now total dispatches per month are more than 10,000 and this figure is increasing every month due to increase in membership. The renewal of this LWP license has been done and is now valid till 31-12-2013. However, Post Office has recently issued directives to all the LWP license holders (like us) to affix postal stamps of 25 paise on all the SAMVAD copies to be delivered at Market Yard (Pune) sorting office for posting on 25th of every month w.e.f. 1st June 2011. This has posed a problem before us to secure 10,000 postal stamps of 25 paise each and affix them on all the copies before posting on 25th of each month. As you may be aware, 25 paise postal stamps are not easily available in post offices. We hope the post office may either repeal this order in view of these difficulties or make available sufficient quantity of 25 paise posral stamps to us.

The Association has received interest on Bank Deposits to the tune of Rs.6,24,632/- and on Govt. of India Bonds to the tune of Rs.3,07,655/-. We have not taken into account interest accrued but not received up to 31st March 2011 due to change in the accounting procedure. Dividend from other investments amounts to Rs.5,420/-, while Rs.8,150/- were received by way of Admission fees. The members have given Donations of Rs.14,02,730/- (including Rs.17,501/- contributed by members from Mumbai ZSC towards Building Fund) during the year for various reasons. The lists of 'Donors'

have already been printed in the past issues of 'Samvad'. You will now observe that our financial position is getting improved and the members will appreciate this. It is worth noting that we have purchased premises at Panaji during the month of January 2010 which is being used as our own 'Holiday Home'. The premises have been well furnished and are being occupied by our members during the season. It is worth mentioning here that office-bearers of our Panaji ZSC viz..Shri.P.M.Narkar, Shri.I.H.Dias and Shri.K.V.Gopinathan are making every efforts to see that the (Holiday Home) occupants' suggestions are taken care of and are being implemented to improve the staying arrangements to the satisfaction of the members.

Donations:

We have received donations for

- (a) Distress Relief Fund;
- (b) for 'Samvad';
- (c) Misc. Donations and
- (d) Legal Fund.

Figures at (a) and (d) are reflected in the Balance Sheet on the Liabilities side while the figures at (b) and (c) are reflected on income side of Income & Expenditure A/c. It is our earnest desire to build up a corpus of substantial amount to enable us to give our share of relief from the interest on the corpus for providing relief to affected families of our members as and when there is a national/natural calamity.

As on 31st March 2011 the 'Distress Relief fund' and 'Legal Fund' show balances of Rs.1,62,750/ - and Rs.12,92,803/- respectively. We take this opportunity and appeal to all the members to donate generously and increase the funds.

Meetings of the Managing Committee:

In all 4 Managing Committee Meetings were held during the year, of which one was held at Thane, two were held at Pune and one was held at Amravati. Apart from administrative work and financial matters, various issues were discussed, viz., the membership drive, problems faced by the members in general, organizational matters such as pensioners' meetings, contacting non-members, organizing Health camps, arranging informative lectures on various issues of interest, taking review of working of Bank's dispensaries etc. The representatives of each zonal sub-centre actively participated in the discussions.

Special Activities:-

a) House Magazine 'Samvad':- We are publishing our house magazine 'Samvad' on monthly basis and sending it to all the members by post. The magazine is so popular that some of the pensioners from neighboring states like Madhya Pradesh and Karnataka have also become subscribers by remitting Rs.100/- per year. We are also sending 'Samvad' to all the office-bearers and Governing Body members of our Federation and all Circle Associations and office-bearers of serving staff Federations. We are also sending our SAMVAD to all the senior executives such as Chairman, M.Ds, Dy.M.Ds, CGMs/CDOs etc. at Corporate Centre and in Mumbai LHO for their information. Our 'SAMVAD' is well accepted by Bank's functionaries and other Circle Association office-bearers as well. 'Samvad' contains latest news on Federation/Association front, reports on organizational and cultural activities undertaken by Sub-Centres and District units, literary works of our members like thought-provoking articles on special subjects/occasions, narration of self-experiences while in service, small stories, poems, jokes and cartoons etc. Competition of writing (in Marathi language) is being organized by the Editorial Committee every year and many members participated in it. Prizes are also being distributed to the winners at the hands of our President in our subsequent Annual General

Meeting. All the issues of SAMVAD published during the past four years are also made available for information of new members on our Association's web-site.

- b) Website: We had launched our website in 2007 containing useful information for members. Our improved web-site "www.sbipensionerspune.org" contains useful new links such as 'Samvad Magazine', 'Financial Statements', 'Photo Gallery', 'Current News', Bank's/Federation's Circulars', 'DA Rates', 'Financial Statements' etc. We are getting very good response from the members, especially from those who go abroad for certain period and are now able to read our 'SAMVAD' magazine and latest developments on Federation front on web-site from any corner of the world which is linked with internet. It is observed that the number of visits from pensioners from other Circles also are increasing day by day & there is encouraging feedback from pensioner-members of other Circle Associations when they get latest information regarding developments on our "Federation front". Our members who have not yet visited our website are requested to visit the same very often to know the latest information.
- c) Birthday Greetings: We are getting, almost every week, appreciation letters from members on receipt of 'Birth-day Greeting Card' promptly sent by our devoted member Shri.M.K.Bapat. Shri.Bapat is handling this activity for the last more than 10 years. His family members also assist him for mailing more than 1400 cards per month. Shri.L.V.Joshi from Pune also extends his helping hand to Shri. Bapat, which is worth noting. Very often we get letters from family pensioners and old retirees who express their sincere appreciation for this good gesture of Association. Many reciprocate their appreciation by sending 'Donation' to the Association. We are really grateful to Shri.M.K.Bapat for this extra-ordinary service which keeps all the members cheerful throughout the year.
- d) Library:- The Libraries have been started at Pune & Thane office premises which are running successfully. At Pune, many books in Marathi/English, all donated by our members, are made available for reading at home without charging any subscription/fee to the members. At Thane, for Library an annual subscription of Rs.100/- is being collected from the members and the books are made available to them at home for reading. In Thane many books are donated by members and few books are being purchased as per the members' choice. The response at both the places is encouraging.

Audit of our Financial Statements as on 31st March 2011:-

It is worth mentioning here that it was possible to complete the audit of the Financial Statements as on 31-03-2011 well in time. This was possible because of strenuous efforts taken by Shri.D.A.Kulkarni, Treasurer, with the timely help by Shri.S.P.Barve to collect the final Financial Statements/necessary papers/certificates from the branches, where our accounts are maintained, in time from all the ZSCs and getting the same audited from M/s A.R.Sulakhe & Co, Chartered Accountants. The Chartered Accountants have also done the audit well in time. Mrs.Swati Rajurkar is helping us to maintain the financial accounts with the aid of Computer. The Secretaries/Treasurers of ZSCs S/Shri.J.B.Pusalkar, J.S.Vakil, I.H.Dias & N.K.Joshi deserve compliments for their co-operation in the matter.

Reports from Zonal Sub-Centres -

1) Aurangabad Zonal Sub-Centre: - As reported in the past, the retirees from the branches under Aurangabad Zonal office generally prefer to settle down in Dhule and Jalgaon Districts and few big cities in Marathwada Region. The membership of the sub-centre is also spread all over Marathwada region covering 7 Districts viz. Aurangabad, Jalna, Beed, Latur, Parbhani, Nanded & Osmanabad Districts. Under the leadership of Shri.Sahebrao Desai, President, & Shri.N.K.Joshi, Secretary, the special efforts are being made by all the District representatives to enroll old retirees who have been settled in remote villages in Marathwada region. They have enrolled 125 new members during the

year and collected Rs.1,64,915/- including subscription fees of Rs.1,07,000/- and aggrgate Donations of Rs.57,915/- for various purposes. Zonal Sub-Centre launched a special membership drive to enroll old retirees as members who up till now could not be contacted and enrolled as members of the Association. The District representatives are arranging get-togethers and functions like Tilgul/Haldi Kumkum and entertainment programmes as usual. Recently, in Aurangabad, the local unit is organizing 'Bhishi' of local members in order to enable them to have regular contacts with each other.

Nanded Unit: The local active members are publishing a four page quarterly 'News Letter' named "Vartalap", wherein they are giving the latest developments on Assoiation front and the local news about activities in the Nanded District to the local members. They are distributing the sufficient Xerox copies to all the members residing in Nanded District. This is really worth emulating idea of publishing quarterly bulletin for benefit of local members. We wish them a grand success.

2) Mumbai Zonal Sub-Centre: - Mumbai Zonal Sub-Centre is always on the forefront of the Association activities. Under the leadership of Shri.S.B.Gokhale, President and Shri.R.S.Rajiwadekar, Organizing Secretary, with the help of all the other office-bearers and active committee members, the sub-centre has shown exemplary growth in membership by enrolling 290 new members. A total sum of Rs.13,27,935/- has been collected, of which Rs.2,84,000/- by way of membership fees and Rs.10,43,935/- as donations for various purposes as follows - Legal Fund - Rs.8,98,823/-; Misc. Donations - Rs.33,310/-; for Samvad - Rs.3,601/- & Advertisements worth Rs.90,700/- and Building Fund - Rs. 17,501/-. We are happy to note here that Mumbai ZSC has collected highest Legal Fund this year which has helped the Association to contribute promptly to the Federation for fighting legal battle in the Supreme Court. All out efforts are always being made by the committee members to increase the membership. Pensioners meetings were arranged at Dombivali (E), Andheri(E), Naupada (Thane), Dahisar and Varsova branches during the year which were attended and addressed by subcenter's office bearers. Mumbai Sub-Centre's 24th Annual General Meeting was held at Shivaji Mandir, Dadar on 11th February 2011 which was attended by more than 1000 members. Mumbai Sub-Centre is now functioning from its own office premises at Thane for which they have collected donations from members for more than 50 % of the cost of the Flat (i.e. more than Rs.8.50 lacs). This is a commendable achievement, indeed!

'Thane-Mulund Sanskritik Mandal' is arranging every alternate month entertainment programmes such as lectures of eminent personalities on various subjects, sharing experiences by our members while doing social work etc. for the benefit of local members. Mumbai ZSC have also organized Medical Check-up camp during the year. 'Andheri Club' is functioning since past many years and is organizing various cultural activities including publication of 'Deepavali-Annual' named 'Sneh-Deep' wherein literary contributions of local members are being published.

At Dahisar the local members have formed a club named "SBI Pensioners' Organization Club" under the leadership of Shri.Nabar on 30-10-2010 and are organizing social and cultural activities for the benefit of local members.

Library at Thane: A library is run in Thane office premises by local members for which few books have been collected from the members as donation. They are collecting Rs.100/- from each member as subscription and are purchasing new books. Recently they have arranged a 'Cinema' show in Malhar Theatre for benefit of local members & their families and collected Rs.20,000/- as Donations which will be utilised for purchasing library books. Shri.Sharad Gadkari, Secretary of the Mandal, donated steel cupboards for keeping library books. Many local members are taking advantage of this library. Shri.V.M.Kanhere from Thane is managing the Library activities very efficiently with the help of local committee members.

3) Nagpur Zonal Sub-Centre :-

The Zonal Sub-Centre has enrolled 206 new members during the year and have collected Rs.2,23,353/- which includs total subscription of Rs.1,86,000/- and Rs.37,353/- as Donations for various purposes. Nagpur ZSC has gained its past glory under the able guidance and leadership of Shri.S.G.Desai, president and strenuous efforts of Shri.Jayant Vakil, Secretary with the valuable support from S/Shri.Mohansing Munot, Nilkanth Nagraj, Dnyanprakash Khobragade, Avadhoot Rotkar, Yatindra Gupta, Gopalkrishna Gadge and Bhojraj Rodge. Shri. Bhojraj Rodge was instrumental in enrolling maximum new members in entire Vidarbha region. The District representatives are taking interest in organizing various organizational activities in their respective District places. The ZSC has provided guidance and support to the 'Exit' optees for solving the issue of wrong demand of Income-tax on their terminal benefits. Due to efforts of our Nagpur ZSC the Nagpur Zonal Office has recently empanelled following Hospitals in Nagpur city as approved hospitals.

- a) K.G.Deshpande Memorial Centre, Ramnagar, Nagpur
- b) Life Care Hospital, near Telephone Exchange, Nagpur
- Shrikrishna Hrudalaya & Critical Care Centre, Congress Nagar, Nagpur

Zonal Office has also approved two Diagnostic Centres for getting investigations done under Medical Schemes i.e. (i) Apollo Clinic & Shri.Surya Clinic, Congress Nagar, Nagpur; and (ii) Ashwini Kidney Dialysis Centre, Ramdas Peth, Nagpur.

Akola Unit: - Shri. Neelkanth Nagraj, Secretary of our Akola unit, is very much active and arranging regular meetings. AGM of the unit was organized at Staff Learning Centre, Akola which was a grand success.

Amravati Unit: - Shri. Dnyanprakash Khobragade, Secretary, is organizing the unit's activities very well. He organized 'Sneh-Melava' of all the pensioners at Amravati and the function was well attended. The unit also organized successfully the Circle Executive Committee Meeting on 23-01-2011.

Yavatmal, Khamgaon, Buldana and Wardha units: - These District units are also functioning very well under the leadership of S/Shri.Gopalkrishna Gadge, M.G.Munot, Yatindranath Gupta & Avadhoot Rotkar respectively who are very active and arranging local meetings regularly and mobilising the membership.

4) Panaji (Goa) Zonal Sub-Centre: -

We are glad to note that the Panaji Sub-Centre is progressing very well under the dynamic leadership of Shri.P.M.Narkar, President. It is also noted with great satisfaction that with the active support of Shri.V.D.Kulkarni, Vice-President and Shri.I.H.Dias, Secretary, the regular meetings are being held at Panaji, Mapuca, Margao and occasional meetings at Ratnagiri, Sawantwadi & Kudal. In all 12 Managing Committee meetings were organized during the year. The sub-centre has enrolled 35 new members during the year. They have collected Rs.93,728=11 which includes total subscriptions of Rs.32,500/- and donations of Rs.55,826=11 as Legal Fund and Rs.5,402/- for 'Samvad' during the year. 13th Annual General Meeting of the Sub-Centre was held on 27th March 2011 which was attended by 280 pensioners/family pensioners from Goa as also from nearby area in Ratnagiri & Sindhudurg districts. The members have also donated generously for 'Samvad' and expressed their happiness for getting first hand information about recent developments about pending issues.

Our Circle Association has purchased premises at Panaji admeasuring 101.03 sq. mtrs.,

comprising three Bed-rooms, a Hall, a Kitchen and two toilet blocks. The premises are being used as our Association's "Holiday Home". During the year ended on 31-03-2011 total 110 persons occupied the rooms and we have collected Rs.47,300/- as room rent.

The total recurring expenditure of Rs.8,789/- was incurred as under :-

a) Electricity Bills paid during the period Rs. 3,245/-b) Municipal taxes/House tax etc. Rs. 4,272/-c) Misc. Expenses Rs. 1,272/-

Taking into account the above income from room-rent & recurring expenditure during the first year, it can be said that the investments made by the Association for establishing Holiday Home will be beneficial in the long run. We have also paid 1% premium (i.e. transfer fees) of Rs.33,500/- to the Society which is appearing on Assets side of the Balance Sheet.

There is an excellent rapport of office-bearers of the Zonal Sub-Centre with the Zonal Office functionaries, especially with the AGM (Admin) and Chief Medical Officer of the Module. This helped in getting many problems of the pensioners solved without difficulty. This is worth noting.

5) Pune Zonal Sub-Centre: -

The Zonal Sub-Centre has enrolled 159 new members and has collected total amount of Rs.5,22,656/- which includes Subscriptions of Rs.1,60,000/- and Donations of Rs.3,62,656/- (including Rs.3,04,201/- for Legal Fund) during the year. Shri.V.R.Punekar, aged 78 years, has enrolled so far more than 1372 new members and collected total subscriptions of Rs.13,70,000/- (approx.) during the last 15 years. Under the leadership of Shri.L.G.Gandhi, President, Shri.C.P.Kulkarni, Secretary and unit's Jt.Secretary Shri.A.S.Pandit and other District representatives, the sub-centre has showed very good progress in organizational activities. Apart from membership drive, they arrange cultural programmes under the banner "Sneh-Mandal" etc. All such activities help our members to keep themselves energetic. The active workers at all the district places helped the Association for conducting many activities. A few activities undertaken by the District representatives are as under.

Ahmednagar: - Regular monthly meetings are being arranged as also good rapport has been maintained with the local Branch Managers to redress the grievances of the members.

Kolhapur: - Activities like celebration of seasonal festivals, participation in local social activities, short duration trips to sight seeing places, organizing health check up camps/lectures of learned personalities have become the routine.

Nashik: - The unit organizes Annual Meet/family gathering of local members and arrange lectures by eminent personalities.

Satara: - The unit members meet regularly once in a month besides Annual Meeting. The guest lectures by eminent personalities are also arranged.

Sangli: - The unit conducts regular meetings through out the year and discuss important issues affecting pensioners and seek information/guidance from the Circle authorities.

Solapur : - Solapur unit participates in local cultural activities & arrange guest lectures of eminent writers/experts from literary fields/medical line etc.

Pune: - Being the head quarters of the Association, it becomes the responsibility of the local Committee members to look after the Association's office and maintain the books of accounts as also keep the membership record up to date. This is being done on a regular basis by S/Shri.D.A.Kulkarni, Treasurer, R.N.Lalingkar, Secretary, M.M.Sirdeshmukh, Jt.Secretary, S.P.Barve, Pramod Chate, Avinash Deshpande, G.N.Joshi and P.B.Kulkarni.

Besides this, the other activities undertaken by the local active members are as under.

Sneh-Mandal: - Shri.M.M.Sirdeshmukh leads the group and arrange quarterly cultural and entertainment programmes. Such activity brings the members more close.

Library: This is another praise worthy activity being looked after by local active members. Library is having more than 1200 books (Marathi & English), on various subjects, all donated by our members. S/Shri.Ashok Wakchaure, Arvind Kale and Subhash Belsare are managing the library work systematically.

On Federation Front: -

The Governing Body and General Body meetings of the Federations were held to discuss various issues concerning all the pensioners/family pensioners during the year as under.

- A) Governing Body Meetings on 24th April 2010 at Patna & on 20th & 21st Nov.2010 at Guwahati
- B) General Body meetings on 25th April 2010 at Patna

Recently, this year the Annual General Meeting and Governing Body meeting of our Federation were held in the first week of April 2011 at SLC, Kochi. Various pending issues were discussed and it was decided to pursue the Supreme Court writ petition which was filed on 16th March 2011 by the Federation. The writ has been admitted on 13th May 2011 and is likely to be heard within 8 to 10 weeks. The main prayer is (1) 50% as pension on last drawn 12 month's average pensionable 'Pay' (pro-rata if pensionable service is less than 30 years); and (2) The said pension should be applicable from 1-11-1987 or from the date of retirement whichever is later to all pensioners who retired on or after 1-11-1987. These demands cover all the pensioners and there will be no different categories of pensioners as being made by different Bi-partite settlements.

Federation is also persuing following cases in different High Courts which are pending.

- i) Family Pension case filed in Nagpur High Court
- ii) 100% neutrilization of DA case filed in Bangalore High Court.

A structured meeting was held on 24th December 2010 between Federation representatives and the Top Management officials of the Bank at Corporate Centre, Mumbai. The discussions were held on our several problems. The response from the Management was positive. Improvement in REMBS-III (including extending 'Domiciliary treatment' for all the diseases) have now been considered and the last date for admission to the Scheme for eligible retirees who retired on superannuation have been extended up to 30th June 2011.

Shri.P.M.Narkar, Vice-President, has met once again Mr. Shantaram Naik, MP from Panaji, and requested him to look into the matter which is pending with the Banking Operations Dept since long and get justice to SBI Pensioners.

Acknowledgements:-

We express our deep gratitude to the Bank's Chairman, Managing Directors and the Dy. Managing Director & Corporate Development Officer, Chief General Manager (Personnel) and other Executives at Corporate Centre as well as AGM (PPG) Corporate Centre of the Bank for giving us opportunities to discuss with them our problems and difficulties of pensioners and related policy matters.

We are grateful to the Branch Managers of our Vakola (Mumbai) and Dattawadi (Pune) branches and their staff for co-operation in conducting the day to day operations of our Circle Association's accounts.

We are thankful to M/s. A.R.Sulakhe & Co., our Chartered Accountants, who have audited and finalized our accounts in time and also guided us on accounting and investment matters.

Personally, I am grateful to Shri.B.G.Dandekar, former President and now Advisor to the Federation, Shri.V.M.Gokhale, President of our Circle Association and Shri.S.B.Gokhale, President of Mumbai ZSC under whose guidance the Association could achieve whatever has been achieved during the year. I am thankful to S/Shri. V.M.Prabhudesai, K.D.Paradkar, K.S.Dhande, S.G.Rabade, M.D.Palkar for their valuable guidance given from time to time.

Latest developments on "Revision of Pension" front

Federation has filed a Writ under Article 32 in Supreme Court on 16th March 2011 and it has been admitted on 13th May 2011. We are much happy to advise our members that the Hon'ble Supreme Court at the hearing held on 13-05-2011 admitted the Writ Petition filed by our Federation and directed to serve notices on the Respondents viz. Government, our Bank, Trustees of our Pension Fund and Reserve Bank of India returnable within 10 weeks. This is a welcome development. If the prayers made in the above writ petition are granted, only one ceiling at one-half of the last 12 months' average pay will be stipulated on our pension and the other proviso to Rule 23(2) stipulating monetary ceilings would be quashed. Pension would be calculated and paid at 1/60th of the average pay of last 12 months' pay drawn at the time of retirement for every year of service, reckoning the entire service not exceeding 30 years rendered by us. our Seventh bipartite pension issue as also the pension issue of the past pensioners would get resolved. We are confident of securing a favourable verdict from the Supreme Court. It is learnt from the web-site of Supreme Court the Writ has now been Listed on 27th July 2011 for hearing.

We are persuing the Family Pension case filed in Nagpur High Court and 100% Neutralization of DA case filed in Bangalore High Court which are pending.

मनात आलं. या गृहनिर्माण संस्थेतील घराघरात ती गृहशांती मायेची ओढ आहे का? संस्थेतील सर्व कुटुंबांमध्ये तो सलोखा, तो प्रेमबंध असेल का?

नातीगोती किंवा स्नेहसंबंध दोन्हीही सहजपणे माणसांना परस्परांशी जोडून ठेवतात.

'कसे कोठूनी येतो आपण, कसे नकळता जातो गुंतून।' या गीत पंक्तीप्रमाणे कळतनकळत कधी नात्याने, तर कधी दृढ स्नेहाने आपण एकत्र येतो. एकमेकांच्या सुखदु:खात सहभागी होतो. अडीअडचणींना उपयोगी पडतो. या ना त्या पद्धतीने माणसातले माणूसपण जपण्याचा प्रयत्न करतो आणि या परिवर्तनामधूनच नातीगोती, स्नेहसंबंध किंवा ऋणानुबंध या शब्दांच्या व्यापकतेपर्यंत पोहोचतो.

जे नाकारता येत नाही ते, किंवा जे स्वीकारावेच लागते ते नाते! अशी असंख्य नाती सांगता येतील. घराशी, घरातल्या माणसांशी, शेजाऱ्यांशी, समाजाशी, गुरूशी, ईश्वराशी, निसर्गाशी, सृष्टीतील इतर प्राणीमात्रांशी, मातृभूमीशी इ. ही सर्व नाती श्रेष्ठ व पवित्र आहेत. अशा अतूट नातेसंबंधामुळेच घर व समाज एकत्र येतो.

आई-वडील, भाऊ-बहीण, पती-पत्नी, आजी-आजोबा-नातवंडं ही नाती रक्ताच्या ओढीने चिकटून राहतात. हल्लीच्या चौकोनी किंवा त्रिकोणी कुटुंबात आत्या, काका-काकू, मावशी-मामा-मामी वगैरे नाती थोडी पांगत चालली असली तरी तिथेही मायेची ओढ आहेच. नाती माहेरची-नाती सासरची. सारख्या सूचना देणारी सासू व सूचना नको म्हणणारी सून! परंपरेनेच सासुसूनेचे हे नाते थोडे नाजूक ठरले आहे तरी गुणदोषांसकट एकमेकांना स्वीकारण्याने व फक्त चांगल्याशीच देवाण-घेवाण केल्याने, सामंजस्याने हे नाते अजूनही नांदते ठेवले आहे.

मराठीतील सासरची माणसे यापेक्षा इंग्रजीतील In Laws हा शब्द जास्त संयुक्तिक वाटतो. by laws चं हे नातं काडीमोड घेऊन by law केव्हाही नाकारता येतं. पण आपली संस्कृती माणसा-माणसांमधील स्नेह-नाते जपण्यासाठी फार जागरूक असते. हे पवित्र बंधन मोडताना ती असंख्य वेळा विचार करण्यास भाग पाडते. म्हणून मग भोंडल्याच्या गाण्यातील नणंद, दीर-जाऊ, सासू-सासरा व पतीदेव, सगळेच रूसलेल्या राणीला 'आपुल्या' घरात नेण्यासाठी धावून येतात.

जोडलेली नाती किंवा रक्ताची नाती त्यात आपल्याला choice नाही. नात्यांमध्ये एकमेकांकडून कर्तव्य व अधिकार यांची अपेक्षा धरली जाते. एकमेकांना गृहीत धरले जाते. नातेसंबंध वाढवले नाहीत तरी ते मानावेच लागतात. नातं कधीतरी उपरं ठरू शकतं कारण ते ठरवून आलेलं असतं. नाती-गोती या शब्दात आप्त व गोतावळा हा व्यापक अर्थ सामावलेला आहे. हवे-नको ते सगळेच त्यात येतात. पण तरीही ती दुरावत नाहीत कारण ती रक्तातून निर्माण झालेली असतात किंवा कधी स्नेहाच्या घट्ट धाग्याने विणलेली असतात.

कधीकधी एखाद्या महत्त्वपूर्ण घटनेत किंवा प्रसंगात किंवा यशाचे मानकरी असलेल्या व्यक्तिशी आपण लांबलांबचं नातं जोडून सुद्धा, आपल्या-त्याच्या नात्याची स्वतःलाच आठवण करून देतो. अभिमानाने किंवा जवळकीच्या भावनेने तो किंवा ती माझा अमुक-तमुक असे आग्रहाने सांगत फिरतो. त्यावेळी विशिष्ट 'तो' किंवा 'ती' शी नात्याचे शिक्कामोर्तब करायला आपण अधीर असतो. म्हणजे कुठेतरी आपण नाते मानतो. फक्त स्वतःच्या सोयीनुसार ते दाखवतो किंवा लपवतो.

नात्यातलं नातं योग्य प्रकारे जपलं तर दृढ मैत्रीचं एक

उत्तम उदाहरण ठरू शकतं. संयम, सामंजस्य, कृतज्ञता, माया व सस्नेह यांच्या संमिश्रणाने नात्याची गोडी अधिक वाढते आणि मनाशी, मनाचे असे अजून एक नवीन नाते फुलू लागते. दोन पिढ्यांमधील दुरावा नाहीसा होतो व तिसऱ्या पिढीशी नातवंडांशी आजीआजोबांचं एक आगळंवेगळं नातं उमलतं व जपलं जातं!

ग्लोबलायझेशनमुळे, खोटी प्रतिष्ठा तर कधी श्रीमंतीच्या हत्यासापोटी वा कधी पोटाची खळगी भरण्यासाठी नाईलाजाने जो तो धावतो आहे. त्यामुळे रक्तातील गुणतंत्रामधील मायेची घनता कमी तर होत नाही ना, अशी शंका येते. प्रत्येक जण स्वतंत्र वृत्तीचा झाला आहे. करिअरच्या नावाखाली आई-वडीलांपासून दूर जाणारी मुलंही आहेत तर माकडीणीच्या गोष्टीप्रमाणे स्वार्थी झालेले पालकही आहेत. घरातल्या पाल्यांकडे, वृद्धांकडे दुर्लक्ष होत आहे. ही मंडळी प्रेमाच्या चार शब्दांसाठी आसुसलेली आहेत. त्यांना अंत:करणातील माया हवी आहे. पण ती द्यायला पुरेसा वेळ नाही.

'दूर देशी गेला बाबा, गेली कामावर आई'.... या सारख्या कवितांमधून ही व्यथा साकार होते आहे.

नात्यांची सुरुवात घरापासून होते तर स्नेहसंबंध मात्र घराबाहेर रूजवले जातात. समदु:खी, प्रवासात भेटलेली, अडचणीत सापडलेली, योगायोगाने भेटलेली इ. अनेक माध्यमांमधून प्रथम ओळख होते. परिचय वाढतो, भावबंध जुळतात आणि स्नेहाचे नाते निर्माण होते. स्नेहातून मग मैत्री फुलते. शाळा-कॉलेजमधील सहाध्यायी, कार्यालयामधील सहकारी, कुठे-कुठेही हा स्नेह संपन्न होतो. स्नेह म्हणजे पुन्हा, मैत्रीचे एक नवीन नातेच! कधी मानलेले तर कधी जोडलेले! स्नेह वाढवणं किंवा न वाढवणं आपली मर्जी असते. आपल्याला कोण आवडावं किंवा कोण आवडतं याला काहीतरी खास कारण असते. कधी आदर, कधी अनुकंपा, कधी विश्वास, कधी सहानुभूती, कधी कृतज्ञता तर कधी आंतरिक ओढ! स्नेहसंबंध कुठेही उमलतो व संपूर्ण भावविश्व व्यापतो. भाषा, ठिकाण, जातपात, धर्म, पंथ कशाचाही अडथळा येत नाही. एकेरी, अहोजाहो, कोणत्याही संबोधनाने एखाद्याशी लोभ जोडला जातो. रक्ताच्या नात्यात कधीतरी प्रेम सक्तीचं अस् शकतं पण स्नेहसंबंधांमध्ये नकळत प्रेम सक्तीचं होऊन जातं. स्नेह हा शब्दच स्निन्धतेने भिजलेला आहे. स्नेहातून नाते व नात्यातला स्नेह असे हे परस्परसंबंध!

A Report of the Meetings held at Kudal and Ratnagiri

At the request of members from Sindhudurg and Ratnagiri Districts, meetings were arranged at Kudal and Ratnagiri. Accordingly, Shri.P.M.Narkar, President, Shri.V.D.Kulkarni, Vice-President, Shri.I.H.Dias, Secretary and Shri.Ashok Malkarnekar, Committee member camped at these places on the 15th & 16th May 2011 and conducted the meetings. Although some of the activitists and Committee members from these areas had attended the 13th Annual General Meeting of the Panaji ZSC held on 27th March 2011 at Panaji, these activitists and members very much desired a close inter-action meets with the office-bearers of the Zonal Sub-Centre of the Association to sort out their problems and seek clarification on certain areas of doubts.

2. Accordingly, on 15th May 2011, inspite of peak local marriage functions in these areas, 32 pensioners attended the Meet held at Kudal. At the outset, when Shri.P.M.Narkar, President, made an announcement that the Supreme Court had admitted the Writ Petition filed by our Federation and that this happened on 13th May 2011, after hearing our Counsel which had directed to issue Notice on the Respondents i.e. Government, our Bank and RBI returnable within 10 weeks, the members were jubilant to hear the news. The President explained the options or choices before the Federation to settle the outstanding issues of the pensioners i.e. (a) by maintaining good relationship and dialogue with the Bank management and the Govt., (b) with support from Unions/Associations of working staff and (c) costly Legal recourses. After exhausting the first and second options, the Federation was compelled to seek justice from the Courts of Law. The President then explained the background and the present scenario of the legal Suits and the reasons/necessity that compelled us to go in for filing a Writ petition before the Supreme Court on 16th March 2011, which has since been admitted. The President also alerted the members not to fall prey to false propoganda spread around by circulating brochures/leaflets/xerox copies of letters among the unwary members of the Association. The President rebutted item by item

the contra issues raised in these circulated material.

- 3. At the Meeting held at Salvi Stop Branch premises, Ratnagiri, on the 16th May 2011, in the same way, inspite of peak marriage season, 27 pensioners attended the Meet. The expectations of the local activists and members were similarly replied to on member to member basis and the queries raised by them in respect of the letter circulated by one of the disgruntled member of Sangli Unit, were ably replied rebutting the issues detailed, item by item. He cautioned the members not to fall prey to false allegations which have no substance.
- 4. At both Kudal and Ratnagiri meetings, doubts regarding SBIREMB Scheme-III were clarified. The extended date for eligible pensioners to join the said Scheme were also highlighted.
- 5. The Secretary then appealed to the members to intensify efforts to increase the membership by contacting those who are about to retire and those who have already retired but not yet become our member. He read out the names with details from the Lists of Staff about to retire etc., as conveniently supplied by the PPG Dept., Mumbai LHO to us periodically. The activists noted down the names of would be retirees, dates of their retirement, their designations and the names of their branches where from they will retire.
- 6. Since all their doubts, apprehensions etc. have been convincingly cleared fully by the President during his talks and inter-actions, members expressed their happiness and voluntarily donated Rs.15,005/- for Legal Fund as follows at Kudal Rs.6,505/- and at Ratnagiri Rs.8,500/-.
- 7. At both these meetings, there was request to organize such meets somewhere in August 2011 so that the enthusiasm and the responses created are sustained.
- 8. At both the meetings, the Vice-President counselled the members to continue their fitness programmes such as Yoga and conveyed thanks for their welcome and goodwill.

आज स्त्री पुरुषाच्या बरोबर अर्थार्जनासाठी घराबाहेर पडू लागल्यामुळे चूल आणि मूल अनाथ झाली आहेत. त्यामुळे प्रेम, जिव्हाळा, श्रद्धा, संस्कार नीतीमत्ता हवेत विरून गेले आहेत. मुलाचे नाते पाळणाघराशी, आई वडीलांचे नाते वृद्धाश्रमाशी जोडले गेले आहे. पाहुण्याचे स्वागत कुलूपाने होते. यदाकदाचित सुट्टी दिवशी पाहुणा आला तर कपाळावरील आठ्याने स्वागत!

'हम दो हमारे दो' संस्कृती उदयाला आली. त्यामुळे मुले परदेशात आणि आई वडील वृद्धाश्रमात. आईवडीलांची विचारपूस करायला, आजारी पडले तर औषधोपचार करायला वेळ नाही. दगावले तर अंत्यसंस्कार करायला वेळ व इच्छा नाही. सर्व काही अन्त्यविधी इतरांनीच करायचे!

घराचे 'घर'पण, स्त्रीचे 'स्त्री'पण, माणसातली माणुसकी संपली. सर्व काही पैशासाठी. प्रत्येकाचे नाते फक्त पैशाशी. विवाहसंस्था, कुटुंबसंस्था संपली. लग्न नको, मूल नको, पै पाहुणा कुणीच नको. बकाल आणि भणंग समाज. अनाथाश्रम, वृद्धाश्रम फोफावले. पैशासाठी हपापलेला, माणुसकी, संवेदना, संस्कार, नीतीमत्ता हरवलेला माणूस! समाजाची, कुटुंबाची नाळ तुटलेला माणूस! नव्हे केवळ माणसाचे अवयव असलेला राक्षस! अंत:करण राग, लोभ, अहंकार, मत्सर, द्वेष, असुया यांनी काठोकाठ भरलेले!

कुटुंबातील कर्त्या स्त्रीने गृहलक्ष्मी, अन्नपूर्णा, प्रेमस्वरूप अन् वात्सल्यसिंधू आईची भूमिका घेऊन नातेसंबंध जीवंत ठेवण्याची तसदी घेतली पाहिजे. आई म्हणजे आत्मा आणि ईश्वर यांचा आविष्कार! चूल आणि मूल या माध्यमातून कुटुंबाचे पालकत्व स्वीकारले पाहिजे. कितीही पाहुणे आले तरीही 'अतिथी देवो भव!' म्हणून आनंदाने स्वागत केले पाहिजे. सर्वांचा यथोचित पाहुणचार केला पाहिजे. 'एक तीळ सात जणात' ही आपली संस्कृती आहे ती आचरणात आणून काटकसरीने वागून त्याग, परिस्थितीशी मिळतेजुळते घेणे व समाधानी राहणे हे संस्कार मुलांना दिले पाहिजेत. घरातील स्त्री जितकी आनंदी समाधानी तितके कुटुंब आनंदी व नातेसंबंध स्नेहपूर्ण!

घरातील आई वडील जितके आनंदी मनमिळावू, तितकी मुलंही प्रेमळ मनमिळावू! मुलांनी सुद्धा शिस्तीने, मान मरातब, मर्यादा पाळून पाहुण्यांचे स्वागत केले पाहिजे. अभ्यास, नोकरी धंदा मनापासून करून आई वडीलांना आधार द्यावा. आई वडीलांना समजून घेऊन अवास्तव अपेक्षा करून त्यांना त्रास न देता आई वडीलांचे नातेसंबंध मंगलमय करावेत.

🔆 सहकार भूषण

(एप्रिल २०११ 'संवाद'च्या अंकात 'सहकार भूषण' हा श्री.भावे यांचेवरील लेख प्रसिद्ध केला. त्यासंबंधी खालीलप्रमाणे अधिक खुलासा श्री.भावे यांनी 'संवाद'कडे पाठवला आहे.)

एप्रिल २०११ च्या 'संवाद' च्या अंकामध्ये माझ्यासंबंधी श्री. श्रीधर वि. सहस्रबुद्धे यांनी लिहिलेला लेख आपण प्रसिद्ध केलात. याबद्दल आपण आणि श्री. सहस्रबुद्धे, दोघांनाही मी मनापासून धन्यवाद देतो. मला मिळालेल्या या पुरस्कारासंबंधी थोडी अधिक माहिती द्यावी म्हणून या पत्राद्वारे संपर्क साधत आहे.

'संवाद'चे सर्व वाचक हे स्टेट बॅकेतील निवृत्त सेवक, अधिकारी, त्यांचे कुटुंबीय आहेत. त्यामुळे आपल्या सर्व सभासदांना इतर सर्वसामान्य लोकांपेक्षा बॅंकिंगची थोडी अधिक माहिती असणे स्वाभाविक आहे. म्हणूनच जनता सहकारी बँक लि.पूणे या बँकेची नेमकी परिस्थिती काय होती? आणि ७-८ वर्षांचे काळात यामध्ये कशा पद्धतीने सुधारणा होत गेल्या याचे आकलन 'संवाद'च्या वाचकांना अधिक चांगल्या पद्धतीने होईल. २००३ साली जनता सहकारी बँकेच्या अस्तित्वाचा प्रश्न निर्माण झाला. एका बाजुला अनुत्पादित कर्जाचे प्रमाण जवळजवळ ५०% पोहोचले. त्यामुळे त्यावरील तरतूदीही मोठ्या प्रमाणावर वाढत गेल्या. याचा परिणाम म्हणून बँक तोट्यात गेली आणि १९९८ ते २००३ या ६ वर्षांचे काळात तोटा वाढत जाऊन तो रू. १२५ कोटींवर पोहोचला. यामुळे बॅंकेचे नक्तमूल्य (Networth) ऋणांकात (Negative) गेले. २००३ चे आकडेवारीनुसार ते (-) रू. ९० कोटी इतके झाले. दुसऱ्या शब्दांत सांगावयाचे तर बँकेचे स्वत:चे भांडवल + राखीव निधी हे पूर्णपणे नाहीसे होऊन ठेवीदारांच्या ठेवींपैकी बँक रू. ९० कोटी वापरू लागली. कोणत्याही आर्थिक संस्थेच्या दृष्टीने ही स्थिती अतिशय भयावह म्हणावी लागेल. याचाच अर्थ ही बँक आर्थिकहष्ट्या आजारी (Financial Sickness) झाली असे म्हणता येईल. बॅकिंगच्या इतिहासावर नजर टाकली तर अशा आर्थिक संस्था तग धरू शकत नाहीत. इंडियन बॅंकेच्या भूतपूर्व अध्यक्षा श्रीमती रंजनाकुमार यांचे त्या बॅकेच्या Turnaround विषयी लिहिलेले पुस्तक आपल्यापैकी बऱ्याच जणांनी वाचले असेल. इंडियन बॅकेचा आणि जनता सहकारी बॅकेचा तुलनात्मक विचार करता इंडियन बॅकेची स्थिती ही जनता सहकारी बँकेपेक्षा कमी भयावह होती हे लक्षात येईल. मात्र ही बँक तरली ती राष्ट्रीयकृत असल्याने व सरकारने दिलेल्या रू. २७०० कोटींच्या भांडवलावर. जनता बँकेचे बाबतीत असा कोणताही बाहेरील मदतीचा हात पुढे आला नाही.

मात्र तरीही २००३ च्या कठीण परिस्थितीतून मार्ग काढून २०११ साली या बँकेचे नक्तमूल्य (Networth) + ११० कोटी रूपये, ढोबळ अनुत्पादित कर्जे (Gross NPA) ५%, निव्वळ अनुत्पादित कर्जे (Net NPA) 0.83%, संचित तोटा (Accumulated Loss) पूर्ण संपलेला आणि रू. २७ कोटींचेवर निव्वळ नफा (Net Profit) अशी स्थिती २०११ मध्ये आली आहे. श्री. सहस्रबुद्धे यांनी उल्लेख केल्याप्रमाणे ही स्थिती येण्यासाठी बँकेचे संचालक मंडळ, अधिकारी, सर्व कर्मचारी यांनी एका दिशेने आणि एकदिलाने काम केले. बँकेच्या सभासदांनी बँकेच्या व्यवस्थापनावर विश्वास ठेवला, ग्राहकांनी अलोट पाठबळ दिले, १०-१२ वर्षे डिव्हीडंड न मिळताही रू. १० कोटींपासून रू. ७० कोटींपर्यंत भागभांडवल वाढ अशा अनेकविध कारणांमुळे हा चमत्कार घडला. होय! रिझर्व बँकही याला Turnaround Miracle असेच म्हणते.

हे सर्व होत असताना या बँकेत मुख्य कार्यकारी अधिकारी म्हणून काम करण्याची मला संधी मिळाली त्यामुळे हा पुरस्कार मला मिळाला.

पुन्हा एकदा श्री. सहस्रबुद्धे यांना मन:पूर्वक धन्यवाद देतो. त्यानिमित्ताने जनता सहकारी बँकेच्या पुनर्वेभव प्राप्तीची ही हकीकत वाचकांसमोर मांडण्याची संधी मिळाली हे मी माझे भाग्य समजतो.
