संपादकीय

सभासदमित्रहो,

माणूस जन्माला येतो. जन्मानंतरची त्याची वाढ हा नैसर्गिक भाग असतो. पण हे वाढणे समाजाच्या भल्यासाठी कामाला आले तर त्या वाढण्याला एक वेगळेच महत्त्व प्राप्त होते. आयुष्याची सार्थकता ही जगण्याच्या लांबी-रूंदीवर अवलंबून नसते. ती अवलंबून असते जीवनमूल्यावर.

<u>Proceedings of the 28th Annual General Meeting held at Shivaji Mandir, Dadar</u> <u>on Wednesday the 25th February 2015</u>

The Meeting was scheduled to start at 11.00 a.m., however, due to lack of quorum it was postponed by 30 minutes.

At 11.30 a.m. the Meeting began. Shri P.A. Lopes who was on the stage extended a warm welcome to all members attending the Meeting. He, thereafter, requested the following dignitaries to occupy their chairs on the dais.

After every one occupied the chair they were warmly greeted with a bouquet by Shri S.M.Dharadhar. Sarvashri Madhav Nadkarni & C.N.Date offered prayers to the Almighty Lord Ganesh at the beginning of the Meeting.

Shri.Lopes on behalf of the entire gathering offered good wishes to the young relatives of the pensioners who were to appear for HSC & SSC examinations, so also he extended good wishes to the Indian Cricket team who are playing in the World Cup of Cricket in Australia & New Zealand. Shri.Lopes also read out the messages conveying good wishes to the Meeting received from Sarvashri Laxminarasaiah and B.G.Dandekar. The Meeting thereafter proceeded as per the Agenda of the Meeting.

Agenda Item No. 1: To condole the death of Bank's Pensioners/Family Pensioners/Associate

Members whose names have been reported to us after the 25th February 2014.

Members requested to advise us the names & dates of deaths of members, if not in the list to be read out at the time of AGM.

Shri.Lopes then read out the list of the deceased members & then every one in the Auditorium stood in silence for 2 minutes to offer their respect towards the departed Souls.

Agenda Item No. 2: To confirm the Minutes of the AGM held on the 25th February 2014 (Minutes published in March 2014 issue of Samvad)

There were no gueries on the Minutes & hence they were treated as confirmed.

Agenda Item No. 3: To honour Senior Members who have completed/will complete 75 years of age between the 25th February 2014, to the 25th February 2015 (both days inclusive)

There were 191 members who were eligible for the honour and out of that 57 were ladies. Nearly 60 members could attend the Meeting. Shri S.B.Gokhale, Circle President, honoured each & every member with a bouquet of flowers & a cheque for Rs.751/-. The Meeting was being attended by nearly 900-1000 members & hence it was a great feeling to be honoured before such appreciative gathering. Moreover it amounted to honour for their hard & sincere work put in by them for the Bank.

Those members whose birthday fell on 25-2-2015 were also honoured. Shri.V.M.Kanhere, Librarian of the library at Thane, was also honoured.

Towards the conclusion of the honouring ceremony Bank's officials arrived & hence the next items of Agenda were put on hold & Bank's Meet was organized. Shri Lopes requested the following officials of the Bank to come on the stage & occupy the chairs reserved for them.

Shri. Asit Nandi who was requested to speak gave in a nutshell an account of the Structured Meeting held by the Bank with the Federation of SBI PAs. Shri. Nandi informed the House that the Bank was going in a big way for automation of the work. He also touched the following points:

- a) No new account needed to be opened by a Family Pensioner
- b) REMBS: The enrollment of Membership will be done by the Branch 'online' and conveyed to ZO/LHO/Corporate Centre. This also applies to the payment of bills under the scheme.
- c) Loans to Pensioners Quantum could be upto Rs. 1.00 lac and maximum repayment period of 80 months.
- d) Opening of a new portal for pensioners wherein access would be easier. The portal will help pensioners to see details of his pension, view 'Second Innings' and also advise the Bank of his investments for tax saving.

Shri.Nandi was thankful to the Assn for the opportunity given to him to address such a large gathering of pensioners.

Shri.C.P.Muley, Dy. Manager, PPG Department, Corporate Centre informed the gathering on following:

- a) Out of nearly 15,000 pensioners in Mumbai Circle nearly 2,150 have so far not submitted their Life Certificates. He, therefore, urged everyone to verify about the receipt of pension for February 2015 and if pension has not been received, please resubmit the Life Certificate. He further informed that arrangements are being made for biometric submission of Life Certificate from next year and L.C. to be linked to Adhar Card.
- b) All pensioners should keep a regular follow up with their Pension paying Branch for remittance of their Income Tax to GOI, Investment declaration form and submission of Life Certificate.
- c) Bank has opened a new portal for pensioners where no password or no log-in is required which gives information about :
 - 1) Second innings
 - 2) Rules and Regulations PF / Pension
 - 3) eCirculars DA etc.
 - 4) Various Application forms



- 5) Grievance Registration
- 6) Important links

Shri.Muley further informed about REMBS 'online' bill submission payment etc.

Dr.(Smt) Ajinkya in her speech cautioned everyone on upkeep of health by adhering to good diet/exercise and taking proper medicines. She emphasized on taking good fruits, curds, butter milk instead of oily food. In respect of exercise she gave preference to a brisk 45 minutes walk and Yoga, Pranayam etc. She also impressed upon pensioners to do regular medical check up, give up tobacco completely, have sound sleep etc, to maintain good health.

Dr.(Smt) Manjusha Padhye at the start of her speech complimented the Association for organizing such a grand function. She too urged all pensioners to do proper exercises, have a balanced diet and a peaceful sleep for good health.

Shri.Ganesh Shetty, AGM, PPG, LHO when requested to speak informed that the Bank is in the process of further automation and Mumbai ZO has been selected as a pilot ZO. All memberships for REMBS and payment of bills under the scheme shall be done directly online from Branch to ZO to LHO to CC. This will reduce the time from nearly 90 days at present to 40 days. Payment of bills also would be done much faster. For submission of Life Certificate biometric system would be used and this will reduce the present system of submission of L.C. Shri. Shetty was all praise for the work done by Mumbai ZSC and Association. He agreed that at times we do take the help of the Association. Shri. Shetty advised members to take a note of advices given by Dr. Ajinkya and Dr. Padhye to keep all ailments away and have a healthy peaceful life.

Dr. Samant of Saraswat Brahmin Sabha was allowed to speak. He appealed to the gathering to donate funds for helping the poor suffering from cancer.

A lunch Break was taken at this juncture.

Agenda No.4: Committee's report for the year 2014 to be read, discussed and adopted (a copy of the report enclosed)

Shri.P.A.Lopes enquired with the assembly as to whether anyone has any query on the report. Since no questions were asked the report was treated as adopted.

Agenda No.5: To discuss recent developments -

Shri.S.B.Gokhale, President, Mumbai Circle as well as Mumbai ZSC gave the following information:

A Structured Meeting was held recently by the Bank with the Federation of SBI Pensioners' Associations. The Meeting was attended by himself and Shri.Gandhe, Circle Secretary. In that Meeting the Dy.MD and CDO of the Bank told that the Bank's officials have succeeded in alleviating the misconception about three benefits enjoyed by the Bank staff.

Further, the gratuity being paid to Bank retirees is statutory one and the conversion factor used for calculation of commutation was also adverse in comparison to other Banks.

The CDO further informed that the GOI have now agreed to rectify anomalies that exist in our pension since 1986.

Shri.Gokhale further said that SC judgement was expected to be in our favour but delayed by the GOI. In fact, anomalies do exist in respect of retirees of the 5th, 6th, 7th and the 8th Bipartite retirees. GOI has requested the Bank to submit suitable recommendation for removal of the anomalies. We understand that the Bank has submitted appropriate recommendations and GOI's response is awaited.

In respect of REMBS, a review of the scheme may take some more time since as per actuaries' advice a huge provision is required to be made if all retirees are to be covered under the Scheme. In respect of appointment of Pharmacists, Shri.Gokhale said that 27 pharmacists were given appointments but none reported. Moreover, they were all 'B Pharm' instead of 'D Pharm'. Hence the process has to be reinitiated.

The Supreme Court case which has been transferred to Delhi High Court is now to be heard on 6th April 2015. (Now posted for hearing on 6th May 2015)

In case Life Certificate has not been submitted the pension could be stopped from February 2015 onward. From next year onwards the Life Certificate will be uploaded biometrically and it will be linked to 'Adhar Card'.

Shri.Gokhale concluded his speech on a optimistic note that our long outstanding anomalies would get resolved shortly.

Shri.V.V.Gandhe, Secretary, Mumbai Circle, spoke on the occasion. He complimented Mumbai ZSC for the maximum number of enrollment of pensioners as Association members and for collecting maximum donation. He mentioned that from 2008 to 2014 Mumbai ZSC have collected nearly Rs.44 lacs for the Association. So also they have collected 50% of the cost of Thane Office.

Shri.Gandhe thereafter narrated the various activities undertaken by Association HQs at Pune.

Registration of newly enrolled members and keeping excellent records is handled by Shri. Avinash Deshpande. Monthly publication of 'Samvad' and its distribution etc. (nearly 11,000 copies per month) is handled by office bearers of Pune ZSC, under the leadership of Shri. Lalingkar, Birthday Greeting cards are regularly sent by Shri. Pramod Chate. Maintaining the Association's accounts which is a daily job of 3-4 hours. This is done by Shri. D.A. Kulkarni, Treasurer. He urged members to make use of the new pension portal started by the Bank.

The Meeting was in concluding stage when Shri.J.B.Pusalkar announced that a sum of Rs.1.30

lacs in the form of donation from members attending the Meeting has been collected since morning.

Staff Welfare Activities Bank's Dispensaries - Stocking of Medicines

In response to the problems raised in the Structured Meeting held recently in Hyderabad between Bank authorities and our Federation representatives regarding Stocking of Medicines in Bank's Dispensaries, the Bank has issued a Circular Letter No.HR:IR:2018 dt. 23rd February 2015 addressed to all the Circles clarifying the instructions in this respect. We publish hereunder a copy of our Bank's Letter mentioned above for information of the members which should help in resolving the problems faced in this regard.

STAFF WELFARE ACTIVITIES BANK'S DISPENSARIES STOCKING OF MEDICINES

In the recently held structured meeting held with representatives of Federation of SBI Pensioners' Associations at Hyderabad, it is brought to our notice that many dispensaries are not keeping adequate medicines on regular basis required for ordinary ailments. As a result, many of the Pensioners need to visit 2/3 times in a month to collect their monthly quota of medicines required for chronic diseases like hypertension, diabetes etc.

- 2. In this context, we reiterate that inadequacy of budget can not be cited as a constraint for not stocking required quantity of medicines at Bank's dispensaries. It is the duty of the Medical Officer posted in the dispensary to prepare the budget according to the need at the dispensary and in line with the stocking pattern, approved by the appropriate authority. We are sanguine that if this job is carried out judiciously, there would not be any room for complaints. In this connection, we invite a reference to our circular special letter No.HR/IR/SPL/387 dated 5.12.2009(*) containing the revised stocking pattern of medicines in dispensaries.
- 3. We therefore, request that the Medical Officers and the staff involved in the process of acquiring, dispensing the medicines to the existing as well as retired staff and concerned sanctioning authorities are suitably instructed to do the needful to prevent complaints from the retired employees in future.

LATEST POSITION of W.P.1875 of 2013

On 8th April 2015 when our case was being heard, it was pointed by our Advocates that the Bank has framed SBI Employees Pension Fund Regulation 2014 superseding SBI Pension Fund Rules 1955 notified in the Gazette of Govt of India on 18-09-2014. It is, therefore, necessary to change our 'prayers' accordingly. Our Advocates filed an application to change the prayers. This application was listed on 8th April 2015. Our Advocates requested the court for early hearing of the case. Court said that they are aware of the position and **posted the hearing of our Application to 6-05-2015** asking our Advocates to file our W.P with amended prayers. We give hereunder the Circular issued by our Federation in this respect.

Sub: Order dated 6-04-2015 of Delhi High Court passed in W.P.2353/2014 filed by Shri Jaipuriar, pensioner

We enclose for your information a copy of the above order of Delhi High Court. Our Circular No2/2015-2016 dated 8-04-2015 was based on the oral orders listened to by the undersigned, when the above W.P was heard on 6-04-2015 by the Delhi High Court. The above order passed by the Delhi High Court clearly indicates that a decision on challenges to vires of Rule 23 (2) has to be in harmony with the law declared by the Supreme Court in the decision reported as 1990 (4) SCC 270 D.S.Nakara Vs. UOI.

2. This order also recognizes the need for computation of pension on last drawn salary as provided in Rule 23(1) as stated below and has also directed our Bank to compute his pension on Seventh Bipartite pay Scales for the month of April 1998.

"and therefore his average last 12 months' salary on basis whereof pension was computed, as required by Rule 23(1) was the basis."

"Concededly the 7th Bipartite Settlement Agreement was entered into between the employees of State Bank of India and the Bank in the year 2000 as per which salary of staff employees was enhanced with effect from November 01, 1997 and of the Officers with effect from April 01, 1998. Having retired as an officer, salary for the month of April, 1998 of the petitioner was re-fixed and arrears paid"

"Since while fixing petitioner's pension when he superannuated on April 30, 1998, the average salary drawn in the last twelve months formed the basis on which pension was paid, it is apparent that for one out of the twelve months i.e. the month of April, 1998, benefit of enhanced salary which the petitioner received by way of arrears pursuant to the Bipartite Settlement of the year 2000 had to be extended and pension recomputed."

3. We are happy to share with you this encouraging order of Delhi High Court and our renewed confidence that justice would be rendered to us, when our W.P is adjudicated by the Delhi High Court.

ORDER dated 06.04.2015

- 1. The writ petition was filed in the High Court of Jharkhand at Ranchi and was transferred to this Court by the Supreme Court pursuant to an order dated January 27, 2014. The reason was that a writ petition filed directly in the Supreme Court, in a representative capacity, by the Union of the retired employees of State Bank of India was also transferred to this Court.
- 2. The challenge by the Union as also the instant writ petitioner is to the vires of Rule 23 (2) of the Pension Rules framed by the State Bank of India.
- 3. The writ petitioner, vide CM No.17063/2014, has prayed that by way of an interim order his pension be re-fixed with effect from March 01, 1999, and for which the petitioner would have to first successfully challenge the vires of the Rule.
- 4. We have told the petitioner that his writ petition would be heard with the writ petition filed by the Union. The writ petitioner states that he gives W.P.(C) 2353/2014 up challenge to the vires of the Rule and desires disposal of his writ petition treating the Rule to be intra-vires.
- 5. After hearing the petitioner and learned counsel for the respondent, realizing that hardly any benefit would accrue to the petitioner if the Rule is applied as it is, we once again have told the petitioner to await the fate of his writ petition to be heard along with the one filed by the Union. But the petitioner insists that the matter may be disposed of after hearing him today itself and by treating the Rule in question as intra-vires.
- 6. As per Rule 22 of the State Bank of India Employees Pension Fund Rules, 1955, a Member shall be entitled to a pension under the Rules after having completed 20 years' pensionable service on attaining the age of 58 years if he is in service of the bank on or after November 01, 1993 or on completing 10 years' pensionable service provided the employee is in the service of the bank as of May 22, 1999.
- 7. Rule 23 of the said Rules reads as under :-
 - "23. (1) Subject to the provisions of sub-rules (2) and (3), the pension payable under rule 22 shall be the amount calculated at the rate of one-sixtieth part of every year's pension able service of the average monthly substantive salary drawn during the last twelve month's pensionable service.
 - (2) The maximum pension shall not exceed one-half of the average monthly substantive salary drawn during the last twelve months pensionable service or `2400/- p.m. (pro-rata in the case of part time employees) whichever is less.

Provided that the maximum amount of pension shall be increased for the members who retired/retire on or after 1.11.93 from `2400/- as mentioned above to `

4250/- (pro-rata in the case of part-time employees) after adjustment of dearness allowance on the basic pay upto 1148 points in the quarterly average of the All India Working Class Consumer Price Index (General) Base 1960=100. W.P.(C) 2353/2014

of 5

Provided further that with effect from 1.3.1999 the maximum amount of pension for the members who retired/retire drawing substantive salary in the pay scales effective from 1.11.1992 (Award Staff) 1.7.1993, (Supervising Staff) and thereafter shall be computed till further amendments in this regard, as under:- (a) Where the average of monthly substantive salary drawn during the last twelve months' pensionable service is up to `8500/- p.m., 50% of the average of monthly substantive salary drawn during the last twelve months' pensionable service (pro-rata in the case of part-time employees); (b) Where the average of monthly substantive salary drawn during the last twelve months' pensionable service is above `8500/- p.m., 40% of the average of monthly substantive salary drawn during the last twelve months' pensionable service subject to minimum of 4250/- (pro rata) in the case of part-time employees."

and

8. The challenge to the vires of Rule 23(2) concerns the date March 01, 1999 in the second proviso. If the said date is opined to be arbitrary, corrective action could be taken by directing relief to be extended as per the proviso to the pre March 01, 1999 retirees in harmony with the law declared by the Supreme Court in the decision reported as 1990 (4) SCC 270 D.S.Nakara Vs. UOI. But the petitioner wants this Court to decide the matter by treating the Rule as intra-vires, and thus it would be enough for us to note the fact that the petitioner superannuated from service on April 30, 1998, a date obviously prior to March 01, 1999, and thus he cannot claim any benefit of the second proviso to sub-Rule 2 of Rule 23.

9. When the petitioner superannuated from service, having sought voluntary retirement as per the Rules, on April 30, 1998, his pension was fixed with reference to the average salary received by him in the last 12 months. The respondents have explained petitioner's pension being fixed as under :-

"Sh.Jaipuriar was confirmed on 17.04.1976 and retired voluntarily on 30.04.1998 i.e. rendering 22 years' of pensionable service. The average monthly substantive salary drawn by him during the last 12 months' pensionable service is Rs.'8,682.50.

Rs.8,683 X 22 X 12

Pension payable ----- = Rs.3,184/-

60 x 12

B. In terms of Rule 23(2) which reads as follows:-

"The maximum pension shall not exceed one-half of the average monthly substantive salary drawn during the last twelve months pensionable service or `4250/- (revised from `2400/w.e.f. 01.11.1993...., whichever is less"

Pension payable = `8,683/2 = `4,342/- (round of)"

- 10. Since the petitioner has given up challenge to the vires of Rule 23 (2) his entitlement to pension has to be determined sans any reference to the second proviso to the Rule in question.
- 11. In this context the only relevant second fact which needs to be noted is that when the petitioner superannuated, he was receiving salary being then paid and therefore his average last 12 months' salary on basis whereof pension was computed, as required by Rule 23(1) was the basis. Concededly the 7th Bipartite Settlement Agreement was entered into between the employees of State Bank of India and the Bank in the year 2000 as per which salary of staff employees was enhanced with effect



from November 01, 1997 and of the Officers with effect from April 01, 1998. Having retired as an officer, salary for the month of April, 1998 of the petitioner was re-fixed and arrears paid. As noted above, the petitioner was voluntarily retired on 30th April, 1998.

- 12. Since while fixing petitioner's pension when he superannuated on April 30, 1998, the average salary drawn in the last twelve months formed the basis on which pension was paid, it is apparent that for one out of the twelve months i.e. the month of April, 1998, benefit of enhanced salary which the petitioner received by way of arrears pursuant to the Bipartite Settlement of the year 2000 had to be extended and pension recomputed.
- 13. Learned counsel for the State Bank of India concedes so.
- 14. Thus, the writ petition as well as the above captioned application are disposed of issuing a direction to the State Bank of India to re-compute the pension payable to the petitioner by taking into account the last twelve months' salary received by him, which as noted above, would mean the salary which petitioner received for the month of April, 1998 in terms of the Bipartite Settlement, and arrears to be paid within a period of 12 weeks from today.

15. No costs.

The amendments to the Bye Laws of our Federation are underway in terms of Federation Cir No 91 of 2015 Dt. 20.02.2015 and the issue is being considered by all the affiliates. In this regard the efforts taken by SBI PA, Mumbai Circle, and the historical events have been enumerated by Shri B. G. Dandekar, Adviser to the Association and we are publishing the same for the information of our members.

State Bank of India Pensioners' Associations Constitution - First and changes thereafter

The idea of forming a Federation of the existing Associations was of Sarvashri L.N. Pabalkar, P.P. Erande (both from Pune) and M.L. Kolhekar (from Indore). A decision was mooted firstly in the General Body Meeting of Indore Unit (i.e. M.P. Association) held on the 18th August 1983. In this Meeting the work of preparing a draft of the constitution of the proposed Federation was entrusted to Shri M.L. Kolhekar.

For the above work, a special Meeting was arranged at Pune in February 1984. The Meeting was held at the residence of Late Shri L.N. Pabalkar which was attended by Sarvashri M.L. Kolhekar (Indore), N.R. Rao (Hyderabad), N.D. Ranganathan (Chennai), and A.K. Halder (Kolkata).

The inaugural Meeting of the Federation was held at Delhi on 23-9-1984. The draft of the constitution was discussed and with certain amendments it was unanimously approved. The same was forwarded to the Registrar of Societies, Delhi. The approval was received in 1986.

In the Governing Body Meeting held at Chennai on the 14th, 15th & 16th July 1990, the issue of doing certain amendments was discussed (First amendments). A draft of amendments was approved and forwarded to Circle Associations for consideration.

In the Annual General Body Meeting held at Bangalore, on the 18th/19th March 1991, the above draft of the amendments was placed for approval. In the same Meeting a draft of the constitution (Not amendments) drafted by Bengal Circle Association, as guided by Late Shri Mohan Lal Majumder, Vice-President of the Federation (from 4-3-1990 to 6-7-1999) was placed before the House. However as the new draft was not circulated amongst the Associations, the issue was not discussed in the Meeting.

Thereafter till 1st/2nd May 1993 the issue was not placed before any Meetings. In the 7th AGM held at Chennai on 1st/2nd May 1993 though the item of "Amendments to the constitution" was on the Agenda, the same was not discussed for want of time. In this Meeting the H.Q. of the Federation was shifted from Chennai to Pune (Mumbai Circle). Shri B.R. Gadre was unanimously elected as President and Sarvashri B.G. Dandekar, as Secretary, S.G. Rabade, as Jt. Secretary and K.S.Dhande as Treasurer were also unanimously elected.

In the Governing Body Meeting held at Hyderabad on the 6th/7th December 1993, the issue of amendments to constitution was discussed on the 6th, and Sarvashri Mohanda and A.M. Mariappan suggested to form a committee for this purpose. Accordingly committee consisting of the following Members was formed.

Shri S.G. Rabade, Pune Shri Mohan Lal Majumder, Kolkata Shri R.S. Kulkarni, Ahmedabad Shri A.M. Mariappan, Chennai & Shri C.L. Kapoor, Delhi

The committee was requested to submit its observations on the 7th (i.e. next day). Therefore the Committee met on the 6th night and 7th early morning and discussed the amendments. (Note: Shri C.L. Kapoor refused to participate as he felt that there is no need of doing any amendments. Shri Mariappan also did not participate due to his earlier commitments. However he gave a note stating therein his views).

Next day Shri Rabade said that at the instance of the President (Shri B.R. Gadre), some work has been done by a group consisting of Sarvashri G.S. Aphale, R.J. Joshi, V.R. Kuddyady and himself. The note prepared by this group was forwarded to all Circle Associations with a request to forward to Pune office their views within one month.

Shri Mohanda endorsed the reporting made by Shri Rabade. Thereafter necessary resolution was passed in that Meeting.

In the Governing Body Meeting held at Bangalore, on 21st March 1994, the final draft was approved (17 Members representing all Associations attended). It was necessary to place these amendments before the special General Body Meeting (As required under the Societies Registration Act, 1860).

Special General Body Meeting (first) was held at Chennai on the 12th June 1994 (16 Members from 9 Circle Associations attended). Amendments to the constitution of the Federation, as approved by the Governing Body Meeting held on 21-3-1994 were approved and recommended to place before another Special General Body Meeting, for confirmation.

Second Special General Body Meeting of the Federation was held at Pune on the 25th September 1994.

Amendments to Federation's Constitution as adopted in the first special General Body Meeting of the Federation held on 12-6-1994 were confirmed by the Meeting. The same amendments were submitted to the Registrar of Societies, Union Territory of Delhi, vide Pune letter No. PNA/64/94 of 31-12-1994 (26 Members from 11 Circles attended).

A copy of the above was forwarded to all Circle Associations on 19-9-1996 by Shri B.G. Dandekar, General Secretary.

The approval from the Registrar was not received. We, i.e. Shri Gadre and myself went to Delhi, on invitation, to attend their Association's Annual General Body Meeting which was held on 26--3-1995. After Meeting we sought the help of Hon'ble Minister Dr. Harshawardhan, then Health Minister. We met him on 28-3-1995 in his office. He talked to some one, hence our file was immediately taken out by the concerned staff. We, i.e. Shri Gadre, Shri Bahal and myself, went to the office of the Registrar. There one Affidavit was signed by Shri Gadre and we were told that within one month the approval will be forwarded to Pune. Thereafter our friend from Delhi were regularly doing the follow up. Once Shri K. S. Dhande also went to Delhi and met the officers of the Registrar's office and enquired about the approval to the constitution. However no satisfactory reply was given. On 6-7-1999 the H.Q. of the Federation was shifted to Delhi and Shri B. Rai was elected as President of the Federation. While handing over the charge to the new General Secretary, I suggested him to get the approval at the earliest to the amendments made to the constitution of the Federation.

Approved copy was received and forwarded to all Circles by Shri B.P. Khanna vide letter dt. 15-7-2002. Certain discrepancies were brought to the notice of the Secretary (late Shri Damoon) vide my letter No. 43 of 4-10-2002. That time I was vice-President of the Federation and President of Mumbai Circle Association. It is necessary to do corrections as suggested by me in the letter under reference.

PAYMENT OF LEGITIMATE PENSION TO SEVENTH BIPARTITE RETIREES

We publish hereunder a copy of the appeal dated 22-02-2015 made to the Chairman of our Bank by the former council members of All India SBI Staff Federation for resolving our long pending pension issue of payment of pension on Seventh Bipartite Pay Scales for the information of members. Despite the efforts of our Federation and all its Affiliates over many years for the payment of legitimate pension on last drawn pay and also several recommendations submitted by our Bank to the Government, the above issue remaining so far not resolved without any justification is causing severe heart burn among all the affected pensioners. Let us hope that this representation by the veteran leaders of the All India SBI Staff Federation would receive the due attention of our Chairman for her personal intervention to resolve the above long pending pension issue.

"We wish to inform that the Council Members of All India State Bank of India Staff Federation (AISBISF) retired from all Administrative Circles of the Bank meet once in a year since 2010 under the banner of our organisation styled as "FORUM OF FORMER COUNCIL MEMBERS OF ALL INDIA STATE BANK OF INDIA STAFF FEDERATION" with a view to develop friendship amongst members coupled with various other aims and objectives which are of common interest concerning us. While Shri. M. R. Awasthi is the President, Sarvashri Sankareshwar Datta and Profulla Kumar Patnaik are the Joint Convenors of the Forum.

In the 5th Annual Meet of our organisation which was held at Guwahati on 22nd February 2015 participated by members presided over by Shri. D. Venugopal Reddy, Vice-President of the Forum, decided unanimously to place before your good-self over the pathetic light of the 7th Bipartite Retirees as regards their Basic Pension payable to them.

You are well aware that around 40,000 Employees & Officers of the Bank retired during the period between 1st November 1997 and 31st October 2002 drawing the salary under the 7th Bipartite settlement signed in the year 2002 at Industry Level, of which around 25,000 employees & officers retired under 'SBI Voluntary Retirement Scheme - 2001'. It will not be out of place to state that many of our former Council Members of AISBISF are also the unfortunate lot who fall under the category of such retirees. We wish to point out that all these retirees are being paid the basic pension from their respective date of retirement computed on the basis of pre-revised scale i.e. pay in terms of 6th Bipartite Settlement, but on the revised rules of SBI Employees Pension Fund Rules, 1955 (now known as SBI Employees Pension Fund Regulations - 2014) that came into force in the year 2000 which read as under:

REGULATION 23: Computation of Pension - (1) Subject to the provisions of Sub-regulations (2) and (3), the pension payable under Regulations 22 shall be the amount calculated at the rate of one-sixtieth part of every year's pensionable service of the average monthly substantive salary drawn during the last twelve months' Pensionable service. (2) The maximum pension shall not exceed one-half of the average monthly substantive salary drawn during the last twelve months' pensionable service or rupees two thousand four hundred per month (pro-rata in the case of Part-time employees) whichever is less; Provided that the maximum pension shall be increased for the members who retired or retire on or after the 1st November 1993.........

Provided further that with effect from the 1st March 1999 the maximum amount of pension for the members who retired or retire drawing substantive salary in the pay scales effective from the 1st November 1992 (Award Staff) 1st July 1993 (Supervising Staff) and thereafter shall be computed till further amendments in this regard as under:

- (a) Where the average monthly substantive salary drawn during the last twelve months' pensionable service is up to rupees eight thousand five hundred per month, fifty per cent, of the average monthly substantive salary drawn during the last twelve months' pensionable service (pro-tata in the case of part-time employees) and
- (b) where the average monthly substantive salary drawn during the last twelve months' pensionable service is above rupees eight thousand five hundred per month, "on account of administrative instructions of the Bank issued during the end of 2000 conveying that their basic pension would be revised on the basis of revised pay scale of 7th Bipartite Settlement, soon after obtaining the approval of Government of India to its proposal to pay the basic pension on the revised pay under 7th Bipartite Settlement. Thus, the retirees between 1st November 1997 and 31st October 2002 continue to receive their basic pension only on the pre-revised scales till date. Similarly the retirees between the 1st November 2002 and 30th April 2005 drawing the pay scales under 8th Bipartite Settlement have also been deprived of their legitimate pension up to 30th April 2005 and paid pension only on the basis of pay scales under 6th Bipartite Settlement from the date of their retirement up to 30th April 2005 which has since been modified on the basis of revised pay under 8th Bipartite Settlement with effect from 1st May 2005 based on the instructions issued by the Bank in the middle of 2006. We have been patiently waiting all these years that the Bank will arrange to pay the legitimate basic pension on their last drawn pay under 7th Bipartite Settlement in the case of retirees between 1st November 1997 and 31st October 2002 and also in the case of retirees between 1st November 2002 and 30th April 2005 from the date of their retirement, particularly when the retirees drawing the pay scale revised under 8th and 9th Bipartite Settlements are sanctioned payment of basic pension on their last drawn pay with effect from 1st May 2005 in the case of 8th Bipartite retirees and from the date of retirement in the case of 9th Bipartite retirees.

It is pertinent to be noted in this connection that the Senior Head Messenger who retired between 1st November 1997 and 31st October 2002 are also being paid pension only on the pre-revised scale i.e. under 6th Bipartite Settlement despite the fact that their last drawn pay under 7th Bipartite Settlement falls below the ceiling of pay i.e. Rs.8,500/- specified under the Rule / Regulation 23 making them eligible for 50% of their last drawn pay, thus they are also now deprived of their legitimate pension to the extent of around 25%. Besides that the family pension of such of those 7th Bipartite retirees which was initially calculated on the basis of the pre-revised scale of 6th Bipartite Settlement has since been revised on the basis of 7th Bipartite scale of pay last drawn by such retirees, but unfortunately their own basic pension is yet to be revised despite the lapse of around 17 long years during which period a large number of them having already reached their heavenly abode.

We may be permitted to drawn your kind attention that the Rules / Regulation 23 under Rules - 1955 or for that matter under Regulations - 2014 do not envisage payment of basic pension on the basis of computation of pre-revised scale drawn by them, but stipulate computation of basic pension only on the basis of last drawn pay.

We therefore appeal to your good-self to kindly bestow your personal attention in the matter and seek your indulgence so as to enable the retirees of 7th Bipartite Settlement to get some relief in these hard days of high cost of living by receiving their legitimate basic pension computed on their last drawn pay from the date of retirement as envisaged in unambiguous terms in the SBI Employees Pension Fund Rules 1955 (now known as SBI Employees Pension Fund Regulations, 2014)."

Slow and Steady wins the Race

Negative factors have also positive aspects. Fear is negative. But, care to be taken to avoid negative things is caution and is a positive aspect of fear. Hurry is bad as we will make many mistakes. Slowing down is opposite of hurry to avoid problems which can be created by hurry. Thus a steady approach is a positive aspect of hurry to avoid problems. If we are in hurry, we may forget certain things to do which may result in a problem. While leaving home in a hurry, if we forget to carry house keys it would result in a problem.

Effectiveness requires time to think:

Peter Drucker has quoted a story in one of his management books. Prince Bismark wrote a long letter to his friend and added a postscript, 'I am sorry, I have had no time to write a short letter'. Writing precise matter requires thinking to assimilate thoughts & to present them properly without making the contents too long. Solution to this problem is blurting out what we want to convey while dictating and making it precise thereafter by eliminating many words and/or sentences. In a long letter it would be difficult to find the correct contention. But, in a precise and concise letter it is very easy to understand the correct aspect and contention.

Stephen Covey narrated 'The Story of a woodcutter'. On the first day, he cut down 18 trees, the next day despite hard efforts, he could cut only 15 trees. Day after day, his tally was going down. Finally, the boss asked him as to when did he sharpen his axe last time. The woodcutter said he was very busy trying to cut trees & had no time to sharpen his axe. Stephen Covey summarises that we need time to relax, to think and meditate, to learn and grow.

No extremity in a virtue:

Ashwathama, son of Dronacharya, was born after severe penance of Shiva by his father. He was deathless. In the Mahabharata war at Kurukshetra ,when there was a rumor that Ashwathama died, Dronacharya enquired from Yudhishthira (Dharmaraja), about the rumour. Ashwathama was also name of an elephant .Yudhishthira said, 'Narova Kunjarova', although he knew that the elephant was killed. The meaning of what Yudhishthira said was he didn't know whether the elephant died or the man by that name died. For this incorrect reply he had to loose his thumb while going to Heaven with full body after completing his life span on the earth.

Virtue involves morality and while telling the truth moral aspect of the answer is important. In other words, it is not desirable to go to extreme of truthfulness if it is not possible to adhere to moral aspect of the answer. The approach has to be balanced with positive intention & morality aspect.

If a thief or a robber chases some body & enquires with a person on way whereabouts of the later, the truth should not be told of the correct path. Rather innocence should be maintained. The important aspect while answering is to have positive & moral approach.

The story of the race of hare and tortoise is important. The hare started running and got tired. After watching that the tortoise was far behind, the hare slept. The tortoise was slow but not tired. While the hare was sleeping, the tortoise reached the destination. The story is symbolic. As Stephen Covey says, we need time to relax & grow.

Positivity for satisfaction:

Sant Kabir says in one of his couplets(dohas) that when an individual is born all people around smile. He should lead his life performing good deeds for service of others without any expectations. This will fulfill his life with satisfaction & happiness. He will depart from the earth when his time comes. But, the world will weep. This is the way activity should be performed while living on the earth. The

company we keep is also important .In Mahabharata, negativism of Karna's charioteer weakened & lowered motivation & confidence of Karnna. Lord Krishna was charioteer of Arjuna who improved confidence of Arjuna.

Conclusion:

Fear is a negative character. But, it has a positive aspect like caution. Positive character can't be exercised to its extreme, as we have to look to the moral aspect while implementing it. Every action has equal & opposite reaction in the normal course. We should increase the gap between reaction to any action to allow us time to remain positive and moral in our reaction. When we are slow and steady, it is possible to come to the conclusion where we can find balance and happiness. That is the way to win the race in life. Tattvaloka monthly issue of July 2014 was useful to recollect various events & google of Internet enabled to get clarity. I have written the article for the benefit of fellow pensioners as also for better understanding of the concepts to me.

अमलात येत आहेत. पॅरॅलेसिस वरील उपचारपद्धतीमध्ये सुधारणा दिसू लागेल. अवयवदानाबद्दल देहदानाबद्दल जगजागृती चालूच आहे. मध्यंतरी बेंगलोरमधील रागणाकडून मानवी अवयव शीघ्रगतिने चेन्नईला नेऊन तेथील रागणाचे प्राण वाचवण्यात डॉक्टरांना यश आले. यामध्ये भविष्यात अजून प्रगती संभवते.
