'मी' 'आत्मप्रौढी' 'अहंभाव' ह्याच गोष्टी माणसाला सुधारू देत नाहीत. मी नेता, मी प्रतिष्ठित, मी व्ही.आय.पी. हाच अहंकार आपल्या जीवनाची चौकट आक्रसत नेतो. नेतेपदापर्यंत, प्रतिष्ठितपणापर्यंत पोहोचण्यामागे बऱ्याच गोष्टी कारणीभूत असतात. नेत्यामागे कार्यकर्त्यांचे कार्य, आवेश, सहकार्य. त्यांनी उंच ध्वजासाठी काठी होऊन दिलेला आधार हे सगळं विसरून ते नेतृत्वाची झूल मिरवत असतात. नेहमीच्या परिचयाचे उदाहरण द्यायचे तर वारकरी, इतर भक्तगण पांड्रंगाच्या दर्शनासाठी चालतच दिंडीत सहभागी होतात. पायीच वारी पूर्ण करून दर्शनाचा लाभ घेतात. काही जण आम्ही पायीच वारी पूर्ण केली असे गौरवाने सांगतात व श्रेय स्वत:कडे घेतात. परंतु अगदी सहज विचार केला तर ते चालत नाहीत तर

त्यांची पाऊले चालतात, म्हणून तर असे म्हणतात की **'पाऊले** चालती पंदरीची वाद' मग कितीजण याचे श्रेय पाऊलांना देतात, त्यांच्याबद्दल कृतज्ञता व्यक्त करताना दिसतात?

दिवा प्रकाश देतो, म्हणून तो अहंभाव, आत्मप्रौढी करत नाही. त्याला माहित आहे की अंधार आहे म्हणून प्रकाशाला महत्त्व आहे. त्याला याची पूर्ण जाण आहे की, वात जळते तसे तेलही जळते आणि तेल जळते म्हणूनच आपण उजळतो.

Status of our W.P. 1875/2013 in Delhi High Court

While there are no fresh developments to report since our last advice, we wish to inform that the W.P. listed under Regular Matters for final hearing are taken up by the Delhi High Court only after the completion of hearing of the W.P.s for admission as fresh cases or after notice matters. The hearing of such admission matters takes almost the entire time of the Court on most of the days and only a limited time is available, when W.P. under Regular Matters reaches the board. The hearing of the W.P.s listed with the seniority above our W.P. under Regular Matters has since been completed. In the cause list as on date, our above W.P. has been listed as the first item under Regular Matters by the Delhi High Court to take up our W.P. immediately on completion of cases listed under the Advance Matters on any of the week days. Our Advocates are closely following up the proceedings and will submit their arguments in support of the prayers made in our above W.P. We are constantly monitoring the position and shall keep you advised of the developments.

COURT CASE C.W.P.No.18586 / 2015 converted to Case No. 30746 / 472015 SBI and others Versus Kiran Kumar Jaipuriar

Our colleagues are aware that Sh. Kiran Kumar Jaipuriar, a colleague of ours posted in Jharkhand sought retirement from the Bank on 30.04.1998 (under 7th Bi-partite Dispensation). Accordingly, his pension was fixed as per pre-revised scales applicable to 6th Bi-partite Retirees. Sh. Jaipuriar filed a Writ Petition at Ranchi High Court, which was transferred to Delhi High Court for final disposal.

On 6th April, 2015, Delhi High Court decided the case in favour of Sh. Jaipuriar and directed the Bank to include his Basic Pay for the month of April, 1998, as per Revised 7th Bi-partite Pay Scales. The Bank subsequently filed a Revision Petition in Delhi High Court, which was dismissed. The Bank then approached the Hon'ble Supreme Court of India, against the Delhi High Court order. The appeal by the Bank has been dismissed in the Supreme Court on 16.10.2015.

While dismissing the appeal the Court passed the following order :-

"Dismissed. However, the question of Law is kept open."

Our Advocate from Delhi advised the meaning as under :-

"This order should not be treated as binding on other cases. Legal issues are not decided."

Let us see what course the Bank now adopts in this case. The case is mainly relevant for 7th Bipartite Retirees. We shall keep you advised about the developments.

THREE DECADES FEDERATION OF S.B.I. PENSIONERS' ASSOCIATIONS PERIOD COVERED 20-07-1987 TO 05-03-1989

I retired from the Bank's service on Saturday, the 28th February, 1987. At the instance of Late Shri. S.S. Pandit, from July, 1987, I started participating in the activities of Mumbai Circle Pensioners' Association. In the history of Federation and Pensioners the captioned period is very important. Therefore it took time for me to collect the material and write this article.

Since January, 2015 we missed, forever, the company of Late Sarvashri E.K. Thakur, N.S. Kulkarni, V.R. Kuddyady and B.P. Khare. Shock of this affected my work.

So far I had written three articles strictly based on records available with me. However, hereafter, I shall be writing based on records available to me and also based on my personal diary and memories.

Under Article 32 of the Constitution of India, a Writ Petition No. 305 of 1987 was filed in the Supreme Court of India on 04-3-1987 by Imperial Bank of India Pensioners' Association (Delhi Circle). The case again came up for hearing on 12-01-1988. The Government pleader at the very outset informed the Court that the Government of India has almost taken a decision for changing the Pension Fund Rules giving considerable relief to old Pensioners. Our Counsel requested for a copy of the proposal. However Bank's Counsel expressed his inability as the approval of the Reserve Bank of India and Central Board of the Bank was awaited.

In view of the above the case was adjourned for a period of six weeks (Ref. Fed. Circular Dt. 12-01-1988).

Most awaited letter of approval (dated 18-03-1988) from the Government of India, Ministry of Finance (Banking Division), was received by the Bank. On Monday the 21st March 1988 myself and late Shri. S.S. Pandit got a copy of the letter No. F-1/24/88/IR dt. 18-3-1988 from the Govt. of India, Ministry of Finance (Banking Division), addressed to the Chairman, State Bank of India, Mumbai. On the same day a copy of the above letter was forwarded to our Associations' Head Quarter i.e. at Pune, who in turn forwarded the copies thereof to Federation (New Delhi) and to Associations at Ahmadabad, Kolkatta, Indore, Lucknow and Chandigarh, vide letter dated 23-03-1988. (Special addition in that letter was "Our Mumbai Centre representatives are successful in getting a copy of Govt.'s sanction letter to the Bank's proposal".)

Comments on GOI's Letter Dt. 18-03-1988

Pension to be calculated on the average substantive salary drawn during the last 12 months' pensionable service (as per Bank's recommendation);

No change in the formula for calculation of pension (as per Bank's recommendation).

Ceiling on pension - Maximum 50% of pensionable pay subject to maximum as under :-

Rs.2,400/- for Officers, Rs.1,000/- for Award Staff.

Bank's recommendation - 50% of pensionable salary to all employees, Maximum Rs.2,400/-p.m.

I.B.I. Retirees lost the benefit of pensionable service, if more than 30 years.

Ceiling of Rs.1,000/-p.m. for Award Staff was not acceptable to our Federation and also Award Staff Federation. Even in Bank's proposal it was clearly stated that the salary (Basic) + Stagnation increments + permissible allowances would be more than Rs.2,400/- p.m. for Award Staff. That time the maximum salary of Dy. Managing Director was Rs.4,800/- p.m. (D.A. merger 332 pts - 1960 = 100 i.e. prior to 1-11-1987).

The Bank had also mentioned in their proposal Dt.28-08-1986that the revision of salary for all

employees is overdue. Thereafter in 1989 salary of all employees was revised - effective from 01-11-1987) (D.A.600 pts. merged - 1960=100)

Minimum Pension of Rs.200/- p.m. was raised to Rs.300/- p.m.

Benefit of above revision was extended to all earlier retirees, however, w.e.f. 01-01-1987.

Family Pension Scheme - Relevant extract from the above letter Dt. 18-03-1988 from GOI is as under:

"A relevant provision may be added in the Pension Fund Rules for enabling the Trustees of the Pension Funds to sanction Family Pension, on the terms and conditions approved by the Central Board, to the dependents of an employee, who die while in service of the Bank on completion of pensionable service of one year or after retirement."

All the modifications to come into effect from 01-01-1987. (Bank had recommended that this should be effective from 01-02-1984 i.e. The date of revision of officers' salary - Base 332 pts D.A. Merger).

On 26-03-1988 Late Shri. P.S. Santhanakrishnan and the undersigned called on late Shri. M.N. Sheorey, Chief General Manager, Personnel (Central Office). We thanked him for getting the approval for revision of pension and introduction of "Family Pension Scheme." However we added that the ceiling on pension of Rs.1,000/- p.m. for Award Staff is inadequate even for existing salary wherein D. A. upto 332 points has been merged. We suggested him to take up this issue with the GOI. We added that according to this all the officers will receive pension calculated at 50% of pensionable pay, whereas some of the employees from Award Staff will be deprived from getting pension at 50% of their pensionable pay.

Later on we talked to Shri.J.C. Sah (AGM) about minimum pension and D.R. rates applicable to such pensioners. He confirmed that this minimum pension is related to cost of living index at 332 points level.(Later on, this was confirmed in one of the circular letters addressed to all L.H.Os.)

The Bank finally took the cognizance of this and recommended to GOI that there should be only one ceiling of Rs.2,400/-p.m. In spite of such recommendations the GOI conveyed the approval for the ceiling of Rs.1,300/- p.m. in respect of Award Staff (Increased from Rs. 1,000/- p.m.).

On 08-08-1988, late Shri Santhanakrishnan and myself again met the Chief General Manager (Personnel). We were told that now the GOI has directed to implement the ceiling of Rs.1,300/-p.m. in respect of pensioners from Award Staff. However the approval from Reserve Bank of India was then awaited.

On 10-08-1988 Writ Petition came up for hearing and was posted for hearing on 25-08-1988.

On 25-08-1988, the Writ Petition filed by I.B.I. Pensioners' Association (Delhi Circle) came up for hearing before a new bench comprising of Hon'ble Mr. Justice Oza, Mr. Justice Dutt and Mr. Justice Shetty. The moment our Senior Lawyer stood up to open our case, the Bank's Counsel, Shri. S.S. Sharma, informed the Court that the Bank's revised scheme for pension was being placed, this very day, before the members of the Central Board of the Bank for final clearance and adoption and that an adjournment may please be granted to enable the Bank to produce before the Court the approved scheme after about a week's time. Accordingly, the Court directed that the case be listed for further hearing after three (3) weeks by which time the petitioners too would have studied the final proposal and would be in a position to offer their comments and reactions.

On 25-08-1988, finally to give effect to the revision of Pension Schemes, the Central Board of the Bank at its meeting held on 25/08/1988 amended Rules No. 18 and 20 of the I.B.I. Employees' Pension and Guarantee Fund Rules and Regulations and Rule 23 of the S.B.I. Employees' Pension Fund Rules. The Board also approved the Family Pension Scheme newly introduced in the Bank. The effect of these amendments in nut shell was as under:-

Pension to be calculated on the basis of average substantive salary (Pensionable pay) drawn during the last 12 months pensionable service.

The revised ceiling on pension will be as under :-

Rs.1300.00 p.m. for Award Staff

Rs.2400-00 p.m. for all Officers.

Maximum Pension:- 50% of Pensionable Salary, subject to above ceiling and for 30 years pensionable service.

The pension payable to the staff in India under the revised Rules from 01-01-1987 shall not be less than that payable under the previous Rules. (Such situation can arise only in respect of I.B.I. Pensioners).

Minimum Pension:- Rs.300/- p.m.

Family Pension Scheme introduced :-

Substantive Salary p.m. Rate of F.P. per month

Rs.1500/- and below 30% of salary minimum Rs.300/- per month

Above Rs.1500/- p.m.15% of salary - minimum Rs. 450/- p.m. and maximum of Rs.1,000/-p.m.

Our Bank is the first Bank to introduce Family Pension Scheme in the Banking Industry.

The aforesaid modifications come into effect as from 01-01-1987.

A copy of the circular letter No.-PA:CIR: 130 of 25-08-1988 issued by Central Office of the Bank and addressed to the Chief General Managers of All Circles of the Bank was obtained from the Central Office by the undersigned and forwarded to our Pune Head Quarter, who in turn forwarded the same to Shri. B.D. Mehta, New Delhi and to other Circle Associations.

NOTE:-

In connection with 'Family Pension Scheme' it has been stated that the maximum Family Pension would be Rs.1,000/- p.m. That time the maximum salary of the Dy. Managing Director was Rs.4,800/-p.m. (D.A. Merger 332 pts.) . In his case, as per above formula, F.P. works out to Rs.720/- p.m. only. Then why the ceiling of Rs.1,000/-p.m. has been stipulated? The reason is as under :-

"If one or both the family pensions are payable at the rates mentioned in the proviso to paragraph 2, the amount of both the family pensions shall be limited to Rs.1,000/- p.m. or the maximum amount of family pension payable in respect of any one of the parents, whichever is higher for the specified period."

(Situation as stated above, arises only if the death of the employee (one or both) happens, within first five years after retirement.)

Ref.:- Central Office letter No.PA:CIR:130 of 25-08-1988 and No.PA:CIR:44 of 10-05-1990.

Major comments by Shri. B.D. Mehta, General Secretary, as per his note Dt. 14-09-1988, are as under:-

Formula negated the benefit of length of pensionable service, over 30 years, (This benefit was applicable only to I.B.I. Pensioners).

Two ceilings viz. Rs.2,400/- and Rs.1,300/- Though the Bank had filed an affidavit in the Supreme Court that there will be only one ceiling.

Minimum pension of Rs.300/- p.m. to pensioners of Presidency Banks w.e.f. 01-01-1983, whereas for IBI/SBI Pensioners it is w.e.f. 01-01-1987.

Bank recommended effective date as 01-02-1984, whereas GOI approved from 01-01-1987 without assigning any reasons.

Introduction of Family Pension Scheme - A Welcome step.

On 03-09-1988 - Amendment made in S.B.I. Pension Fund Rules as under :- Pensionable service will

be calculated from the date of completion of 18 years (instead of 21 years) w.e.f. 01-09-1988 or from the date of joining (for Probationary Officer) or date of confirmation (for Award Staff) in the Bank's service, whichever is later. Benefit of this amendment should be given even to earlier retirees of course from 01-09-1988. Benefit also extended to IBI Pensioners.

Ref.:- C.O. Letter No.PA:CIR:137 of 03-09-1988 to all L.H.Os.

(As stated above, benefit was extended to earlier retirees without waiting for our demand. However now the benefit of "100%- D.A. Neutralization" given to pensioners w.e.f. 01-05-2005 has not been extended to earlier retirees in spite of our pointing out earlier practice and also Supreme Court Judgment Dt. 03-10-1998. (Civil Appeal No. 5048 of 1998. V. Kasturi V/s. State Bank of India)

On 25-10-1988 - Ad-hoc Fixed Additional Dearness Relief (AFADR) was granted. Details of this have been published long back in Samvad. (Ref.:- PA:CIR:163 of 25-10-1988 to all L.H.Os)

On 11-11-1988 - Sometime in early November 1988, late Shri Santhanakrishnan and myself discussed the issue of sanctioning minimum pension (Rs.300/- p.m.) to all pensioners who are at present in receipt of pension less than Rs.300/- p.m. We brought to the notice of the Chief General Manager that the procedure laid down in Central Office Circular Letter No. PA:CIR:152 of 30-09-1988 need not be followed and L.H.O. CGM may be given authority to sanction the minimum pension only to existing pensioners. This issue was also discussed with DGM (IR), who was in favour of the suggestion. Our suggestion was approved and instructions issued to all L.H.Os. (No. PA:CIR:162 of 11-11-1988).

By end of December 1988, LHOs. were told to submit a control return on the prescribed form.

This resulted in considerable reduction of work at PPG Department at LHO and Central Office and all such pensioners were also happy as their pension was revised before 31-12-1988.

On 26-12-1988 - The proposal prepared by our Mumbai Office for graded dearness relief (allowance) to pensioners who retired in different scales (Viz. D.A. merger 100, 200 and 332 points) was forwarded to Federation by our Pune Office, for consideration. However, though the Federation liked the proposal it was felt that it is not proper to discuss this at present as the Writ Petition was pending in the Supreme Court. (The same proposal later on was discussed by late Shri Santhanakrishnan and the under signed, with Central Office Officials and thereafter with certain modifications it was implemented by the Bank.)

On 23-02-1989 - Long awaited Judgment in respect of Civil Writ Petition No. 305 of 1987 filed on 04-03-1987 by I.B.I. Pensioners' Association (Delhi Circle) was pronounced.

The revision implemented by the Bank was approved with following changes :-

- i) Only one Ceiling of Rs. 2,400/- p.m.
- ii) Effective date 01-01-1986. (instead of 01-01-1987)
- iii) Family Pension Scheme also approved for which effective date was changed from 01-01-1987 to 01-01-1986.
- iv) "The petition is partly allowed to the above extent with costs which we quantify at Rs.5,000/-. The Respondent Bank will pay the same."

Bench - Hon'ble Mr. Justice K. Jagannatha Shetty, Hon'ble Mr. Justice A.M. Ahmadi, Hon'ble Mr. Justice Kuldip Singh.

On 23-02-1988 - Establishment of Mumbai Zonal Sub - Centre (Under S.B.I. Pensioners' Association (Mumbai Circle), Pune.

Considering the need of good rapport with Central Office (Now known as Corporate Centre) and Mumbai L.H.O, a Zonal Sub-Centre was established in Mumbai on the 23rd February 1988. Inaugural

address was of late Shri. P.T. Chaphalkar, President of the Circle Association (H.Q. Pune). The Meeting was also addressed by late Shri. G.S. Aphale, Vice President, Late Shri. N.D. Ranganathan General Secretary, Chennai Circle Pensioners' Association as Special invitee and Shri. K.D. Paradkar, General Secretary of the Association. The following office bearers were unanimously elected.

Shri. S. S. Pandit - President Shri. B. G. Dandekar - Secretary Shri. M. K. Neurekar - Treasurer

On the day of inauguration of the Zonal Sub-Centre there were only 120 pensioners in Mumbai and Thane. Out of this 80 pensioners attended this meeting.

I thank Shri. V. M. Gokhale, then President of the Mumbai Circle Association, for promptly approving the recommendations of Mumbai Zone for purchase of office for use of the Zonal Office.

This Zonal Office has played the role of a Liaison Office of the Circle Association and even that of the Federation. Even now the position has not been changed.

I have watched the progress of this Zone very closely as out of the last 28 years, I was office bearer for 21 years either of the Federation or that of the Mumbai Circle Association.

This note on Mumbai Zone cannot be completed without mentioning the contribution of Late Shri. V.R. Kuddyady, Shri. V.M. Gokhale and at present Shri. S.B. Gokhale, President of the Circle Association. The Federation Secretary's Report presented before the Federation Annual General Meeting held at New Delhi on Sunday the 5th March, 1989:-

A copy of the report was given to us at the time of the Meeting, hence we had no time to read and think over on the contents of the report.

SUMMARY:-

In the Report it has been stated that copies of the Judgment dt. 23-02-1989 were dispatched to all for

study with utmost expedition by private arrangement (though certified copy was yet to be received). (However Circle Associations Viz. Ahmedabad, Banglore, Hyderabad, Kolkata and Pune did not receive the copies in question).

COMMENTS ON JUDGMENT:-

"From the very beginning the Bank's stand was that the petitioners had no locus standi(1) and that the petition which suffered from laches(2) and staleness should be dismissed in limine(3). What a rebuff the Judgment has given to the Bank's claim is evident from the fact that not only our petition was entertained but a penalty of Rs. 5,000/- has been imposed upon the Bank by way of costs which the court rarely awards in such cases and was not even demanded by us. In famous Nakara Case no order as to costs was passed although it was specifically asked for."

Revision from 01-01-1986 and one common ceiling of Rs.2,400/-p.m. was a great achievement. (That time maximum salary of Dy. M.D. was Rs.4,800/- p.m.)

Other improvements done by the Bank were confirmed.

Judgment did not touch our grievances viz.

- i) Index linked D.A. like working Staff;
- ii) Updation of pension after every salary revision.
- iii) Medical Aid and
- iv) Family Pension Uniform rate of 30% for all eligible spouses.

The Secretary felt that "We can legitimately draw solace from the Judgment which weighs heavily in our favour."

Finally the Secretary stated that "Now, that we have played our innings and half of our task has been done. I look to our friends from Bombay (Mumbai) who are so close to the Centre of Bank's power to prepare themselves to step into our shoes as and when we unburden ourselves of the responsibilities of office and take upon themselves the duty to complete unfinished work."

On 05-03-1989:- Third A.G.M. of the Federation was held on Sunday, the 5th March, 1989 in the conference hall of the Sanatan Dharam Mandir, Greater Kailash - I, New Delhi.

GIST of the Proceedings:-

From 10 Circle Associations 34 representatives attended the Meeting. The Meeting was also attended by Sarvarshri H.C. Sarkar and S.P. Puri (both Patrons), A.B. Majumdar and K.D. Nayar.

From Mumbai Circle Association following attended the AGM:-

Shri. S.R. Rege, Vice President.

Shri. K.S. Gharpure, Vice President.

Shri. V.M. Dravid, Secretary.

Shri. B.G. Dandekar, Secretary - Mumbai.

The Supreme Court Judgment was pronounced on 23-02-1989, hence all the focus was on the contents thereof. However majority members had not received, in advance, a copy of the Judgment under reference. Earlier before the Meeting, when Shri. C.L. Kapoor (Secretary - Delhi Circle) arrived at the venue, he brought a few copies, however instead of giving a copy to each Association, he simply threw all the copies towards the audience. (Late Shri. Kuddyady was able to catch one copy for our Association.)

This was not liked by many members. Shri. M.L. Majumdar expressed his dissatisfaction about the action of Shri Kapoor.

Shri. B.D. Mehta, Secretary, explained, in detail, the contents of the Judgment (as stated earlier in this article). Finally he suggested that the present team of office bearers had done their job to the best of their ability and the burden of looking after the affairs of the Federation be now shouldered by friends from Bombay (Mumbai) who are nearer to the Bank's power Centre. However friends from Madras objected to this suggestion. In the meantime Shri Rege stated that although they had no objection to undertake any responsibility, it was their earnest desire that unfinished task should continue to be looked after by the present team. I supported the suggestion of Shri. Rege. Hence this issue was not pursued. (In this connection before leaving for Delhi our President, viz. Late Shri. L.N. Pabalkar had suggested us that at this stage the H.Q. of Federation should not be shifted).

In the open discussion Sarvashri late P.S. Santhanakrishnan, M.L. Mujumdar, Padam Narayan, R.S. Kulkarni, M.M. Bijawargi, M.L. Kolhekar and A.V. Nagarswamy took active part.

The discussions were more on implementation as per Bank's Scheme as modified by the Supreme Court. All were unanimous in their views that all out efforts should be made by the entire membership in identifying persons eligible for family pension.

It was decided that no unit (Circle Association) to take up any matter directly with Central Office and only to correspond with respective Head Office (Circle L.H.O.) concerning grievances of their members. (Even now this principle holds good)

About "AFADR" the extract from the proceedings is as under :-

"Shri. Dandekar advised that he had worked out the total cost which the Bank might have to incur by granting liberal relief to old pensioners' "His efforts were greatly appreciated by one and all."

The Meeting came to a close with a vote of thanks to the Chair.

Further developments after the 4th AGM which was held at New Delhi on 04-03-1990 will be given in the next article.

SBI RETIRED EMPLOYEES' MEDICAL BENEFIT SCHEME EXTENSION OF BENEFIT TO SURVIVING SPOUSES OF EMPLOYEES WHO DIE WHILE IN SERVICE

Surviving spouses of employees who die while in service are currently not eligible to become member of the SBI Retired Employees' Medical Benefit Scheme (SBIREMBS) under the existing provisions of SBI Retired Employees' Medical Benefit Trust Rules.

- 2. In this connection, the Executive Committee of the Central Board in its meeting held on 23.09.2015 has approved following modifications in scheme:
 - i. The spouses of only those employees who die while in service after putting in at least 20 years of pensionable service and after attaining the age of 50 years and above (both the conditions to be satisfied) may be allowed membership of SBIREMBS. The membership will be restricted up to Plan-'E' of the existing scheme (i,e. 'A1', 'B1', 'C1', 'D1' and 'E').
 - ii. The medical benefit will accrue to the spouses on and from the notional date of superannuation of the deceased employee at the age of sixty years, had he / she remained alive or the date of taking membership within a period of 3 months thereafter, whichever is latter.
 - iii. Such eligible spouses would take membership of the scheme by contributing subscription on the same line of provisions in existing scheme within 3 months from the notional date of superannuation of the deceased employee (at the age of 60 years) had the employee remained alive.
 - iv. The modification will have prospective effect from the date of approval by ECCB i,e. 23.09.2015 and shall be applicable to cases of death occurred on or after that date.
- 3. All other instructions relating to SBIREMBS shall remain the same.
- 4. Please bring the contents of this e-Circular to the notice of all concerned.

PAYMENT OF STAFF PENSION SUBMISSION OF LIFE CERTIFICATE & ACKNOWLEDGEMENT

Pensioners and family pensioners are required to submit Life Certificate in the month of November every year and pension payment for the defaulting pensioners gets discontinued from the month of next February.

- 2. In this connection, it is observed from the various complaints received at this office that staff pensioners have submitted the Life Certificates well in advance and they are holding manual acknowledgement having submitted their life certificate, still they are included in the list of defaulters and their pension is discontinued, reason being non-updation of Life Certificate into the system by the Branches. Inadvertently or negligently these certificates are neither promptly entered nor authorized by the Branches with the result that staff pensioners get a suffering.
- 3. To overcome this issue, instead of requirement of issue of manual acknowledgement by the branches, CSPPC system is now generating the acknowledgement instantly after updating and authorizing the Life Certificate in the system at Branch.
- 4. All branches are, therefore, while entering the Life Certificate into the CSPPC system, shall be required to authorize the same into the system immediately and handover the system generated acknowledgement to the staff pensioner. The entire process will be completed in one go and will reduce the incidents of non-updation of the Life Certificate into the system.
- 5. Please bring the contents of the Circular to the knowledge of all concerned for meticulous compliance.

IBI / SBI PENSIONERS SUBMISSION OF DIGITAL LIFE CERTIFICATE "JEEVAN PRAMAAN"

Pensioners and family pensioners are required to submit Life Certificate in the month of November every year for the uninterrupted payment of pension every month. Government of India, on 10th November 2014 has launched 'Jeevan Pramaan' an 'Aadhaar based Digital Life Certificate' for pensioners. This initiative is in addition to the existing system of physical submission of Life Certificate by pensioners at the pension disbursing branches or any branch of the Bank at his / her convenience.

- 2. In this connection, Government of India, Ministry of Finance, Central Pension Accounting Office, New Delhi have advised that "A life Certificate issued online by a Government Agency as a result of Aadhaar Biometric Authentication will also be accepted as a valid certificate".
- 3. Digital Life Certificate submission involves biometric authentication by the pensioner from remote point and creation of life certificate maintained in digital repository in NIC. Following steps are to be followed for enrolling and submitting digital life certificate.

Enrollment

Pensioner has to download the PC/ Mobile application from jeevanpramaan.gov.in or alternatively visit the nearest Branch or Jeevan Pramaan Centre (available under 'locate centre' under ''jeevanpramaan.gov.in' for registration. He / She will provide necessary information like Aadhaar number, Pension Payment Order No.(PF Index Number),Bank Account No., Bank Name and Mobile number.

Aadhaar Authentication

Pensioner will provide biometrics ie. a finger print and authenticate himself / herself. (Jeevan Pramaan uses the Aadhaar Platform for on-line biometric authentication)

· Life Certificate.

After successful authentication an SMS acknowledgement is sent to pensioner's mobile number including Jeevan Pramaan Certificate ID. The certificate is stored in the Life Certificate Repository

for making it available anytime and anywhere for the pensioner and the Pension Disbursing Agency.

· Access to Certificate

Pensioner can download a PDF copy of the certificate from the Jeevan Pramaan website by providing the Jeevan Pramaan ID or Aadhaar number.

Pension Disbursing Agency

The Pension Disbursing Agency can access the Life Certificate from the Jeevan Pramaan website and download the same.

Electronic Delivery

The Life Certificates can also be electronically delivered to the Pension Disbursing Agency, without any manual intervention. Additionally the Pensioner can login by providing his Pramaan ID or Aadhaar number to generate One Time Password and use the same to sign in to the system to download the certificate.

- 4. As the entire process is primarily Aadhaar based, digital life certificate submitted by the pensioner can be authenticated only when pensioner's account is seeded with Aadhaar Number.
- 5. Branches are, therefore, advised to publicize to pensioners the benefits of this initiative and motivate them to seed their pension accounts with Aadhaar number. The Aadhaar numbers of pensioners must be fed in CBS data base / pension software in time bound and campaign mode at the earliest.
- 6. All Branches are also advised to prominently display availability of this facility for the pensioners in the Banking hall and educate the pensioners. It is reiterated that physical Life Certificate will continue to be accepted from pensioners if preferred by them.
- 7. Please bring the contents of the Circular to the knowledge of all concerned for meticulous compliance.
