

Dear Members,

1. On behalf of the Managing Committee I am glad to place before you the Annual Report of the Association for the year ended 31st March 2012.

2. Membership:-

The Managing Committee is very much thankful to those members who have put in sincere efforts to enroll 660 new members during the year. It may also be observed that the number of employees who retire (i.e. retirees) is less. So, the number of pensioners who are becoming our Association's members is also less. However, as advised by our President Shri.V.M.Gokhale, more efforts need to be made to achieve the target of 75% membership (of total pensioners/family pensioners of Mumbai Circle) during the coming years. At present our total membership as on 31-03-2012 is 10672 (excluding Associate members). While taking review of efforts made for enrolling new members during the year, it will be worth noting that Shri. Rajiwadekar, Organizing Secretary of our Mumbai Zonal Sub-Centre,

secured Branch-wise lists of 'would be' retirees from PPG Department which were distributed to all the Zonal Sub-Centres with a request to contact them on time and enroll them as our members. In turn, all the district representatives were entrusted the work by the Zonal Secretaries. All such efforts resulted in enrolling maximum number of retirees as our members. We take this opportunity and request our Benefactor / Life members to upgrade their present membership to Patron membership by paying the difference in membership fees. We also appeal to each member of the Association to enroll at least one new member each as is being stressed by our President Shri.V.M.Gokhale in every meeting. Resources :

All of us are aware that it is our constant endeavour to meet the expenses out of our income i.e.

- (a) Interest earned on Deposits;
- (b) Income on investments in Govt. Bonds;
- (c) Donations received from the members;
- (d) Admission fee, and
- (e) Dividends received

Membership fees are retained as 'Trust Fund' and are being invested mainly in Govt. Bonds/ Bank Deposits etc. On Liabilities side, it will be observed that our 'corpus' has increased by Rs.6,35,000/- taking the amount of Trust Fund to Rs.1,78,34,933/-. Legal Fund has been increased by Rs.2,89,486/- and this year also we have sent our contribution of Rs.2,50,150/- to the Federation towards Legal expenses. There are additions to the Distress Relief Fund of Rs.31,974/-. Members are requested to contribute generously towards Distress Relief Fund. In view of Writ petition filed in Supreme Court members are also requested to contribute generously towards Legal Fund to enable us to make our Association financially self-sufficient to meet the legal expenses for getting our legitimate demands accepted through courts. We wish to draw your attention to our appeal for Legal fund published in 'SAMVAD' issues from time to time as also appeal made by our President Shri.V.M.Gokhale in various meetings.

The expenses for 'Printing & Stationery', 'Traveling', 'Meeting Expenses', etc. are gradually increasing as per present market trend. As regards 'Postages', we are getting a concession in postal tariff for mailing up to 13000 copies of "Samvad" @ 25 paise upto 50 grammes weight per copy and Rs 2/- if weight exceeds 50 grammes per copy. Now total dispatches per month are more than 10,300 and this figure is increasing every month due to increase in membership. The renewal of this LWP license has been done and is now valid till 31-12-2013. However, Post Office has recently issued directives to all the LWP license holders (like us) to affix postal stamps of 25 paise on all the SAMVAD copies to be delivered at Market Yard (Pune) sorting office for posting on 25th of every month w.e.f. 1st June 2011. We have already engaged an agency who is securing postal stamps of 25 paise each and affixing them on all the copies before posting on 25th of each month. Not only this, the post office also expects from us to help them to cancel the postal stamps affixed on each copy of Samvad as per post office procedure (which is actually their work). Otherwise the work of delivery of Samvad to all our members may get delayed, since post office does not have sufficient staff to do this work at their disposal. In order to deliver the monthly Samvad in time to our members, we have no alternative but to ask our agency to do the 'post office work' also and requested them to engage more labour and do the needful to comply the post office requirements and see that our 'Samvad' issues reach our members as early as possible. This has resulted in incurring more expenses every month on this type of additional work.

The Association has received interest on Bank Deposits to the tune of Rs.15,48,104/- and on Govt. of India Bonds to the tune of Rs.91,811/-. We have not taken into account interest accrued but

not received up to 31st March 2012 due to change in the accounting procedure. Dividend from other investments amounts to Rs.8,130/-, while Rs.6,600/- were received by way of Admission fees. The members have given Donations of Rs.4,98,079/- during the year for the various reasons. The lists of 'Donors' have already been printed in the past issues of 'Samvad'. You will now observe that our financial position is getting improved and the members will appreciate this. It is worth noting that we have purchased office premises at Panaji during the month of January 2010 which is also being used as our own 'Holiday Home'. The premises have been well furnished and are being occupied by our members during the season. It is worth mentioning here that office-bearers of our Panaji ZSC viz..Shri.P.M.Narkar, Shri.I.H.Dias and Shri.K.V.Gopinathan are making every effort to see that the (Holiday Home) occupants' suggestions are taken care of and are being implemented to improve the staying arrangements to the satisfaction of the members.

## **Donations :**

We have received donations for

- (a) Distress Relief Fund
- (b) for 'Samvad'
- (c) Misc. Donations and
- (d) Legal Fund

Figures at (a) and (d) are reflected in the Balance Sheet on the Liabilities side while the figures at (b) and (c) are reflected on income side of Income & Expenditure A/c. It is our earnest desire to build up a corpus of substantial amount to enable us to give our share of relief from the interest on the corpus for providing relief to affected families of our members as and when there is a national / natural calamity.

As on 31st March 2012 the 'Distress Relief fund' and 'Legal Fund' show balances of Rs1,94,724and Rs.15,82,289/- respectively. We take this opportunity and appeal to all the members to donate generously and increase the funds. We have yet to pay Rs.5,00,000/- (approx.) to our Federation towards "Legal Fund" in respect of Supreme Court case and also cases in Nagpur & Bangalore High Courts.

#### Meetings of the Managing Committee :

In all 4 Managing Committee Meetings were held during the year, of which one was held at Pune and three were held at Thane. Apart from administrative work and financial matters, various issues were discussed, viz., the membership drive, problems faced by the members in general, organizational matters such as pensioners' meetings, contacting non-members, organizing Health camps, arranging informative lectures on various issues of interest, taking review of working of Bank's dispensaries etc. The representatives of each zonal sub-centre actively participated in the discussions.

#### **Annual General Meeting :**

The Annual General Meeting of the Circle Association was held on 31st July 2011 at Satara. Around 850 members attended the meeting. Shri.V.R.Punekar from Pune was awarded "Late Shri.L.N.Pabalkar Memorial Gold Medal" for the year 2010-2011 for his invaluable contribution towards increase in the membership of the Association. Besides usual agenda items, the free and frank deliberations were held during the day on the various issues concerning the membership at large. The arrangements made for the AGM by the Satara unit were appreciated by all.

#### Structured Meeting held at Mumbai LHO on 22-10-2011 :

For the first time a structured meeting of the Circle Association with the Bank Management was held on the 22nd October 2011 and various problems/ difficulties faced by the Pensioners/Family Pensioners in the Circle were discussed and the Management representatives assured us to look

into the matters. Holding of this Meeting had provided recognition and a regular forum to the Circle Association to ventilate our grievances before the Circle functionaries.

### **Special Activities :**

a) House Magazine 'Samvad':- We are publishing our house magazine 'Samvad' on monthly basis and sending it to all the members by post. The magazine is so popular that some of the pensioners from neighbouring states like Madhya Pradesh and Karnataka have also become subscribers by remitting Rs.100/- per year. We are also sending 'Samvad' to all the office-bearers and Governing Body members of our Federation and all the Circle Associations and office-bearers of serving staff Federations. We are also sending our SAMVAD to all the senior executives such as Chairman, M.Ds, Dy.M.Ds, CGMs/CDOs etc. at Corporate Centre and in Mumbai LHO for their information. Our 'SAMVAD' is well accepted by Bank's functionaries and other Circle Association office-bearers as well. 'Samvad' contains latest news on Federation / Association front, reports on organizational and cultural activities undertaken by our Zonal Sub-Centres and District units, literary works of our members like thought-provoking articles on special subjects/occasions, narration of self-experiences while in service, small stories, poems, jokes and cartoons etc. Competition of writing (in Marathi language) is being organized by the Editorial Committee every year and many members participate in it. Prizes are also being distributed to the winners at the hands of our President in our subsequent Annual General Meeting. All the issues of SAMVAD published since January 2007 (up to the latest month) are also made available on our Association's web-site www.sbipensionerspune.org for information and future reference of our members.

**b)** Website :- We had launched our website in 2007 containing useful information for members. Our improved web-site " www.sbipensionerspune.org " contains useful new links such as 'Samvad Magazine', 'Financial Statements', 'Photo Gallery', 'Current News', Bank's/Federation's Circulars', 'DA Rates', 'Financial Statements' etc. We are getting very good response from the members, especially from those who go abroad for certain period and are now able to read our 'SAMVAD' magazine and latest developments on Federation front on our web-site from any corner of the world which is linked with internet. It is observed that the number of 'Hits" from pensioners in our Circle as also from other Circles also are increasing day by day & there is encouraging feedback from pensioner-members of other Circle Associations also when they get latest information regarding developments on our "Federation front". Our members who have not yet visited our website are requested to visit the same very often to know the latest information.

c) Birthday Greetings :- We are getting, almost every week, appreciation letters from members on receipt of 'Birth-day Greeting Card' promptly sent by our devoted member Shri.M.K.Bapat. Now the work is being handled by Shri.Pramod Chate from Pune since Shri.Bapat is now not in a position to continue the work due to his ill health. Shri.Bapat was handling this activity for the last more than 10 years. Shri.Chate has offered voluntarily to do this work and we appreciate very much his prompt willingness to do this work voluntarily. Very often we get letters from family pensioners and old retirees who express their sincere appreciation for this good gesture of Association. Many reciprocate their appreciation by sending 'Donation' to the Association. We are really grateful to Shri.M.K.Bapat / Shri.Pramod Chate for this extra-ordinary service which keeps all the members cheerful throughout the year.

d) Library :- The Libraries have been started at Pune & Thane office premises which are running successfully. At Pune, many books in Marathi/English, all donated by our members, are made available for reading at home without charging any subscription/fee to the members. At Thane, for Library an annual subscription of Rs.100/- is being collected from the members and the books are made available

to them at home for reading. In Thane Library, many books are donated by members and few books are being purchased as per the members' choice. The response at both the places is encouraging. **Audit of our Financial Statements as on 31st March 2012 :-**

It is worth mentioning here that it was possible to complete the audit of the Financial Statements as on 31-03-2012 well in time. This was possible because of strenuous efforts taken by Shri.D.A.Kulkarni, Treasurer, with the timely help by Shri.G.N.Joshi and Shri.S.P.Barve to collect the final Financial Statements/necessary papers/certificates from the branches where our accounts are maintained in time from all the ZSCs and getting the same audited from M/s A.R.Sulakhe & Co, Chartered Accountants. The Chartered Accountants have also done the audit well in time. Mrs.Swati Rajurkar is helping us to maintain the financial accounts with the aid of Computer. The Secretaries/ Treasurers of ZSCs SarvaShri.J.B.Pusalkar, J.S.Vakil, I.H.Dias & N.K.Joshi deserve complements for their co-operation in the matter.

#### **Reports from Zonal Sub-Centres : -**

#### 1) Aurangabad Zonal Sub-Centre : -

As reported in the past, the retirees from the branches under Aurangabad Zonal office generally prefer to settle down in Dhule and Jalgaon Districts and few big cities in Marathwada Region. The membership of the sub-centre is also spread all over Marathwada region covering 8 Districts viz. Aurangabad, Jalna, Beed, Latur, Parbhani, Nanded, Hingoli & Osmanabad Districts & 3 Districts of Khandesh i.e. Jalgaon, Dhule, & Nandurbar. Under the leadership of Shri. Sahebrao Desai, President, & Shri.N.K.Joshi, Secretary, the special efforts are being made by all the District representatives to enrol old retirees who have been settled in remote villages in Marathwada region. They have enrolled 44 new members during the year and collected Rs.63351/- including subscription fees of Rs.44000/ - and aggregate Donations of Rs. 19351/- for various purposes. Zonal Sub-Centre launched a special membership drive to enroll old retirees as members who up till now could not be contacted and enrolled as members of the Association for mobilizing membership. Shri.M.T.Deshpande, Nanded & Shri.S.P.Dixit, Dhule have taken special efforts. The District representatives are arranging get-togethers and functions like Tilgul / Haldi Kumkum and entertainment programmes as usual. Recently, in Aurangabad, the local unit is organizing 'Bhishi' of local members in order to enable them to have regular contacts with each other. This has helped in improvement in attendance & also to have get together meetings along with Associate members at the residences of individual members.

During the year, Aurangabad unit arranged two trips for members i.e. a) Trip to Patnadevi near Chalisgaon (Jalgaon District) was arranged on 4th December 2011. Total 45 members including Associate members took part. At Patnadevi, a quiz contest was arranged for gents & ladies separately & winners were given small gifts. During this trip places like Verul (Ghrishneshwar) temple, Bhadra Maruti temple etc. were visited. b) While going to Satara for attending our Circle Annual General Meeting, a trip was arranged to Siddhtek, Jejuri, Narayanpur, Ket-kawale, Kolhapur, Narsoba-wadi etc. The Unit has also arranged Hurda-party, Haldi Kumkum, Kojagiri Pournima etc.

**Nanded Unit :-** The local active members are publishing a four page quarterly 'News Letter' named "Vartalap", wherein they are giving the latest developments on Association front and the local news about the activities undertaken by Nanded unit. They are distributing the sufficient xerox copies of the news letter to all the members residing in Nanded District. This is really worth emulating idea of publishing quarterly bulletin for the benefit of local members. We wish them a grand success. Recently the active members and their family members have also undertaken social work and participated in 'Swatchhata Abhiyan' organized by Nanded Municipal Corporation. Detailed report is given in 'Samvad' for April 2012.

#### 2) Mumbai Zonal Sub-Centre : -

Mumbai Zonal Sub-Centre is always on the forefront of the Association activities. Under the leadership of Shri.S.B.Gokhale, President and Shri.R.S.Rajiwadekar, Organizing Secretary, with the help of all the other office-bearers and active committee members, the sub-centre has shown exemplary growth in membership by enrolling 220 new members. A total sum of Rs.5,24,347/- has been collected, of which Rs.2,15,690/- by way of membership fees and Rs.3,08,657/- as donations for various purposes as follows - Legal Fund - Rs.99,432/-; Distressed Relief Fund - Rs.10,000/-; Misc. Donations - Rs.1,70,124/-; for Samvad - Rs.1,001/- & Advertisements worth Rs.28,100/-. We are happy to note here that Mumbai ZSC has collected highest Legal Fund this year which has helped the Association to contribute promptly to the Federation for fighting legal battle in the Supreme Court. All out efforts are always being made by the committee members to increase the membership. Pensioners meetings were arranged at Dombivali (E), J.P.Road, (Andheri), Naupada (Thane), Dahisar and Varsova branches during the year which were attended and addressed by sub-center's office bearers.

Mumbai Sub-Centre's 25th Annual General Meeting was held at Shivaji Mandir, Dadar on 21st March 2012 which was attended by more than 950 members. The Bank's Pensioners' Meet was also arranged during the day which was attended by Shri.N.S.Kujur, CGM (HR) at Corporate Centre, Shri.O.P.Punia, Dy.GM & CDO at Mumbai LHO, Dr. (Smt) V.M.Ajinkya, Chief Medical Officer at Corporate Centre, Dr.(Smt) Manjusha Padhye, Medical Officer at Mumbai LHO and Smt.Madhuri Sathe, Welfare Officer, Mumbai LHO.

Mumbai Zonal Sub-Centre is now functioning from its own office premises at Thane for which they have collected donations from members for more than 50 % of the cost of the Flat (i.e. more than Rs.8.50 lacs). This is a commendable achievement, indeed !

'Thane-Mulund Sanskritik Mandal' is arranging, every alternate month, entertainment programmes such as lectures of eminent personalities on various subjects, sharing experiences by our members while doing social work etc. for the benefit of local members. Mumbai ZSC have also organized Medical Check-up camp during the year. 'Andheri Club' is functioning since past many years and is organizing various cultural activities including publication of 'Deepavali-Annual' named 'Sneh-Deep' wherein literary contributions of local members are being published.

At Dahisar the local members have formed a club named "SBI Pensioners' Organization Club" under the leadership of Shri. Hemant Nabar on 30-10-2010 and are organizing social and cultural activities for the benefit of local members. Club has also published the Diwali magazine.

Library at Thane :- A library is run in Thane office premises by local members for which few books have been collected from the members as donation. They are collecting Rs.100/- from each member as subscription and are purchasing new books. Shri.Sharad Gadkari, past Secretary of the Mandal, donated steel cupboards for keeping library books. Many local members are taking advantage of this library. Shri.V.M.Kanhere from Thane is managing the Library activities very efficiently with the help of local committee members.

### 3) Nagpur Zonal Sub-Centre :-

The Nagpur Unit has progressed by leap and bounds and achieved greater heights by registering 166 New Members (of which 70 are from Nagpur City alone)during the year. The total

membership registered so far now stands at a respectable figure of 3745. This glorious achievement was possible due to the strenuous efforts put by all the Committee members in general and Sarvashri S.G.Desai, J.S.Vakil, Mohansingh Munot, Nilkanth Nagraj, D.B.Khobragade, Avinash Nimdeo, Gopal Gadge, Uday Deshpande, Awadhut Rotkar in particular.

The unit had organized few welfare programs during the year which were largely attended and appreciated by the members. Some of the prominent programs were (i) A lecture of an eminent Cardiologist Dr. Mahesh Fulwani from"Shrikrishna Hrudayalaya "Nagpur an approved Multi Specialty Hospital by the Bank; (ii) Informative lecture of Shri Arvind M Doye Chief Manager, P&HR Zonal Office Nagpur on New SBI REMB Scheme III followed by questions and answers; (iii) An informative lecture of Shri P.P.S.Murthy, General Secretary of Our Federation on various developments on our federation front including various pending court cases; (iv) A forum was created of the SBI Pensioners who retired under the Exit option Scheme of the Bank and engaged the services of Shri Sunil Money, eminent Chartered Accountant, to fight the demand raised by Income Tax Department by denying the benefit of Income Tax on Rs.5,00,000/- under section 2/B/A of Income Tax Act.

With the establishment of good rapport with the Serving unions (Both Award & Supervising) and personal initiative of the Chief Manager P&HR, Zonal office Nagpur, Seven Multispeciality Hospitals and three Diagnostic Centres (the list will be published in next issue of Samvad) were approved for cashless treatment of the SBI Pensioners who are members of the SBIREMB Scheme.

To reduce the workload of Nagpur Zonal Sub-centre, a new unit named 'SBI Pensioners Association Nagpur Unit', covering five Districts of Nagpur, Bhandara, Gondia, Chandrapur and Gadchiroli, was formed and became operational on 27th May 2012.

Akola Unit : Our Akola unit is progressing very fast under the dynamic leadership of Shri Nilkanth Nagraj who is heading the unit since last 16 years. With the vast knowledge & experience he is serving the needy members from time to time. He also conducts the meeting of the pensioners at regular intervals to update the pensioner members of the latest developments on our Association / Federation front.

Amravati Unit : Our Amravati Unit is achieving new heights under the able leadership of Shri Avinash Nimdeo, President and Shri Dyanprakash B. Khobragade. They are maintaining very good rapport with all the pensioner members. They had organized an annual meet of all the members of Amravati District and a recreation program was arranged followed by dinner which was largely attended and appreciated by the members.

Buldana, Wardha, and Yavatmal Units : All these District units are functioning very well under the leadership of Shri.Mohansingh Munot / Y.D.Gupta (Buldana), Shri Awadhut Rotkar (Wardha), & Shri.Gopal Gadge / Uday Deshpande (Yavatmal). They are conducting regular meetings and guide the members from time to time. Annual gatherings are also arranged at these centers wherein the local SBI functionaries are taking active part.

#### 4) Panaji (Goa) Zonal Sub-Centre : -

We are glad to note that the Panaji Zonal Sub-Centre is progressing very well under the dynamic leadership of Shri.P.M.Narkar, President. It is also noted with great satisfaction that with the active support of ShriV.D.Kulkarni, Vice President and Shri.I.H Dias, Secretary, the regular meetings are being held at Panaji and Margao and occasional meetings at Ratnagiri, Sawantwadi and Kudal. In all 12 managing committee meetings were organized during the year. The Zonal Sub-Centre has enrolled 31 new members during the year. They have collected Rs.76,966/- which includes total subscriptions of Rs.27,500/-, Donations of Rs.44,966/- for Legal Fund and Rs.4,500/- for 'Samvad' during the year.

14th Annual General Meeting of the Zonal Sub-Centre was held on 15th April 2012, which was attended by about 180 pensioners / family pensioners from Goa as also from nearby area in Ratnagiri and Sindhudurg Districts. The members have also donated generously for 'Samvad' and expressed their happiness for getting first hand information about recent developments with regard to pending issues.

As informed earlier, our Circle Association has purchased premises at Panaji admeasuring 101.03 sq meters comprising three bedrooms, a hall, a kitchen and two toilet blocks. The premises are being used as our Association's office-cum-Holiday Home. During the year ended on 31.03.2012 total 55 persons occupied the rooms and we have collected Rs.49,650/- as room-rent. The total recurring expenditure of Rs.10,451/- was incurred as under:-

Taking into account the above income from room rent and recurring expenditure during the year first year, it can be said that the investments made by the Association for establishing office-cum-Holiday Home at Panaji will be beneficial in the long run.

There is an excellent rapport of office bearers of the Zonal Sub-Centre with the Zonal Office functionaries, especially with the DGM (Zonal Office) and Chief Medical Officer of the module. This helped in getting many problems of the pensioners solved without difficulty. This is worth noting.

The President Shri.P.M.Narkar, with his constant personal follow up with HRD Dept at Corporate Centre and at LHO, solved the following cases of the members declared impossible to settle with success.

- (a) Smt.Laxmibai Parab, widow of watchman at Calangute branch, who died while in service, was denied Gratuity in lieu of compassionate appointment. She got sanction of Gratuity of Rs.4.16 lacs recently and she gave donation of Rs.3,000/- to the Association.
- (b) Family pension of PVG Kutty, who retired in 1993, was got sanctioned with constant follow-up of Shri.Narkar.
- (c) Shri.Raymond D'Mellow, who was denied membership to REMBS-II Scheme on technical grounds, was accommodated after due reasoning.

## 5) Pune Zonal Sub-Centre : -

The Zonal Sub-Centre has enrolled 199 new members and has collected total amount of Rs.3,49,076/- which includes Subscriptions of Rs.1,89,500/- and Donations of Rs.1,89,576/- including Rs.1,23,576/- for Legal Fund during the year. Under the leadership of Shri.L.G.Gandhi, President, Shri.C.P.Kulkarni, Secretary and unit's Jt.Secretary Shri.A.S.Pandit and other District representatives, the sub-centre has showed very good progress in organizational activities. The Zonal Sub-Centre has maintained liaison with Pune Zonal Office and LHO. During the year, new dispensaries have been started at Satara, Paud Road (Pune) and at Nashik.. The Zonal Sub-Centre has now three dispensaries established at Pune and one such at Solapur, Satara, Nashik and Kolhapur. Besides this, the local members are undertaking following activities like running a Library at Pune office (by SarvaShri.Ashok Wakchaure, Arvind Kale and Subhash Belsare), preparing & sending Birthday Greetings to about 17000 members by one of the active members Shri.Pramod Chate (earlier this work was being done by Shri.M.K.Bapat), helping the Doctors in the dispensaries established at Kolhapur, Satara, Paud Road (Pune) as no pharmacists have been posted by the Bank. The active workers at all the district places helped the Association for conducting many activities. A few activities undertaken by the District representatives are as under.

Ahmednagar: - Regular monthly meetings are being arranged as also good rapport has been maintained with the local Branch Managers to redress the grievances of the members.

Kolhapur: - Activities like celebration of seasonal festivals, participation in local social activities, short duration trips to sight seeing places, organizing health check up camps/lectures of learned personalities have become the routine.

Nashik : - The unit organizes Annual Meet/family gathering of local members and arrange lectures by eminent personalities.

Satara : - The unit members meet regularly once in a month besides Annual Meeting. The guest lectures by eminent personalities are also arranged.

Sangli : - The unit conducts regular meetings through out the year and discuss important issues affecting pensioners and seek information/guidance from the Circle authorities.

Solapur : - The unit participates in local cultural activities & arrange guest lectures of eminent writers/ experts from literary fields/medical line etc.

Pune: - Being the HQs of the Association, it becomes the responsibility of the local Committee members to look after the Association's office and maintain the books of accounts as also keep the membership record up to date. This is being done on a regular basis by S/Shri.D.A.Kulkarni, Treasurer, R.N.Lalingkar, Circle Secretary, M.M.Sirdeshmukh, Circle Jt.Secretary, S.P.Barve, Pramod Chate, Avinash Deshpande, G.N.Joshi and P.B.Kulkarni.

### **On Federation Front : -**

The Governing Body and General Body meetings of the Federations were held on the following dates.

- A) Governing Body Meetings on 2-04-2011 at Kochi; on 30-09-2011 at Chandigarh and on 29-03-2012 at Ahmedabad
- B) General Body Meetings on 3-04-2011 at Kochi & on 30-03-2012 at Ahmedabad

As stated in the last year's report, our Federation filed a Writ Petition in the Supreme Court on 16-03-2011. The Writ Petition (No.184 of 2011) was admitted on 13-05-2011. Respondents were ordered to submit their replies. Our Bank submitted its Counter Affidavit on 29-11-2011 to which our Federation filed a Rejoinder Affidavit on 11-01-2012. However, Government of India (GOI) did not file their reply even up to 12-03-2012. GOI's Senior Counsel requested the Court to grant some more time to file the counter affidavit. Accordingly, GOI was granted time of further four months. However, in the order dated 12-03-2012 passed by the Supreme Court it has also been stated as under :

" In the affidavit to be filed on behalf of the Union of India by a senior officer, it will be explained as to why in the first instance, the Union of India did not respond to the notice stated to have been served on them on 1st September 2011." Four weeks time has also been granted to Federation for filing a Rejoinder Affidavit after receipt of GOI's reply.

The next date of hearing is listed on 2-07-2012, i.e. the first day of opening of the Supreme Court after summer vacation beginning from 13-05-2012.

Latest news is that now in April 2012 GOI filed their reply to which our Federation filed reply on 4-05-2012.

Information about our 'prayer' etc. has been stated in the last year's Report (Samvad - June 2011)

There is no progress about the High Court cases filed in Bangalore and Nagpur.

During the year under report no Structured Meeting was held with the top Management Officials of the Bank.

#### Acknowledgements : -

Sub: CENTRALISED STAFF PENSION PROCESSING CELL (CSPPC) SHIFTING FROM HRMS TO CSPPC

We have been bringing to your kind notice the various problems being faced by pensioners and family pensioners living in various parts of our Country in the services provided to them through the HRMS. Some of the recurring problems faced by a large number of pensioners are :

- (i) Non-payment of pension even to those who have acknowledgements of their Life Certificates issued by the Branches.
- (ii) Delay in payment of family pension after the demise of the pensioners.
- (iii) Difficulties in accessing the HRMS site both by the Beanch Officials and Pensioners and deduction of TDS without prior intimation to those pensioners and without taking into account the investment details.
- (iv) Lack of adequate machinery for rectification of mistakes committed in the computation / payment of pension / wrong or excess deduction of TDS; and
- (v) Difficulties in reconciling the discrepancy in the PAN Card details recorded in the HRMS site with NSDL site and consequent problems in obtaining refund of the excess TDS from the I. T. Department.

2. We understand that with a view to improving the pension payment system, a CSPPC has been set up at Central Accounts Office, Kolkata for processing and payment of staff pension. Accordingly, pension is being paid from CSPPC from the month of May 2012 onwards. We have received representation from our Affiliates on non-payment of pension for the month of May, 2012 to a large number of pensioners as the Life Certificates given by them to the various Beanches have not been uploaded. No clarification or support from the Officials of the PPG / HRMS Departments of LHOs could be obtained. While we are aware that any new system evolved and implemented for computation and payment of pension will face some teething problems, we wish to bring to your kind notice that the pensioners experience considerable difficulties in sorting out these problems, as there is no staff

designated at the Branches for attending to Pension matters. The skeleton staff at PPG / HRMS Department of LHOs, who themselves are not conversant with the revised system now introduced are not in a position to address the problems faced by the pensioners brought to their notice. The aggrieved pensioners, therefore, look only to our Affiliates in attending to their problems being faced by them. Without adequate support from our Bank, it would not also be possible for the Circle Pensioners' Associations to serve our members and help the Bank in providing its various services to its pensioners and family pensioners. For this purpose, some of the office bearers of the Circle Pensioners' Associations need to get acquainted with the details of the procedure now introduced in the payment of staff pension through CSPPC, CAO, Kolkata and for accessing the web site being made now available to the pensioners. We, therefore, request you to arrange to conduct a workshop for one or two days for some of our representatives for enabling them to get equipped with the revised procedure as early as possible at a venue and dates convenient to you under advice to us.

3. We shall on our part, assure you of our cooperation and support in putting in place a system which will ensure correct computation and payment of pension promptly complying with the requirements of the Income Tax Department. We shall be glad to have your early reply.
