# संपादकीय

प्रिय सभासदबंधूंनो,

आजकाल 'व्यक्तिमत्त्व विकास' (Personality Development) ह्या विषयावर वर्तमानपत्रांतून विविध लेख व जाहिराती प्रसिद्ध होत असतात. हा विषय सर्वांच्याच जिव्हाळ्याचा आहे ह्यात शंका नाही. 'व्यक्तिमत्त्व विकास' म्हणजे आपल्या स्वतःमधील प्रत्येक सुप्त व उपयुक्त गुणांचा अभ्यास-मनन-चिंतन-अनुभव यांच्या साह्याने विकास वा वाढ करणे. यामुळेच आपण समाजातील लोकांवर आपल्या प्रभावी व्यक्तिमत्त्वाने छाप पाडू शकतो. त्यामुळे व्यक्तिमत्त्व विकासाचे महत्त्व दिवसेंदिवस वाढतच जाणार आहे.

वास्तविक व्यक्तिमत्त्व विकास हा आपल्या ज्येष्ठांचा प्रदीर्घ अनुभवाचाच भाग आहे. स्वामी विवेकानंदांनी आपल्या अनेक भाषणांतून त्यावर मार्मिक व अभ्यासपूर्ण भाष्य केलेले आहे. आधुनिक संशोधकांनी व अभ्यासकांनी ह्या विषयाची मांडणी वेगळ्या पद्धतीने केलेली आहे इतकेच. तेव्हा हाच मार्ग जीवनाच्या शेवटच्या क्षणापर्यंत चालू ठेवून स्वतःच पूर्णत्व प्राप्त करणे हेच आपणा ज्येष्ठांच्या जीवनाचे ध्येय असले पाहिजे. आपल्या शारीरिक, मानसिक व आध्यात्मिक प्रगतीसाठी सर्व प्रकारचे ज्ञान शक्य असेल तेवढे संपादन करून ते प्रत्यक्ष आचरणात आणण्याचा प्रयत्न करणे आणि जीवनात पूर्ण यश, आनंद आणि शांती मिळविणे ह्यातच जीवनाची सार्थकता आहे.

श्रीरामकृष्ण परमहंसांचे शिष्य स्वामी विज्ञानांवजी म्हणतात, ''सूर्य उगवला असे कोणी कोणाला सांगायची आवश्यकता नसते. स्वतःच्याच प्रकाशाने सूर्य स्वतःला प्रकट करतो.'' त्याचप्रमाणे 'आपल्यात सुद्धा तो सूर्य आहे' ही भावना व हा विश्वास बाळगा. आपल्याला स्वतःमधील 'मी'चा जेव्हा शोध लागतो तेव्हा त्याचे खरे ज्ञान होते. (अहं ब्रह्माऽस्मि) हे ज्ञान म्हणजेच इंद्रियांचा प्रकाश, बुद्धीचा प्रकाश आणि

आत्मज्ञानाचा प्रकाश होय.

योग्य व्यायाम आणि आहार घेऊन शरीरसौष्ठव उत्तम ठेवणे हाच आपल्या इंद्रियांचा प्रकाश होय; माणसाला वरदान म्हणून लाभलेल्या बुद्धी, कल्पनाशक्ती अन् विचारशक्ती यांचा उपयोग करून योग्य झान मिळविणे हा आपल्या बुद्धीचा प्रकाश होय आणि शुद्धबुद्धी राहण्यासाठी प्रझा नावाचे आपल्यामध्ये इंद्रिय वा शक्ती आहेच. ही प्रझा म्हणजेच बुद्धीची बुद्धी होय. प्रझा हीच आपल्याला आत्मझानाचा प्रकाश दाखवीत असते. हा आत्मझानाचा प्रकाश फारच दुर्मिळ असून तो अगदी मोजक्याच व्यक्तींना प्राप्त होतो. असे प्रझावंत प्राचीन ऋषिमुनी किंवा झानेश्वर-तुकाराम-विवेकानंद यांच्यासारखे अपवादानेच निर्माण होतात. म्हणूनच या विशेष प्रझावंतांचे-द्रष्ट्यांचे विचार शतकान्शतके समाजाला मार्गदर्शन करतात.

ज्येष्ठहो, व्यक्तिमत्त्व विकासाची म्हणजेच आपल्या यशस्वी जीवनाची ही महत्त्वाची तत्त्वे पूर्णतः आचरणात आणण्यासाठी सतत प्रयत्नशील राहा. सूर्यासारखे स्वयंप्रकाशी व्हा; विचार बदला; त्यानुसार आचार बदला. शेवटी लक्षात घ्या की जीवन हा एक संग्राम आहे; ही लढाई आहे. हा संग्राम ही लढाई आपण जिंकायलाच हवी. ती जिंकणे आपल्याच हातात आहे. त्यासाठी लढावयाची मात्र आपली सिद्धता आणि जिंकण्याची जिद्द हवी.

रामकृष्ण परमहंसांच्या भाषेत सांगायचे तर "पुढे चला. वाटेत चंदनाचे वृक्ष दिसतील, त्यापुढे चांदी-सोन्याच्या खाणी लागतील आणि त्यापुढे प्रत्यक्ष परमेश्वरच तुमची वाट पाहात असेल." त्या परमेश्वराचे साक्षात दर्शन आपणास घडावे आणि आपले जीवन सुफळ-संपूर्ण होऊन ते सार्थकी लागल्याचे समाधान आपणास लाभावे ही परमेश्वरापाशी प्रार्थना!

#### Report of the Managing Committee for the Year 2014-2015

Dear Members.

**1.** On behalf of the Managing Committee I am glad to place before you the Annual Report of the Association for the year ended 31st March 2015.

#### 2. Membership:-

The Managing Committee is very much thankful to those Office Bearers who have put in sincere efforts to enroll 1327 new members during the year. At present our total membership as on 31-03-2015 is 12,317 excluding Associate members and with Associate members it is 20,751. In addition to this, there are 102 members from other States. As on 31.03.2015 the percentage of our membership to total pensioners is 61%. As being always advised by our President, more efforts need to be made to achieve the target of at least 75% membership. While taking review of efforts made for enrolling new members during the year, it is



pertinent to mention that Shri.R.S.Rajiwadekar, Principal Secretary of our Mumbai Zonal Sub-Centre, is securing branch-wise lists of staff members who are going to retire within a period of next 6 months, from PPG Department. These lists are helping the ZSCs to enroll new members. All such efforts made by all the Zonal Sub-Centres resulted in enrolling maximum number of retirees as our members. We have been requesting all the ZSCs, that the Benefactor/Life members be upgraded to Patron membership by paying the difference in membership fees. In this direction our Mumbai ZSC is making concerted efforts which other Zonal Sub Centres should emulate. We also appeal to each member of the Association to enroll at least one new member and help us to achieve the target of 75% (to total pensioners) as is being stressed by our President Shri.S. B. Gokhale.

#### 3) Resources:

Following are the resources for the Association and it is our constant endeavour to meet the expenses from these resources.

- (a) Admission fee;
- Interest earned on Deposits; (b)
- (c) Donations received from the members;
- (d) Dividend on investments in Shares of SBI.

Membership subscriptions are retained as 'Trust Fund' and are being invested mainly in Govt. Bonds/Bank Deposits etc. On Liabilities side, it will be observed that our 'corpus' has increased by Rs.13,10,500/- taking the amount of Trust Fund to Rs.2,12,32,433/-. Under "Legal Fund" Rs.14,761/- has been received during the current year. There are additions of Rs.50,063/- to the Distress Relief Fund. Members are requested to contribute generously towards Distress Relief Fund. Members are also requested to contribute towards Legal Fund to enable us to make our Association / Federation financially self-sufficient to meet the legal expenses for getting our legitimate demands accepted through courts.

The expenses for 'Meetings', 'Printing & Stationery, 'Travelling', etc. are gradually increasing due to inflationary trends and increase in membership. Similarly the expenses for 'Samvad' are increasing due to increase in overall expenses and number of copies, obviously due to increase in membership. For this reason we have been making appeals to all our members through 'Samvad' to donate at least Rs.1000/-. We have been getting good response for this. As a result of this, our Donations received only for 'Samvad' during the current year are Rs.7,77,966/-. We are continuing this drive for some more time. As regards 'Postages', we are getting a concession in postal tariff for mailing our house magazine 'Samvad' at concessional rate of 25 paise per copy (upto 13000 copies), if the weight per copy is upto 50 grammes and if, the weight per copy exceeds 50 grammes, then we will have to pay postages @ Rs.2/- per copy as per extant Post Office rules. In view of this, the pages of 'Samvad' are confined to 24 only to keep the postages to a minimum level. Now total dispatches per month are around 12,300 copies and this figure is increasing every month due to increase in membership. The renewal of this license to post without pre-payment (WPP) has been done for the period 1st January 2014 to 31st December 2016.

The Association has received interest on Bank Deposits (T.D.R. and S.B. Accounts) to the tune of Rs.19,99,453/-. We have not taken into account interest accrued but not received up to 31st March 2015 due to change in the accounting procedure. Dividend from other investments amounts to Rs.8,130/-, while



Rs.13,270/- were received by way of Admission fees. The members have given aggregate Donations of Rs.13,79,704/- during the year for various reasons. The receipts under Advertisements for 'Samvad' are Rs.1,10,000/-. The lists of 'Donors' have already been printed in the past issues of 'Samvad'. You will now observe that our financial position is getting improved and the members will appreciate this. It is worth noting that we have purchased Holiday Home at Panaji during the month of January 2010 which is also being used as office premises. The premises have been well furnished and are being occupied by our members during the season. During the year the receipts were Rs.83,250/- and expenses were Rs.11,913/ -. It is worth mentioning that Office-Bearers of our Panaji ZSC viz.SarvashriP.M.Narkar, I.H.Dias and K.V.Gopinathan are making every effort to see that the suggestions of the occupants of the Holiday Home are taken care of and are being implemented to improve the staying arrangements to the satisfaction of the occupants/members. Further, with a view to increase the occupancy at our requests, some of the other Circle Associations have published appeals in their house magazines about the 'Holiday Home'.

#### 4) Donations:

We have been receiving donations under following heads and the figures are mentioned against these heads.

The "Distress Relief Fund" is used for providing relief to affected families of our members as also to contribute to various Relief Funds raised by State/Central Governments/N.G.Os to help the needy persons when there is a national level and/or natural calamity. As on 31st March 2015 the 'Distress Relief fund' and 'Legal Fund' show balances of Rs.1,35,309/- and Rs.10,94,710/- respectively. In the current year we have remitted Rs.2,50,150/- from the 'Legal Fund' to our Federation. This amount is used for meeting the expenses related to our case number 1875 of 2013 in Delhi High Court as well as cases in Nagpur & Bangalore High Courts.

We take this opportunity to appeal to all the members to donate generously for these funds.

#### 5) Meetings of the Managing Committee:

In all 4 Managing Committee Meetings were held during the year, of which two were held at Pune office and two were held at Thane office. Apart from administrative work and financial matters, various issues were discussed, viz. our court cases, the membership drive, problems faced by the members in general, organizational matters such as pensioners' meetings, contacting non-members, organizing Health camps, arranging informative lectures, taking review of working of Bank's dispensaries, appreciation of members doing good work, etc. The representatives of each Zonal Sub-Centre actively participated in the discussions.

#### 6) Annual General Meeting:

The Annual General Meeting of the Circle Association was held on 27th August 2014 at Harshal Hall, 153 Karve Road, Near Karishma Society, Pune, 411029. Around 900 members attended the Meeting. Shri.J. S. Vakil of Nagpur, was awarded "Late Shri.L.N. Pabalkar Memorial Gold Medal" for the year 2013-2014 for



his invaluable contribution towards the members of the Association. From this year onwards, the conferring of "Late Shri VasudeoVithal Gandhe and Smt. UmabaiVasudeo Gandhe Award" also commenced. These awards were conferred on Shri M.T.Deshpande of Nanded and Vice President of Aurangabad ZSC and Shri S. B. Satwe of Nashik for their valuable and highly dedicated services to the members of the Association. Besides, usual agenda items, the free and frank deliberations were held during the day on the various issues concerning the membership at large. The detailed minutes of the AGM as well as the Pensioners' Meet conducted by the Bank have been published in 'Samvad' for December 2014.

#### 7) Structured Meeting with the Management:

Despite our requests no structured meeting of the Circle Association with the Mumbai LHO functionaries was held during the year 2014-2015 to discuss various issues of our members. This has been brought to the notice of our Federation.

#### 8) Special Activities :-

#### A) House Magazine 'Samvad' :-

- i) We are publishing our house magazine 'Samvad' on monthly basis and sending it to all the members by post. The magazine is so popular that some of the pensioners from states like Karnataka, Madhya Pradesh, Delhi, etc. have also become subscribers. We are also sending 'Samvad' to all the Office-Bearers and Governing Body members of our Federation and all the Circle Associations and Office-Bearers of serving staff Federations. We are also sending our 'SAMVAD' to all the senior executives of our Bank such as Chairman, M.Ds, Dy.M.Ds, CGMs/CDOs etc. at Corporate Centre and at Mumbai LHO for their information. Our 'SAMVAD' is well accepted by Bank's functionaries and other Circle Associations' Office-Bearers as well. The Editorial Committee comprising of Sarvashri Prabhakar Gupchup, Vasant Dhupkar, Krantisen Athavale & Sharad Shingvekar, is managing the work of editing and publishing the Marathi section of 'Samvad' every month for which they deserve compliments. The Editorial Committee is also arranging a 'Writing Competition' for members and prizes are being awarded at the hands of our President during the Annual General Meeting. 'Samvad' contains latest news on Federation/Association front, reports on organizational and cultural activities undertaken by our Zonal Sub-Centres and District units, literary works of our members like thought-provoking articles on special subjects/occasions, narration of self-experiences while in service, small stories, poems, jokes and cartoons etc. In the current year our Adviser Shri B.G.Dandekar has contributed three articles on the subject "Three Decades of Federation" by giving even minute particulars. These articles were appreciated by not only our members but also by pensioners from other Circles and a good number of Office Bearers of other Circle Associations. ShriAvinash Deshpande looks after the dispatch of 'Samvad', recording membership records including change of addresses of the members/recording death of members and attending to all the complaints relating to non-receipt of 'Samvad' etc. All the issues of 'SAMVAD' published since January 2007 till last month are also made available on our Association's website for information and future reference of our members.
- ii) SBI Pensioners' Portal: Our Bank has launched "SBI Pensioners' Portal" w. e. f. 2<sup>nd</sup> February, 2015 for the benefit and use of pensioners. The website is https://www.sbi.co.in/pension/user.htm The important aspect is all the e-Circulars related to pension matters and of Pensioners' interest are provided by the Bank. The information about this was published in Samvad' for February 2014.

- B) Association's Website: We launched our website in 2007 containing useful information for members. We have made improvements from time to time in the web-site "www.sbipensionerspune.org" which contains new 'links' such as 'Samvad Magazine', 'Latest News', 'Financial Statements', 'Photo Gallery', Bank's/ Federation's Circulars', 'DA Rates' etc. We are getting very good response from the members, especially from those who go abroad for certain period. It is observed that the number of 'Hits' are increasing day by day. Now it has crossed 11,58,929 mark and there is encouraging feedback from our pensionermembers and also from other Circle Associations.
- C) Association's E-mail: We are also having our Association's e-mail account sbipenmumbai@gmail.com which is always printed at the bottom of first page of 'Samvad'. Our members as also members of other Circle Associations are using it for raising their problems, advising change in residential addresses etc. Members' queries are always replied promptly which is also appreciated by them.
- D) <u>Birthday Greetings</u>: We are getting appreciation letters from members on receipt of 'Birthday Greeting Card' promptly sent by our devoted member Shri.Pramod Chate. The work was being handled earlier by Shri.M.K.Bapat of Pune for about 11 years. Shri Pramod Chate is looking after this work voluntarily for the past four years. Very often we get letters from our members who express their sincere appreciation for this good gesture. Many reciprocate this by sending 'Donations' to the Association. We are really grateful to Shri.Chate for this extra-ordinary service to the members which keeps all the members cheerful throughout the year. This work-load is also increasing day by day and at present the number of Birthday Greetings sent every month is around 1600.
- E) <u>Library at Pune and Thane</u>: Sarvashri Subhash Belsare and Ashok Wakchaure members from Pune, are managing the Library at Association's Pune Office. We also have a Library at our Thane Office and the same is taken care of by Shri V.M. Kanhere.
- F) Appreciation of Association Work: We are glad to inform that our Association was awarded "Adarsha Seva Sangh Puraskar" for 2014 by the "Pune Shahar Nivrutta Sevak Mahasangh, Pune" (i.e. - Federation of Retired Employees' Associations of Pune City) for doing excellent work for the Pensioners. This award which contains a Memento and a Certificate was distributed on Pensioners' Day i.e. on 17.12.2014 at the hands of Shri Bhai Vaidya, President of the above Federation (Pune) and a renowned personality in Union activities.

#### 9) Audit of our Financial Statements as on 31st March 2014 :-

It is worth mentioning here that it was possible to complete the audit of the Financial Statements as on 31-03-2015 well in time. This was possible because of strenuous efforts taken by Shri.D.A.Kulkarni, Treasurer, for collecting the Receipts and Payments Statements from all the ZSCs, other necessary papers/certificates /particulars, in time from the branches where our accounts are maintained and getting the same audited from M/s A.R.Sulakhe & Co. Chartered Accountants. The Chartered Accountants have also done the audit in time. Mrs. Swati Rajurkar is helping us to maintain the financial accounts with the aid of Computer programme. The Secretaries of all the ZSCs viz. Shri. Subhash Agarkar (Mumbai), Shri. V. R. Kulkarni (Pune), Shri.SudhirAgrekar (Nagpur), Shri.I.H.Dias (Panaji-Goa), Shri.N.K.Joshi (Aurangabad) & Shri.Dnyanprakash Khobragade (Amravati) deserve complements for their co-operation in the matter.



I) Aurangabad Zonal Sub-Centre: - The membership of the sub-centre is spread all over Khandesh and Marathwada regions covering total 11 Districts. Under the leadership of Shri.Sahebrao Desai, President and Shri.N.K.Joshi, Secretary, the special efforts are being made by all the District representatives to enroll new as well as old retirees, particularly those settled in remote villages of Marathwada region after retirement. Shri.M.T.Deshpande, (Vice President of ZSC) from Nanded and Shri.S.P.Dixit, (District Representative from Dhule) have taken special efforts for enrollment of members. During the year, they have enrolled 159 new members and collected Rs.1,52,500/- as subscription fees and aggregate Donations of Rs.32,021/- of which for 'Samvad' are Rs.32010/-. The District representatives are arranging get-to-gethers and functions like Tilgul / Haldi Kumkum, picnics, Bhishi and entertainment programmes. This has helped in improving the attendance and also to have get-to-gether meetings along with Associate Members at the residences of individual members. The AGM of the sub centre was held on 17.07.2014 in Aurangabad.

Nanded Unit: - The local active members are publishing a four page quarterly News Letter named "Vartalap" for the district members, wherein they are giving the latest developments on Association front and also the local news about the activities undertaken by the unit. We wish them a grand success.

Jalgaon Unit: The annual 'Sneha-Melawa' of pensioners was held on 11.01.2015 at Jalgaon during which the unit collected Rs.30,000/- donations for 'Samvad' due to the lead taken by Shri V. R. Baviskar, Member of Circle Managing Committee. For this, we appreciate the efforts taken by him and the other office bearers of Jalgaon Unit.

#### II) Amravati Zonal Sub-Centre :-

Amravati Zonal Sub-Centre was established after creation of separate Amravati Zonal Office for administrative purpose by the Bank. The Amravati ZSC started functioning w.e.f. 4th August 2013. The first Annual General Meeting was held on 14th March 2014 and the following are the elected Office Bearers.

They have enrolled 130 new members in the current year. They have collected Rs.1,30,000/- as subscriptions and Donations worth Rs.45,283/-, of which for 'Samvad' are Rs.33,011/- & Rs.12,272/- are under Miscellaneous. For this progress, the efforts taken by all the Office Bearers are appreciated.

Akola Unit: Our Akola unit is progressing very well under the leadership of Shri Nilkanth Nagraj who is heading the unit since last 19 years. With the vast knowledge & experience he is serving the needy members from time to time. He also conducts the meetings of the pensioners at regular intervals to update the pensioner members of the latest developments on our Association/Federation front.

Amravati Unit: Our Amravati Unit is achieving new heights under the able leadership of Shri Avinash Nimdeo, President and Shri Dyanprakash B. Khobragade, Secretary. They are maintaining very good rapport with all the pensioner members. They had organized an annual meet of all the members of Amravati District and an entertainment programme was also arranged followed by dinner which was largely attended and appreciated by the members.



Buldana and Yavatmal Units: Both the District units are functioning very well under the leadership of Shri.Mohansingh Munot (Buldana) and Shri.Gopal Gadge (Yavatmal). They are conducting regular meetings and guide the members from time to time. Annual gatherings are also arranged at these centres wherein the local SBI functionaries are taking active part.

#### III) Mumbai Zonal Sub-Centre :-

i) Mumbai Zonal Sub-Centre is always on the forefront of the Association's activities. Under the leadership of Shri.S.B.Gokhale, President and Shri.R.S.Rajiwadekar, Principal Secretary, with the help of all the other Office-Bearers and active Committee Members, the sub-centre has shown exemplary growth in membership by enrolling 522 new members with subscriptions of Rs.5,24,220/-. The aggregate amount of donations collected is Rs.5,55,769/- for various purposes e.g. 'Samvad' - Rs.1,90,722/-, Legal Fund Rs.5,000/-, Misc. Donations - Rs.3,59,797/-, Distress Relief Fund - Rs.250/-. Under advertisements - Rs.79,000/- were received. We highly appreciate the efforts taken by Shri.S.B.Gokhale, President, Mumbai ZSC and his entire team viz. Sarvashri S.M.Dharadhar, R.S.Rajiwadekar, S.W.Agarkar, J. B. Pusalkar, P. A. Lopes, C.N.Date, B.P.Khare, R.V.Chhabria, A.D.Butala, Smt.Jyoti Shahane and Shri.B.C.Thakur from Nashik for enrollment of highest members as well as collection of huge donations. It is nothing but the result of all out efforts always being taken by the Committee Members of Mumbai ZSC. The performance of Mumbai ZSC has always been appreciated in the Circle Managing Committee Meetings.

#### ii) Shakuntaladevi M. Dalal Trust -

Shri M.D. Dalal, retired C.G.M., has donated a sum of Rs.1,11,111/- to our Association in the memory of his beloved wife late Smt.Shakuntaladevi M. Dalal. As per his wish the amount will be invested in TDR and the annual interest accrued on the deposit will be utilized every year to pay to the needy and poor pensioners of our Association for taking care of their serious ailments. The pensioner, family pensioner, spouse of the pensioner who is suffering from serious diseases, viz. cancer including leukemia / stroke leading to paralysis, by-pass surgery, angioplasty, angiography, heart valve replacement surgery, major organ transplant, kidney failure, dialysis, diabetes and its complications (e. g. hyper tension) will be eligible for such assistance. The pensioners may submit their requests to the respective Zonal Sub Centre with the details of disease, its tenure and status of treatment. The sanction will be accorded in the Circle Managing Committee Meeting. The Association is thankful to Shri M. D. Dalal.

- iii) Mumbai Zonal Sub-Centre's 28th Annual General Meeting was held at Shivaji Mandir, Dadar on 25th February 2015 which was attended by more than 900 members. The Bank's Pensioners' Meet was also arranged during the day which was attended by Shri Asit Nandi, AGM, PPG Dept., Corporate Centre; Shri.Chintamani Mulye, Dy.Manager, PPG Dept., CorrporateCentre.; Dr.(Smt)V.M.Ajinkya, Chief Medical Officer, Corporate Centre; Shri.Ganesh Shetty, AGM, PPG Dept., Mumbai L.H.O.; Smt.Pratibha Savant, Manager PPG Dept., Mumbai LHO; Dr. (Smt.) Manjusha Padhye, Medical Officer Mumbai LHO; Shri Manohar Kamat, CM (HR-I), Mumbai Z.O.; Shri.Patkar, C.M.(HR-II); Shri.Krishnamurthi, C.M.(HR-III) at Z.O. Mumbai; Shri Jayant Deshmukh and Smt. Kavita Salunke, both Dy. Managers in Welfare Cell, Z.O., Mumbai.

- **iv)** Mumbai Zonal Sub-Centre is now functioning from its own office premises at Thane for which they have collected donations from members for more than 50 % of the cost of the Flat (i.e. more than Rs.8.50 lacs). Indeed, this isanother commendable achievement by the Mumbai ZSC.
- v) (a) 'Thane-Mulund Sanskritik Mandal' is arranging certain programmes such as lectures of eminent personalities on various subjects, sharing experiences by our members while doing social work etc. for the benefit of local members. (b) 'Andheri Club' is functioning since past many years and has been organizing various cultural activities including publication of 'Deepavali-Annual' named 'Sneh-Deep' wherein literary contributions of local members are being published. (c) At Dombivali the local members have formed "State Bank Pensioners'Mitra Mandal Dombivali-Kalyan" on 11th March 2014 under the leadership of Shri.S.A.Vechalekar and Shri.S.R.Shetty.This Mandal organized total 7 events viz. cultural programmes, picnics etc. to nearby centres for the benefit of local members. Out of these, one programme was at 'Madhav Baug Centre' at Khopoli where the doctors gave information on heart related problems with the help of video. (d) At Dahisar also the local members on 30.10.2010 have formed an club named 'SBI Dahisar Pensioners' Welfare Association' under the leadership of Shri.Hemant Nabar. They are organizing social and cultural activities for the benefit of local members. The Club has also published the Diwali magazine 'Snehbandh'. They also arranged a medical Check-up camp where 100 members took benefits. (e) At Borivali the local members have recently formed an organisation named as "SBI Pensioners' Cultural Organisation", to arrange cultural programmes.
- v) <u>Library at Thane</u>: A library is run in Thane office premises by local members for which few books have been collected from the members as donation. They are collecting Rs.100/- p.a. from each member as subscription and purchasing new books. Many local members are taking advantage of this library. Shri.V.M.Kanhere from Thane is managing the Library activities very efficiently with the help of local Committee Members.

#### IV) Nagpur Zonal Sub-Centre :-

Under the leadership of Shri.V.D.Deshpande, President (since retired due to expiry of term on 14.09.2014 and Shri M.P.S.Sawhney has been elected as President from 14.09.2014) and Shri.Sudhir Agrekar, Secretary, the Nagpur ZSC has progressed very well and have enrolled 154 new members during the year and collected total subscriptions of Rs.1,53,500/- and Donations of Rs.29,112/-, of which Rs.24,000/- are for 'Samvad' and Rs.5,112/- are under 'Miscellaneous' head. This achievement was possible due to the strenuous efforts put in by all the Committee members in general and Sarvashri V.D.Deshpande, M.P.S.Sawhney, S.M.Agrekar, C.N.Vazirani, Vijay Jagdale, A.P.Valokar and Awadhut Rotkar (Wardha) in particular.

The AGM of the sub centre was held on 14.09.2014. The ZSC had arranged few organizational programmes during the year which were largely attended and appreciated by the members.

<u>Wardha Unit</u>: The unit is functioning under the leadership of Shri.A.D.Rotkar who is looking after as Secretary since past many years and conducting usual organizational activities.

This year "Shri N.G.More Service Awards" were given to Sarvashri V.M.Jagadale and Dhananjay Godbole of Nagpur for the good work done by them.

#### V) Panaji (Goa) Zonal Sub-Centre : -

We are glad to note that the Panaji Zonal Sub-Centre is progressing very well under the leadership of Shri.P.M.Narkar, President. It is also noted with great satisfaction that with the active support of late Shri.V.D.Kulkarni, Vice President (Shri Madhav Desai has been co-opted as Vice President after the sad demise of Shri V.D.Kulkarni) and Shri.I.H Dias, Secretary, the regular meetings wereheld at Panaji and Margao and occasional meetings at Ratnagiri, Sawantwadi and Kudal. In all 12 Managing Committee Meetings were held during the year. The Zonal Sub-Centre has enrolled 27 new members during the year. They have collected Rs.24,500/- as subscriptions & Donations of Rs.36,104/- of which for 'Samvad' are Rs.26,844/- and for Legal Fund are Rs.9,260/-. The 16th Annual General Meeting of the Zonal Sub-Centre was held on 6th April 2014, which was attended by about 200 pensioners / family pensioners from Goa as also from Ratnagiri and Sindhudurg Districts.

As informed earlier, our Circle Association has purchased premises at Panaji. The premises are being used as our Holiday Home. During the year ended 31.03.2015 the occupancy of the rooms was fairly good and we have received Rs.83,250/- as room-rent. The total recurring expenditure on account of maintenance of the Holiday Home premises was Rs.11,913/-. With a view to increase the occupancy rate of the Holiday Home, at our requests some of the other Circle Associations have given information in their monthly magazines.about availability of our Holiday Home at Goa for their members also.

There is excellent rapport of Office Bearers of the Zonal Sub-Centre with the Zonal Office functionaries, especially with the DGM (Zonal Office) and other officials of the module. This has helped in getting many problems of the pensioners solved without difficulty which is worth noting. The President Shri.P.M.Narkar follows up personally the pending cases of members with H.R. Department at Corporate Centre and at LHO and solve them to the satisfaction of the members.

#### VI) Pune Zonal Sub-Centre : -

During the last year Pune Zonal Sub-Centre has enrolled 335 new members and collected subscriptions of Rs.3,31,000/- and Donations of Rs.2,38,003/- of which Rs.1,12,185/- are for 'Samvad' and Rs.1,25,818/- are for 'Miscellaneous' purposes. Under the leadership of Sarvashri C. P. Kulkarni, President, V.R. Kulkarni, Secretary, Ashok Pandit, Jt. Secretary and other Unit Secretaries of the Districts, the Sub Centre has made remarkable progress in overall organizational activities. After seggregation of Pune ZSC accounts from H. Q. accounts, Shri.S.K.Purandare is working as Treasurer for ZSC.

The Sub Centre has established excellent liaison with the functionaries of Pune Zonal Office by regularly visiting Z.O. At the request of our Zonal Sub-Centre, Pune Zonal Office has designated one officer to deal with the pensioners' work. There are 6 dispensaries in Pune Zone of which 3 are at Pune city & one each at



Satara, Kolhapur & Solapur. The Sub Centre has also regular contacts with the Chief Medical Officer and any problem in medical facilities is immediately got solved from Zonal Office. It will not be out of place to mention that Sarvashri K.D.Paradkar and Madhukar Palkar, senior members, despite their advanced age, are instrumental in settling some old and new Family Pension cases and large amounts of arrears have been paid by the Bank to such family pensioners and in turn got Donations from such family pensioners for the Association.

Pensioners' Meets were arranged at few branches in the Zone. The active members at all the districts have helped the Association in conducting various activities which resulted in relation building. All the District units are arranging regular monthly meetings.

Ahmednagar: The unit arranged a Hurda-Party and a picnic during the year.

Kolhapur: The unit arranged workshops on 'Internet Banking' and 'Mobile Banking' under the leadership of Shri R.R.Kulkarni. They also organized various programmes and picnics. The active participation of lady members is note-worthy in this Unit.

Satara: The unit's members are helping the Medical Officer for maintaining the records of dispensary on Computer. The Dispensary is working satisfactorily. The Unit has collectively donated Rs. 25,000/- to the Municial Council of Satara for repairing of the cemetery under the leadership of Shri.S.S.Deshpande.

Sangli: The unit conducts regular meetings to solve the problems of the members regarding pension matters. Recently, Shri.Suresh Chhatre, a local Committee Member, helped the local members to get revised family pension advices from the Bank's system.

**Solapur:** The unit had recently with the assistance of the RBO Solapur arranged a programme on 'Internet and Mobile Banking' for our members. They also arrange 'Tilgul' and 'Haldi-Kunku' programme during 'Sankranti' festival every year. In response to our appeal fordonations for 'Samvad', Shri.T.M.Patil, Local Secretary and a Member of Circle Managing Committee took lot of efforts and collected Rs.56,000/- till 31st March 2015. The Association appreciate these efforts. The members of the Unit also donated voluntarily Rs.21,500/- to 'Udyogvardhini', an institution dedicated to the working of social cause.

Pune: The members of local unit are shouldering the responsibility to look after the Association's Head Quarter at Pune. Shri.D.A.Kulkarni, Circle Treasurer, maintains books of accounts and Shri.S.P.Barve is helping him. Shri Avinash Deshpande has been attending the work of entering the data of members in the Computer. The Pune Head Quarter has received direct donations of Rs.4,74,422/- and these comprise of for 'Samvad' Rs.3,59,194/-, 'Samvad' Advertisement - Rs.31,000/-, Legal Fund Rs.501/-, Distress Relief Fund Rs.2,501/-, and Miscellaneous Rs.81,226/-.

The resolutions passed in the above Annual General Meetings containing our various demands which include a good number of common issues have been published in 'Samvad' for Novembar 2014.

In Lucknow on 30.03.2015, the Federation's triennial elections took place and the new Office Bearers were elected unanimously. We are glad to inform that Shri S.B.Gokhale, our President, has been elected as Vice President for a term of three years. We congratulate Shri S.B.Gokhale for his deserving success. This information has also been published in 'Samvad' for April 2015.

#### 12) Structured Meeting with the Bank Management :-

A Structured Meeting at Federation level was arranged by the Bank on 22nd January 2015 at Staff College, Hyderabad in which various issues were discussed. On behalf of our Circle Association the Structured Meeting was attended by Sarvashri S.B.Gokhale, President and Vilas Gandhe, Secretary. The detailed report was published in 'Samvad' for March 2015 giving the responses received from the Bank for the various issues raised by our Federation. However, it is important to note that, unlike in the past, this time the overall response of the Bank's Executives was very positive.

#### 13) Position of our Court Cases :-

i) Our Case No.1875 of 2013: The updates of this case were given from time to time in 'Samvad'. As per latest position the case was, most probably, to be taken for hearing on 18th and 19th of May 2015. (The case has since been adjourned to 29.06.2015)

In this connection we have to advise our members that along with the above case, a case No. W.P.(C) 2353/2014 & CM No.17063/2014 filed by Shri Kiran Kumar Jaipuriar was transferred from Ranchi (Jharkhand ) to New Delhi High Court and was heard along with our case. In this case, the decision was given in favour of the Petitioner and the Court has ordered to include the salary of April 1998 (i.e. the revised salary as per Seventh Bipartite) for computing the pension of the Petitioner. This decision shows a ray of hope for our above case as our case is being heard by the same bench of the Delhi High Court.

- ii) Writ Petition with the Nagpur Bench of Mumbai High Court: The above writ petition seeking family pension @ 30% of pay to all Family Pensioners on the same basis as paid to the Government Pensioners, is pending for final hearing before a bench of single judge.
- iii) Case No W.P.No. 1931of 2002 in Delhi Court: The hearing of our old Writ Petition No.1931 of 2002 has been started and the case is being heard on weekly basis.

#### 14) Acknowledgements: -

We express our deep gratitude to the Bank's Chairman, Managing Directors and the Dy. Managing Director & Corporate Development Officer, Chief General Manager (Personnel) and other Executives at Corporate Centre, as well as AGM (PPG) Dept, Corporate Centre of the Bank for giving us opportunities to discuss with them our problems and difficulties of pensioners and related policy matters.

We are also grateful to the Chief General Manager, the General Managers, the Deputy General Manager & Circle Development Officer at Mumbai LHO for their kind co-operation and sympathetic approach towards the issues of Bank's pensioners.

We thank the Asstt. General Manager, (P&HR), Mumbai LHO, Asstt. General Manager, PPG Dept, Mumbai LHO and their staff for their timely assistance. We are also grateful to the Dy. General Managers of all the

Modules, Asstt. General Managers of all the Regions in all the Modules of the Circle, Chief Managers (P&HR), Welfare Officers, Medical Officers of all Zonal Offices in the Circle whose helpful attitude resulted in solving pensioners' problems.

We are grateful to the Branch Managers of our Vakola (Mumbai) and Dattawadi (Pune) branches and their staff for co-operation in conducting the day to day operations of our Circle Association's accounts. We also thank the Branch Managers of the branches where our Zonal Sub-Centres' accounts are maintained for their co-operation to the office-bearers of our Zonal Sub-Centres.

We are thankful to M/s. A.R.Sulakhe & Co., our Chartered Accountants, who have audited and finalized our accounts in time and also guided us on accounting and investment matters.

Personally, I am grateful to Shri.B.G.Dandekar, former Advisor to the Federation, Shri S.B.Gokhale, President of our Circle Association under whose guidance the Association could achieve greater heights during the year. २१ जून १९३८ रोजी धुळे येथे जन्म झाला. वडील नोकरीनिमित्त १९४० साली पुण्यात स्थायीक झाले. लळिंगकरांचे बालपण, तसेच पदवीपर्यंतचे शिक्षण पुण्यातच झाले. १९५९ साली बी.कॉम झाल्यावर एक-दोन ठिकाणी त्यांनी तात्पुरती नोकरी केली. २ मे १९६१ ला ते स्टेट बँकेच्या पुणे मुख्य शाखेत कॅशिअर म्हणून रुजू झाले. १९७० साली सब्-अकाऊंटंट म्हणून प्रमोशन मिळाल्यावर पुणे सिटी ब्रॅंचला त्यांची बदली झाली. डिसेंबर १९७३ ला ग्रेड-१ चे प्रमोशन मिळाल्यामुळे बाळीवेस (सोलापूर) ला अकाऊंटंट म्हणून नेमणूक व नंतर तेथेच फील्ड ऑफिसर म्हणून २ वर्षे काम केले. १९७७ ला करकंब (सोलापूर) येथे ब्रॅंच मॅनेजर म्हणून बदली. नंतर १९७९ ते १९८१ या काळात, केंद्र सरकारच्या योजन्रेपमाणे उस्मानाबाद येथे सुरू झालेल्या जिल्हा उद्योग केंद्रात 'क्रेडीट मॅनेजर' म्हणून डेप्युटेशनवर त्यांची नियुक्ती झाली. उस्मानाबाद येथे मी 'लीड बँक ऑफिसर' म्हणून कार्यरत असल्याने माझा त्यांचेशी जास्त परिचय झाला. आणि त्यांच्या तेथील मन लावून काम करण्याच्या व सर्वांना आपलेसे करून घेऊन बँकांच्या हिताचे निर्णय घेण्याच्या धोरणाबद्दल खूप कौतुक व समाधान वाटले. त्यामुळे आम्ही 'कौटुंबिक मित्र' होऊन अधिक जवळ आलो. त्यानंतर १९८१ मध्ये कै.पी.व्ही.जठार साहेबांच्या चीफ रीजनल मॅनेजर म्हणून (आताची डी.जी.एम्.पोस्ट) अधिपत्याखाली पुणे झोनल ऑफिसची स्थापना झाल्यापासून १९८४ पर्यंत ते तेथे डेस्क ऑफिसर म्हणून कार्यरत होते. तेथून १९८४ ते १९८६ या काळात पिंपरी-टाऊन शाखेत ब्रॅंच मॅनेजर म्हणून कार्यरत होते. सर्वसाधारणपणे अनुभव असा असतो की बँकेच्या सेंट्रल ऑफिस इन्सपेक्शन डिपार्टमेंट्मधील पोस्टिंग टाळण्याचा प्रयत्न होतो. पण मे १९८६ मध्ये 'स्वेच्छेने' बॅकेच्या इन्सपेक्शन डिपार्टमेंटमार्फत जुलै १९९० पर्यंत चार वर्षे ब्रॅंच सब्-इन्स्पेक्टर म्हणून खूप चांगले काम केले व अन्य सर्कल्समधील वरिष्ठ तसेच अनेक शाखाधिकाऱ्यांकडून आपल्या कार्यशैलीमुळे वाहवा मिळवली. नंतर १९९० मध्ये पुणे मुख्य शाखेत चीफ मॅनेजर (अकाऊंटस्) म्हणून नियुक्ती. नोव्हेंबर १९९३ मध्ये पुणे ट्रेझरी शाखा 'ओपन' करण्यासाठी त्यांची शाखाधिकारी म्हणून झोनल ऑफिसकडून निवड केली गेली. तसेच, बॅकेच्या धोरणानुसार ती कॉम्प्युटराईज्ड करून सर्व गव्हर्नमेंट खात्यांचे काम सुरळीत करण्याचे अत्यंत जिकिरीचे काम स्वत: अथक मेहेनत करून त्यांनी पार पाडले व वरिष्ठांची पसंती मिळवली. शेवटी सप्टेंबर १९९७ मध्ये सर्व्हिस ब्रॅंच (पुणे) येथे मॅनेजर (क्लिअरिंग) म्हणून बदली व तेथूनच जून १९९८ अरवेरी सेवानिवृत्ती. असा हा श्री.लळिंगकर यांच्या बॅकिंग करिअरचा धावता आढावा. या सर्व काळात त्यांनी असंख्य मित्र मिळवले. अर्थात ते लहानपणापासून रा.स्व.संघाचे स्वयंसेवक असल्याने माणसे जोडणे व त्यांच्या बरोबरीने काम करणे हे संघाचे संस्कार त्यांना सर्व्हिस काळात प्रत्येक ठिकाणी काम करत असतांना, तसेच असोसिएशनचे काम करतांनाही उपयोगी पडले. त्याचे प्रत्यंतर आपणांस गेल्या कांही वर्षातील असोसिएशनच्या वार्षिक सभांच्या उत्कृष्ठ नियोजनात पहायला मिळते.

३० जून १९९८ रोजी बॅंकेतून निवृत्त झाल्यावर लगेच दुसऱ्या दिवसापासून असोसिएशनच्या कामात ते रस घेऊ लागले व तेव्हापासून त्या वेळचे सेकेटरी श्री.सी.डी.पारखी व नंतर श्री.व्ही.पी.भावे यांना असोसिएशनच्या कामात मदत करू लागले. त्या वेळचे अध्यक्ष कै.एन.एस.कुलकर्णी व नंतर श्री.बी.जी.दांडेकर तसेच श्री.व्ही.एम.गोखले यांचे मार्गदर्शनाखाली असोसिएशनच्या विविध उपक्रमांमध्ये त्यांनी भाग घ्यायला सुरुवात केली. १९९८ साली असोसिएशनचे ऑफिस 'अनुबंध' सोसायटीतल्या (सध्याच्या) स्वतःच्या मालकीच्या फ्लॅटमध्ये शिफ्ट झाले होते. असोसिएशनच्या सभासदांचे सर्व रेकॉर्ड हे प्रथमपासून लेखी स्वरुपात ठेवले जात असे. श्री.एन.एस.कुलकर्णी यांचे पुढाकाराने असोसिएशनच्या कामासाठी कॉम्प्यूटर व प्रिंटर विकत घेतला होता. पण तो वापरायचे ज्ञान



कुणाकडेच नव्हते. अर्थात बॅकेतसुद्धा त्यावेळी कॉम्प्युटरायझेशनची नुकतीच सुरूवात झाली होती. त्यामुळे त्या आधी निवृत्त झालेल्या कुणाला कॉम्प्युटर वापरता येत नव्हता. आणि ते स्वाभाविकच होते. पण कै.एन.एस.कुलकर्णींच्या प्रोत्साहनामुळे श्री.लळिंगकर यांनी स्वतः कॉम्प्युटर चालवायला शिकून त्यावर काम करायला सुरूवात केली आणि सर्व सभासद रेकॉर्ड ऑफिसमध्ये कॉम्प्युटरवर मेन्टेन करायला सुरूवात केली. तसेच कार्यकारिणीच्या त्रेमासिक सभेत लागणारे विविध रिपोर्टस् कॉम्प्युटरवर तयार करायला सुरूवात केली. आजच्या घडीला सभासद संख्या २०,००० चे वर पोहोचली आहे व ती वाढतच जाणार आहे. पण असोसिएशनचे ऑफिस कॉम्प्युटराईज्ड झाल्याने कोणतीही अडचण येत नाही. याचे सर्व श्रेय निश्चितपणे लिळंगकर यांचेकडेच जाते. गेली कांही वर्षे हे कॉम्प्यूटरवरचे काम श्री.अविनाश देशपांडे करीत आहेत.

श्री.लिळंगकर यांनी कॉम्प्युटरचे तंत्र व मंत्र कुठलाही कॉम्प्युटरचा क्लास न लावता निवृत्तीनंतर आत्मसात केले हे विशेष. गेली ७-८ वर्षे आपल्या 'संवाद' मासिकातील असोसिएशनचा सर्व इंग्रजी व मराठी मजकूर स्वतः घरी टाइप करून, 'संवाद' ची मांडणी/ जुळणी करून तो प्रिंटरकडे नेऊन देत असत. सध्या ह्या कामात ते सेक्रेटरी श्री.गंधे यांना मदत करीत असतात. त्यामुळेच २५ तारखेला 'संवाद'चे छापून तयार झालेले अंक पोष्टात पोहोचतात आणि सभासदांना आठवड्याभरात अंक घरपोच मिळतो. घरच्या कॉम्प्युटरवर बराच वेळ ते असोसिएशनचेच काम करत असतात. असोसिएशनच्या 'ई-मेल'द्वारे सभासदांना मार्गदर्शन करून त्यांच्या प्रश्नांचे निराकरण करत असत. आता हे काम सेक्रेटरी श्री.गंधे करत आहेत.

'हाती घ्याल ते तडीस न्या' हे त्यांच्या नूतन मराठी माध्यमिक शाळेचे ब्रीद वाक्य. त्याचे तंतोतंत पालन करण्याचा श्री.लळिंगकर यांनी आपल्या आयुष्यात पूर्ण प्रयत्न केला. त्यांना उदंड व आरोग्यपूर्ण आयुष्य लाभो व त्यांचेकडून असोसिएशनला व सर्व सेवानिवृत्त सभासदांना मार्गदर्शन लाभो हीच ईश्वर चरणी प्रार्थना.

#### "GOODWILL PACKAGE" FOR SENIOR STAFF PENSIONERS & FAMILY PENSIONERS

- 1. Eliqibility: Pensioners and family pensioners of both IBI & SBI who have completed or will complete 80 (eighty) years of age and remain alive on the 1st July, 2015. In respect of family pensioners, her/his age as on 1 st July, 2015 will determine the eligibility irrespective of age of original pensioner at the time of death.
- 2. Coverage: All the IBI and SBI pensioners who have completed or will complete 80 (eighty) years of age as on the 1st July, 2015 and remain alive on that date will be eligible under the Scheme. However, this will not be applicable for e-SBS & e-SBIN pensioners who retired before merger with SBI and are governed by a separate pension Rules viz. Pension Regulations 1995 as well as e-SBS & e-SBIN family pensioners of deceased pensioners, retired before merger with SBI. This package will also not be applicable for pensioners who took voluntary retirement from service and for family pensioners of deceased voluntary retirees.
- 3. Quantum of one-time lump sum amount:

#### Sub: - "GOODWILL PACKAGE" FOR SENIOR STAFF AND FAMILY PENSIONERS

We refer to our letters dated 14-05-2015 and 15-05-2015 to provide the benefits under the above package to all pensioners aged 80 years and above as on 1-07-2015 including those retired on medical grounds and voluntarily. As the number of such eligible pensioners may be few in number, we trust that the above package would be made available to them in order not to allow them feel disappointed over our Bank neglecting them at their old age.

2. We feel that after the merger of State Bank of Saurashtra and State Bank of Indore, all their employees including their past employees should be considered as members of the family of State Bank of India without showing any discrimination among the employees and pensioners of State Bank of India and those of the above two Associate Banks. We therefore request that all the pensioners of e-SBS and e-SB of Indore aged 80 years and above as on 1-07-2015 may be provided with the benefits under the above package.

#### CIRCULAR NO 6 TO ALL AFFILIATES DATED 12-05-2015

Dear Sir.

Sub:Reckoning of pensionable service from the date of regular appointment and not from the date of Confirmation. Judgement dated 16-02-2015 of the Division Bench of Madras High Court.

We forward herewith for your information a copy of the above judgement directing the computation of pensionable service from the date of regular appointment by our Bank. Under our Pension Regulations, there isa discriminationin the computation of pensionable between the workmen staff and directly recruited officers. Although both of them are appointed on regular basis, the pensionable service in the case of directly recruited officers is computed from the date of their initial appointment, whereas in the case of workmen appointed on regular basis, the pensionable service is computed only from the date of their confirmation. This discrimination is caused on the basis that the workmen staff areadmitted to SBI Employees' Pension Fund only from the date of confirmation.

- 2. The abovejudgement has been pronounced in a Writ Petition filed by a pensioner retired on 15-06-2007 under the Bank's Exit Option Scheme with a pensionable service of 19 years and 9 month. No pension was paid to him by our Bank, as he did not have pensionable service of 20 years. Our Bank declined his request for payment of his pension. He therefore filed a W.P in Madras High Court. His W.P was dismissed by the Single Judge. He thereafter filed his Writ Appeal. His W.A has been allowed by the Division Bench of Madras High Court. As his pensionable service from the date of joining works out to 20 years and three months, as per the above judgement, he is entitled for the eligible pension from our Bank.
- 3. We trust that our Bank will act upon the above judgement and remove the unjust disparity between the regularly appointed workmen staff and directly recruited officer in the reckoning the pensionable service and would put an end to this discrimination.

(We are publishing hereunder a Record Note signed between IBA and the UFBU in r/o 10th BPS) Record Note of Discussions between Indian Bank's Association and United Forum of Bank Unions on the issues and demands relating to retirees of the Banks held on 25th May, 2015 at Mumbai.

In the Charter of Demands submitted by the Workmen Unions/Officers Associations for revision of wages and service conditions, certain demands pertaining to the superannuation benefits/issues of retirees were raised. These issues were discussed in detail on various occasions during course of negotiations on the Charter of Demands. IBA maintained that any demand of retirees can be examined only as a welfare measure as contractual relationship does not exist between banks and retirees. The Periodic wage revision exercise based on mandate from member banks cover only wages and service conditions of serving employees. Retirement benefits are based on service conditions prevailing at the time of retirement of an employee and these do not change with subsequent settlements.

Referring to repeated comparison of pension scheme in banks to Government pension scheme, IBA stated that while the Government pays pension out of Budgetary allocation, bank pension is a funded scheme. At the time of retirement of an employee, the bank is expected to ensure that adequate funding is made for payment of pension/family pension with provision for periodic updation of dearness relief payable. As such there is no provision for updation of pension in banks. Financial implications will need to be fully examined before any change in benefits payable to pensioners can be considered. The following table gives the details discussion/conclusion reached on various

### Change in Life Style with Time

I received an email about a famous writer summing up his life story. His gall bladder was removed confining him to bed for long when he was nearing 60 years of age. Due to advancing age he had to retire from his favourite job. His father died & son failed in medical examination as the son met with an accident in his car. The son was hospitalised for a long time.

His wife presented the story differently. He got rid of the gall bladder which caused pain for many years. At the age of sixty he retired from job with good health giving him an opportunity to write with focus and for peace. His father died at the age of 95 without depending on any one. The same time his son was blessed with new life without getting disability. The mail summarises that it is not happiness that makes us grateful but gratefulness makes us happy.

In the Vedic way of life, a person used to give up household responsibility at about an age of fifty and go to forest as a disciple of a guru. At that stage, a person used to become grandfather. But, now many persons marry at the age of late twenties or thirties. Hence, household responsibilities continue till late sixties or seventies. Thus, 'Vanaprastha' i.e. the third stage in life commences late. Many of us can and have been studying scriptures or articles on scriptures thus turning towards spirituality. At this stage, life should be simplified. On seventy fifth birthday, one gets gifts. To avoid all this I had gone to my younger son who was then in London. At present stage of life though some household responsibilities continue, many would have ceased. Hence, turning attitude for 'Vanaprastha' should commence as early as possible after retiring from regular work.

Right eating for advanced age, suitable exercises which should include morning walk and right thinking must commence. At this stage, it would be alright to give advice to youngsters based on experience but should not impose our ideas on them.

Last stage of life is modern 'Sannyasashram'. It is more important because the end of life would direct beginning of the next life. In this stage of life, one has to achieve inner renunciation and universal love. In other words, it requires both love and detachment. Family expectations have to be changed. Love especially for grandchildren should be there, but at the same time there has to be detachment to have more time for spiritual life.

Meditation, chanting and affirmations are important even during second stage of life i.e. in 'Grahasthashram'. I will also advocate practising 'Hasta Mudra' therapy. But, during the last two stages of life, these are very important. Meditation can't be done for long periods. Chanting and affirmations can be done for longer periods. One of the chants devotees of Yogoda Satsanga Society of India do is 'Jai Guru, Jai Guru, Jai Guru, Jai Paramahansa Yogananda, Jai Guru, Jai' Affirmation practised is, 'Beloved God, I will, will, I will act, guide Thou my will and activity to the right thing that I should do'. The Important aspect to remember is when we get benefits of these techniques, we should be grateful to God and Guru. This will enable us to derive happiness in life. Positive attitude and gratefulness are very important.

Happy New Year किंवा नवीन वर्ष सुरवाचे जावो अशा एकमेकांना दिलेल्या शुभेच्छा कानावर पडल्या आणि मग मीही त्यात मनापासून सहभागी झाले. म्हटलं अरेच्च्या नवीन वर्ष आलं देखील! आता कॅलेंडरचं पान बदलायला हवं. 'कालनिर्णय' आणुन ठेवलयं नवीन वर्षाचं तेच आता भिंतीवर लावायचं. गेल्या वर्षाच्या महत्त्वाच्या नोंदी यावर्षीही हव्यात, त्याही करायच्या असं मनाशी म्हणत उठले अन् कॅलेंडर कुठं बरं ठेवलंय? तेही आठवेना. पण स्मृतीला ताण देऊ लागले तर वेगळ्याच आठवणींची पानं फडफडायला लागली.

ह्या आठवणी मात्र कॅलेंडर या शब्दाने जाग्या झाल्या होत्या. पूर्वी कॅलेंडर किंवा दिनदर्शिका या शब्दाला नुसतं महत्त्वच नाही तर वलयही होतं. अगदी लहापणापासून पाहिलेली आणि मनात ठसून गेलेली अनेक रंगीत, साधी कॅलेंडरं डोळ्यासमोर तरळायला लागली. प्रथम कॅलेंडर आठवतं ते म्हणजे देवांची चित्र असलेलं. त्यावर गणपती, कृष्ण, देवी म्हणजे सगळ्या सरस्वती, लक्ष्मी वगैरे किंवा भोळा शंकर, विठोबा-रखुमाई, रामसीता वगैरे जोड्या तर हमखास असत. पूर्वी प्रत्येक महिन्याला एक चित्र अशी चैन नसे बरं का, तर पूर्ण वर्षासाठी एकच चित्र असे व त्याखाली वर्षाच्या तीनशे पासष्ट दिवसांचा पांढऱ्या चौकोनांचा गद्रा चिकटवलेला असे. पांढऱ्या चौकोनावर ठसठशीत काळया रंगात तारीख व महिना! एक दिवस संपला की दुसऱ्या दिवशी आदल्या तारखेचा चौकोन काढण्यासाठी भांडाभांडी असे. यातील देवही सगळे प्रसन्न दिसत. वर्ष संपल्यावर अशा देवांची चित्रे टाकून न देता नीट जपून ठेवली जात. सगळ्यात जास्त कॅलेंडरं एकत्र बघायला मिळायची ती म्हणजे रसाच्या गुऱ्हाळात!

देवादिकांनंतर वेगवेगळ्या नटनटींनी कॅलेंडर्सचा ताबा घेतला. आवडत्या नटाचे/नटीचे कॅलेंडर मिळवण्यासाठी खटपट केली जायची म्हणजे वर्षभर विनासायास दर्शनसुख घेता येई. गुऱ्हाळात हेमामालिनी शेजारी गणपती तर मुमताज शेजारी हनुमानही असे. पण त्याचे कुणालाच काही वाटत नसे. गुऱ्हाळाची भिंत पूर्ण कॅलेंडर्सनी झाकलेली असे. ही सर्व चालू वर्षाचीच असत असं मात्र नाही हं! रंगाचा खर्च वाचवण्याचा तो एक सुलभ आणि रंगीबेरंगी मार्ग होता.

घरी मात्र नटनट्यांची कॅलेंडर्स आणली तरी ती बाहेरच्या दिवाणखान्यात वगैरे लावायला काही दिवस जावे लागले. कॅलेंडरांची एक मात्र खासियत होती. ती नुसती तारीखवार कळण्यासाठीच नाही तर इतर अनेक कारणांसाठी वापरली जात, जसे दुधाचा हिशेब/महत्त्वाचे निरोप, फोन नंबर वगैरे लिहिणे. नंतरच्या काळात कॅलेंडरची ऐट वाढली म्हणजे बाराही महिन्यांना एकच पान वगैरे गरिबी-काटकसरीतून ते बाहेर पडलं आणि प्रत्येक महिन्याला स्वतंत्र चित्र वगैरे वैभव प्राप्त झालं, व कॅलेंडर्स एरवाद्या विषयाला धरून निघू लागली. शेतकरी बांधवांसाठी/ऋतुनुसार वगैरे असलेली माहितीपूर्ण कॅलेंडरे किंवा सौंदर्य/आहार या विषयांवर स्वतंत्र कॅलेंडरे म्हणजे कसं पुढच्या बाजूला महिन्याचे वार व तारखा तर मागील बाजूस एखादा लेख/काही उपयुक्त टिप्स, एखादं योगासन (सचित्र), रेल्वेचे टाईम टेबल किंवा एखादा पदार्थही. अशी नटलेली कॅलेंडरं फारच लोकप्रियतेला पोचली.

कॅलेंडरांचा आमचा आवडता आणरवी एक उपयोग म्हणजे पुस्तकांना कव्हर घालण्यासाठी. जेव्हा मोठमोठ्या कंपन्या कॅलेंडरचा आपल्या जाहिरातींसाठी उपयोग करू लागल्या तेव्हा त्यांचा आकार, पानांचा गुळगुळीतपणा, आकर्षक छपाई व चित्रे यामुळे ती कॅलेंडरं घरात शोभिवंत वस्तूंची जागा घेऊ लागली. घरातल्या हॉलमध्ये विशेषत: अशी आकर्षक कॅलेंडरं मुद्दाम लावली जात. मुद्दाम आपल्या आवडत्या देवाचे. नटाचे, नटीचे कॅलेंडर आणणे हा सुद्धा एक छंदच होऊन बसला.

पण कॅलेंडर म्हणजे भिंतीवरची वस्तू न राहता टेबलावरची (टेबल कॅलेंडर) मिनी कॅलेंडर अशा अनेक रूपाने समोर येऊ लागली. कॅलेंडर म्हणजे पंचांगाला पर्याय अशीही कॅलेंडरं लोकांना पसंत पडली.

जे.पी.सिंघल, रघुवीर मुळगावकर, एस.एम. पंडित यासारख्या चित्रकारांनी कॅलेंडरवरील चित्रांना सौंदर्य बहाल केले तर राजा रविवर्म्याची चित्रेही कॅलेंडरवर झळकत व सर्वांनाच ती आकर्षित करीत. बदलीच्या निमित्ताने कोकणात असताना हेही पाहिलं की गणपतीच्या वेळी सजावट व आरास करताना कॅलेंडरच्या रंगीबेरंगी चित्रांची महत्त्वाची भूमिका असे. तेव्हाच्या जांभा दगडांच्या भिंतींना ती झाकुन तर टाकीतच पण आराशीत रंगही भरीत.

कॅलेंडरांचं सिनेमासृष्टीशी देखील एक अनोखं नातं होतं. वर्षामागून वर्ष उलटली, महिन्यामागून महिने हे अल्पकाळात प्रभावीतपणे दाखवण्यासाठी एक कॅलेंडर पड्यावर दिसे आणि त्याची पाने फडफडू लागत ती दिग्दर्शकाला अपेक्षित वर्ष किंवा तारीख दिसेपर्यंत! तमाम प्रेक्षकांना ही भन्नाट कल्पना मान्य असे अन् रुचतही असे.

आता मात्र मला हे कॅलेंडरचे दिवस फार उरलेत असे वाटत नाही. आता तारीख/वार/वेळ सगळं, इतकच काय तिथीदेखील दाखवणारे मोबाईल आलेत मग कॅलेंडरची अडगळ वाटते. भिंती कशा दिसायला हव्यात तर प्लेन. त्यावर एखादे ॲंटीक पेंटिंग वगैरे त्याचे खिळे न दिसतील असे लावले जाते. घड्याळही शो-पीस म्हणूनच पाहिले जाते.

नुकतीच एका दुकानात बरीच खरेदी केली तेव्हा दकानदाराने बिलाबरोबर एक वहीच्या आकाराच कॅलेंडर दिलं आणि वाटलं अगदीच काही कॅलेंडरची सद्दी संपलेली नाही. ते आहे अन् राहीलच. कदाचित त्याचे रूपरंग बदलेल पण ते असेलच ह्या ना त्या स्वरूपात!
