संपादकीय

प्रिय सभासदमित्रहो,

२०१६ ह्या नव्या वर्षाचा आरंभ आपल्या दृष्टीने फारच छान झालेला आहे. ह्या नवीन वर्षात महागाई भत्ता चांगलाच वाढलेला आहे. मधुमेहावरच्या वर्षभर लागणाऱ्या सर्व औषधांचे पैसे विमा कंपनी देणार आहे. तसेच आणित्वाणीच्या परिस्थितीत इस्पितळात जावे लागल्यास ऑपरेशन वा इतर खर्च विमा कंपनीच करणार आहे. आपले सर्व सभासद ह्या नवीन विमा योजनेचे सभासद आत्तापर्यंत झाले असतीलच.

आजारपण व कष्टप्रद वार्धक्य कोणालाच नको असते. तर मग आपण कायम आरोग्यसंपन्न कसे राहावे त्यासाठी कोणती काळजी घ्यावी ही आपलीच जबाबदारी आहे. जन्मापासून मृत्यूपर्यंत आपण आपल्या शरीराचे विश्वस्त म्हणजे ट्रस्टी आहोत. परमेश्वर प्रत्येक पक्षाला दाणापाणी पुरवितो. परंतु तो त्याच्या घरट्यात टाकत नाही. ह्याचाच अर्थ ज्ञान सुविधा माहित आहेत मात्र ते मिळविण्यासाठी कष्ट आपणच केले पाहिजेत.

विमा कंपनीचे नुसते हप्ते (प्रिमियम) भरून आपले सर्व प्रश्न सुटत नाहीत. शरीर आणि मन ह्या दोन उपकरणांना उत्तम स्थितीत ठेवण्यासाठी आपणास वेगळेच हप्ते भरावे लागतील. अर्थात् हे शारीरिक व मानसिक आरोग्याचे हप्ते भरणे आपल्याच हाती असते. मात्र कोणत्याही प्रकारचा आळस किंवा हयगय न करता हे हप्ते आपण भरले पाहिजेत. थोडक्यात या हप्त्यांविषयी सांगायचं तर आपण दररोज दिवसातला एक तास शारीरिक स्वास्थ्यासाठी प्राणायाम, सूर्यनमस्कार, योगासने, चालणे ह्यासारखे व्यायाम नियमित केले पाहिजेत. तसेच ह्या वयात योग्य आहार, विश्रांती, झोप ह्याही गोष्टींची काळाजी घेतली पाहिजे. हे जितके सोपे वाटते तितकेच ते अवघड देखील आहे. कारण शरीराला लागलेल्या सवयी यासाठी बदलाव्या लागतील. पण शारीरिक स्वास्थ्यासाठी व आरोग्यासाठी भरावयाच्या या हप्त्यासाठी आपण सदैव दक्ष व तत्पर असावयास हवे.

आता दुसऱ्या म्हणजे मानसिक स्वास्थ्य व आरोग्याविषयीच्या

हप्त्याचे स्वरूप समजून घेणे अवश्य आहे. दुसऱ्या प्रिमियमचे मूल्य फारच मोठे आहे. मानवी मनाला लागलेली सततची नकाराची सवय. निंदा, आळस, भ्रष्टता, स्वार्थ, दुष्टपणा, नैराश्य, भीती, अहंकार अशा नकाराच्या अनेक छटा मानवी मनाने जोपासलेल्या आहेत. हे नकार शरीर व मनावर परिणाम करतात जी मृत्यूची नांदी असते. ह्यावर उपाय म्हणजे कोणाकडून कसलीही अपेक्षा न करता संतुष्ट राहणे. ह्यासाठी प्रेम, श्रद्धा, विश्वास, धैर्य, आदर, कृतज्ञता, नम्रता ह्या गुणांची आपल्याला जोपासना करावी लागेल. अध्यात्मविषयक वाचन ह्याबाबत आपणास उत्तम मार्गदर्शक ठरेल. एक चिनी तत्त्ववेत्ता म्हणतो, “जगातील सर्व संकटे, हेवेदावे, द्वेष परस्परांच्या प्रेमाअभावामुळेच उत्पन्न होतात.” ह्या शरीर व मनाचे परिवर्तन म्हणजेच निष्कलंक शरीरातील परिपूर्ण मन होय. जे परमेश्वराच्या जवळ जाऊ शकते आणि भगवत्प्राप्तीचा आनंद आपण उपभोगू शकतो.

**GROUP MEDICLAIM POLICIES FOR SBI RETIREES
CLARIFICATION**

Please refer to Corporate Centre e-Circular No.CDO/P&HRD-PM/93/2015-16 dated 09-02-2016, wherein in paragraph 3 (page - 2), rationalization of the process for joining Group Mediclaim Policy 'B' by the existing member of SBIREMBS has been advised as under.

STATUS OF SBIREMBS ACCOUNT	LAST DATE FOR JOINING POLICY 'B'
Residual SBIREMBS limit above Rs. 1 lac	Within 3 months from the date when residual limit falls to Rs.1 lac or below by paying full premium

2. Some of the existing members of SBIREMBS have raised doubts as under
 - i. Members whose residual SBIREMBS limit is above Rs.1 lac shall not be allowed to join Group Mediclaim Policy 'B' after 31.03.2016.
 - ii. Members whose residual SBIREMBS limit is above Rs.1 lac are not allowed to join Group Mediclaim Policy 'B' before the date when their residual limit falls to Rs.1 lac or below.
3. In this connection, it is clarified that the existing SBIREMBS members whose residual SBIREMBS limit is above Rs.1 lac can join Group Mediclaim Policy 'B' anytime but not later than 3 months from the date when the residual limit falls to Rs.1 lac or below by paying full premium.
4. All other uninstructions relating to the schemes shall remain the same.
5. Please bring the contents of this e-Circular to the notice of all concerned.

**GROUP MEDICLAIM POLICIES FOR SBI RETIREES
EXTENSION OF LAST DATE OF JOINING BY ELIGIBLE
PAST RETIREES UPTO 30-04-2016**

Please refer to Corporate Centre e-Circular No. CDO/P&HRD-PPFG/105/2015-16 dated 18th March, 2016. Under the scheme, onetime option was given to following category of retirees / spouses to join the Group Mediclaim Policy-'B' during the period 01.01.2016 to 31.03.2016 :

- i. Existing non members of SBIREMBS (with certain exceptions) including spouses of deceased employees and pensioners.
- ii. Existing members of SBIREMBS whose lifetime medical benefit limit has been fully exhausted and / or residual limit has fallen to Rs. 1 lac or below.

2. In this connection, based on the requests and feedback received from various quarters, it has been decided to extend the last date for joining Policy 'B' by above groups of retirees up to 30.04.2016.

3. All branches and offices of the Bank are advised to send communication to all eligible pensioners / family pensioners, who have not joined the policy, regarding extension of the date.

4. All other instructions relating to the scheme shall remain the same.

Proceedings of 29th Annual General Meeting held at Shivaji Mandir, Dadar. Mumbai
on Tuesday the 23rd February 2016

- 1) The Meeting was scheduled to start at 11.00 am. However, due to lack of quorum it was postponed by 30 minutes. At 11.30 am the Meeting began. Shri P.A. Lopes who was on the stage extended a warm welcome to all members attending the meeting. He, thereafter, requested the following dignitaries to occupy the chairs on the dais.
 - i) Shri S.B. Gokhale - President Mumbai Circle & Mumbai Zonal Sub-centre
 - ii) Shri Sahebrao Desai - President, Aurangabad ZSC & Vice-President of Mumbai Circle
 - iii) Shri C.P. Kulkarni - President, Pune ZSC & Vice-President of Mumbai Circle
 - iv) Shri V.V. Gandhe - Secretary of Mumbai Circle Association
 - v) Shri D.A. Kulkarni - Treasurer of Mumbai Circle Association
 - vi) Shri R.S. Rajiwadekar - Principal Secretary, Mumbai Zonal Sub-centre
 - vii) Shri V.R. Kulkarni - Secretary of Pune Zonal Sub-centre
- 2) After the dignitaries occupied their seats, they were warmly greeted with bouquets by Shri S.M. Dharadhar, Vice-President, Mumbai ZSC.
- 3) Sarvashri Madhav Nadkarni & C.N. Date offered prayers to the Almighty Lord Ganesh at the start of the Meeting.
- 4) Shri Lopes on behalf of the entire gathering offered good wishes to the young relatives of the pensioners who were to appear for HSC & SSC examinations. Shri Lopes also read out the messages conveying good wishes for the meeting received from Shri Ashwini Mehra, DMD & CDO, Corporate Centre, Mumbai and Shri.B.G. Dandekar, Advisor to the Association.
- 5) The Meeting thereafter proceeded as per the Agenda.

Agenda Item No.1 : To condole the death of Bank's Pensioners/Family Pensioners/Associate Members whose names have been reported to us after the 25th February 2015 till date of the meeting :

Shri Lopes read out the list of the deceased members & then every one in the Auditorium stood in silence for 2 minutes to offer their respects towards the departed souls.

Agenda Item No.2 : To confirm the minutes of the AGM held on 25th February 2015 :

The Minutes were published in April 2015 issue of Samvad. As there were no suggestions, amendments or queries on the minutes & hence they were treated as confirmed.

Agenda Item No.3 : To honour Senior Members who have completed 75 years of age between the period from 26th February 2015 to the 23rd February 2016 (both days inclusive) :

There were 186 members who were eligible for the honour and out of that 58 were ladies. Nearly 65 members could attend the Meeting. Shri S.B. Gokhale, Circle President, honoured all the present members with a bouquet of flowers & a cheque for Rs.751/-.

The Meeting was attended by nearly 1050 members & hence it was a great feeling to be honoured before such appreciative gathering. Moreover, it amounted to honour for their hard & sincere work put in by them for the Bank. Those whose birthday fell on 23-2-2016 were also honoured. Shri V.M.Kanhere, Librarian of the library at Thane was also honoured.

- 6) Towards the conclusion of the honouring ceremony, Bank's officials arrived & hence the next

items of Agenda were put on hold & Bank's Meet was organized. Shri Lopes requested the following officials of the Bank to come on the stage & occupy the chairs reserved for them.

- i) Shri Asit Nandi - AGM HR Corporate Centre
- ii) Shri C.P. Muley - Manager, PPG Deptt, Corporate Centre
- iii) Shri Ganesh Shetty - AGM PPG Mumbai LHO
- iv) Shri Upasani - Manager, PPG Mumbai LHO
- v) Smt. Binita Shah - Vice President, Anand Rathi Insurance Broker

7) Shri Asit Nandi, AGM (HR) Corporate Centre, Mumbai, who was requested to speak, gave in a nutshell an account of the Structured Meeting held by the Bank with the Federation of SBI PAs. on 29th January 2016 at Staff College, Hyderabad.

Shri Nandi informed the house that the Bank was going in a big way for automation of the work. He also touched the following points :

- a) No new account needed to be opened by a Family Pensioner
- b) Family Floater Group Health Insurance Policy for SBI Retirees.

8) Shri C.P. Muley, Manager, PPG Deptt., Corporate Centre informed the gathering on followings :

- a) Out of nearly 19000 pensioners in Mumbai Circle, nearly 1585 have not submitted their Life Certificates. He, therefore, urged everyone to verify about receipt of pension for February 2016 & if pension is not received, please resubmit the Life Certificate. He further informed that arrangements are being made for biometric submission of Life Certificate from next year and Life Certificate to be linked to 'Adhar Card'. He has also explained about the 'Jeevan Praman' (Life Certificate in Biometric Mode).
- b) All pensioners should keep a regular follow up with their Pension paying Branch for remittance of their Income Tax to GOI, Investment declaration form and submission of Life Certificate.
- c) Bank has opened a new portal for pensioners where no password or no logging-in is required. It gives information about -
 - i) Second Innings
 - ii) Rules and Regulations - PF / Pension
 - iii) e-Circulars - DA etc.
 - iv) Various Application forms
 - v) Grievance Registration
 - vi) Important links

9) Shri Ganesh Shetty, AGM, PPG Dept., LHO, informed that the Bank is in the process of further automation and Mumbai ZO has been selected as a 'pilot' Z.O. Shri Shetty was all praise for the work done by Mumbai ZSC and the Association. He agreed that at times we do take the help of the Association.

As per recent circular No.CDO/P&HRD-PM/77/2015-16 dated 21st December 2015 pensioners were requested to furnish option for commutation on account of revision of pension and an undertaking for recovery for excess payment, if any.

10) At this stage Shri. Ramkumar Sabapati, General Secretary, SBIOA, Mumbai Circle, arrived and he was greeted with a bouquet. He informed that our efforts are to fight the pending issues such as updation of Pension, 100% neutralization of the DA, 30% pension to Family pensioners, change in commutation formula etc. of the pensioners with the management jointly and will be taken after the

financial statements for the year 2015-16 of the Bank are completed. He also lamented that the Finance Ministry officials are not cooperating. He appreciated that the Pensioners' Association has been sharing all the things with their members and he also highly appreciated the hard work being done by S/Shri.S.B.Gokhale, President, Mumbai Circle Pen Assn., and R.S.Rajiwadekar, Principal Secretary of Mumbai Zonal Sub-Centre.

11) Smt. Binita Shah, Vice-President of Anand Rathi Insurance Brokers Pvt Ltd., talked about the new insurance scheme explaining its good features viz. no age limit, all the present diseases are covered, no medical examination, 15% / 25% reimbursement of Domiciliary Treatment and as far as possible no claim would be rejected unless it is scrutinized by the committee. A lunch Break was taken at this juncture.

Agenda Item No. 4 : Committee's report for the year 2015 to be read, discussed and adopted

Shri PALopes enquired with the assembly as to whether anyone has any query on the report. Since no queries were asked the report was treated as adopted.

Agenda Item Nos. 5, 6 & 7 : To discuss recent developments, Speech of Chief Guest & the President :

i) Shri S.B. Gokhale, President, Mumbai Circle as well as Mumbai ZSC gave the following information.

a) A Structured Meeting was held recently by the Bank with the Federation of SBI Pensioners' Associations. The meeting was attended by Shri Gandhe, Circle Secretary. In that Meeting the CDO and Dy MD of the Bank told that the Bank's officials have succeeded in alleviating the misconception about three benefits enjoyed by the Bank pensioners.

b) Further the gratuity being paid to Bank retirees is statutory one and the conversion factor for commutation of pension used for calculation was also adverse in comparison to other Banks.

c) The CDO further informed that the GOI have now agreed to rectify anomalies that exist in our pension since 1986. However, the proposal submitted by the Bank was rejected by the GOI. A special committee was appointed by the GOI to look into the problems of the SBI Pensioners and find solution there of. The first meeting of the committee was held on 29th March 2016 hence our W.P.(C) No.1875 of 2013 was adjourned to 26th April 2016 at the request of GOI.

d) Shri Gokhale further said that SC judgment was expected to be in our favour but delayed by the Govt. then. In fact anomalies that exist in respect of retirees of the 5th, 6th, 7th and the 8th Bipartite retirees, GOI has requested the Bank to submit suitable recommendations for removal of the anomalies. Accordingly Bank submitted appropriate recommendations. We understand that the recommendations were rejected by the GOI.

e) A new Medical Insurance scheme known as "FAMILY FLOATER GROUP HEALTH INSURANCE POLICY for all the retirees" was introduced by the Bank from 1.1.2016.

f) In case the Life Certificate has not been submitted by the pensioner, the pension could be stopped from February onwards henceforth. From next year onwards, the Life Certificate will be uploaded with biometric system and it will be linked to 'Adhar Card'.

12) Shri Vilas Gandhe, Secretary, Mumbai Circle, narrated the various activities undertaken by Association HQs at Pune. The work of registration of newly enrolled members and keeping excellent records is being handled by Shri Avinash Deshpande. The work of monthly publication of 'Samvad' and its distribution etc. (nearly 13,000 copies) is handled by the office bearers of Pune ZSC, whereas Birthday Greetings (monthly around 1650) are regularly being sent by Shri Pramod Chate.

Maintainence of the Association accounts, which is a daily job of 3-4 hours, is being handled meticulously by Shri D.A. Kulkarni, Circle Treasurer. He urged the members to make use of the new portal for the pensioners started by the Bank.

Agenda Item No.8 : Elections of the office bearers of Mumbai ZSC :

The biennial elections of the office bearers & committee members for the period 2016 & 2017 were held. Since few nominations were received for the post of committee member, it was decided to continue the same office bearers & committee members with few changes. Shri.S.M.Dharadhar has been elected as President of Mumbai ZSC. The names of other office bearers and committee members are as under.
