संपादकीय 

प्रिय सभासदमित्रांनो,

प्रसिद्ध ग्रीक तत्त्वज्ञ साँक्रेटिसचे एक वचन आहे, Life unexamined is not worth living म्हणजे जे आयुष्य किंवा जीवन तपासून पाहिले जात नाही ते जगण्याच्या लायकीचे नाही. जरा वेगळ्या अर्थाने आपणाला असेही म्हणता येईल की माणसाने सतत दक्षता बाळगून त्याचे स्वतःचे जीवन तपासून पाहिले पाहिजे अन्यथा ते सार्थकी न लागता फुकट जाईल.

**Disbursement of Arrears -Clarifications
Realignment of pension of 5th.6th & 7th Bipartite Retirees**

We reproduce the queries regarding the captioned subject raised by members & their clarifications given in the Circular issued by SBI Pensioners' Association, Agra Unit for information of our members. - Secretary

Query : By which date the Arrears will be disbursed to all the eligible pensioners?

Clarification : As per information put up by Bank on SBI Times on 22.08.2017, the status of unpaid arrears is as under -

Reasons of non payment of Arrears to number of pensioners are

- 1) PAN / Life Certificate not available with PPG Dept
- 2) Inconsistent / incorrect data with PPG Dept
- 3) In case of Family Pensioners, the above data / files of pensioners is not available with PPG Dept.

Pensioners are requested to please visit pension paying branch with a copy of PAN Card and Aadhaar Card and request the Branch to upload the details in HRMS portal. No firm date for payment of arrears to all eligible can be predicted. However, keeping in view the volume of work and the pace it is being attended the exercise is likely to be completed by September end.

Query : Arrears to family pensioners will be paid from which date to which date?

Clarification : The arrears will be paid from the date of retirement of the deceased pensioner till the date of his death.

Query : In the case of Deceased pensioner to whom the arrears will be paid?00

Clarification : SBI Employees' Pension Fund Regulation 2014 does not have provision of nomination, as such, arrears of deceased pensioners will be paid to his legal heirs. Please note it will not be credited to the account of family pensioner. Please refer to circular dated 22.07.2017 published in 'SAMVAD' August 2017 issue on page No.15. Family members of deceased pensioners are requested to keep ready the required documents like Death Certificate, Legal Heirship Certificate in their own interest to avoid further delay in receiving payment. PAN and Aadhaar may also be required for all family members.

Query : Whether Family pension will also be revised and if so, from which date.

Clarification : The Family Pension in SBI was last revised w.e.f. 01.05.2005 on the basis of Industry Level Formula. Their pension has been fixed on 12 months last drawn average salary of the deceased pensioner, as such, there will be no revision of Family pension at this moment.

Query : 5th Bipartite settlement was for five years from 01.11.1987 to 31.10.1992. 6th Bipartite was made effective from 01.11.1992 for Award Staff and from 01.07.1993 for Officers. Whether the Officers retired between 01.11.992 to 30.06.1993 will be eligible for realignment of pension on the basis of 7th Bipartite Pay Scale?

Clarification : 6th Bipartite Settlement for officers was made effective from 01.07.1993 and the officer retired between 01.11.1992 to 30.06.1993 draw salary applicable to 5th Bipartite pay scale as such they will be treated retirees of 5th Bipartite. As the ceiling

of pension for 5th Bipartite retirees has been increased from Rs. 2400/- to Rs. 3775/- their Basic pension will be realigned with the formula 50% of last drawn average 12 month substantive salary subject to maximum Rs. 3775/-.

Query : What is the benefit available to the 6th Bipartite Settlement retirees.

- Clarification** :
- a) 6th Bipartite settlement for Award Staff was effective from 01.11.1992.
 - b) 6th Bipartite settlement for officers was effective from 01.07.1993.
 - c) Pension on 6th Bipartite Salary was sanctioned to only those who retired on or after 01.11.1993 (Award & Officers both)
 - d) The effective date for sanction of pension on 6th Bipartite Scale for award staff has been shifted from 01.11.1993 to 01.11.1992.
 - e) The effective date for sanction of pension on 6th Bipartite Scale for officers has been shifted from 01.11.1993 to 01.07.1993

Thus the pension of those award staff employees who retired between 01.11.1992 till 1.10.1993 will be revised. Similarly pension of officers who retired between 01.07.1993 to 31.10.1993 will be revised.

Query : Arrears of pension for those retirees whose service for the last 12 months falls in 2 BPS periods. (5th & 6th and 6th & 7th).

Clarification : For those cases bank has to issue a specific circular with method of calculation.

Query : Why Pensioners retired in same scale and with the same basic salary have received different amount of Arrears?

Clarification : While revising pension PQA has not been taken in computation of revised pension while it was included in computation of existing pension. With the result the amount of arrears of those retired officers who are non-CAIIB is more than those who are with CAIIB Part I and similarly amount of arrears of retired officers with CAIIB Part I is more than what retired officers with CAIIB (with Both Parts) has received. (Please see Annexure)

Query : Amount of arrears received is too less as compared to what was expected?

Clarification : PQA and FPA which was taken into consideration while fixing the existing pension was not considered while revising the pension. In case of officers the revised pension has been calculated on average of last 12 months Basic pay ignoring the PQA and FPA components. In the case of Award staff only Basic Pay and Special Allowance has been considered for revising their pension ignoring PQA and FPA which was earlier part of pension fixation. This has resulted in substantial less payment of arrears. The biggest sufferers are Award Staff (Clerical) and officers Scale V and above. The non inclusion of PQA and FPA components for revising the pension of 7th Bipartite retirees appears to be on account of Mumra Committee report which is silent on the issue. **This is a serious Anomaly and should be immediately rectified** for the following reasons :-

- i) As per Bipartite Agreements
 - a) PQA ranks for DA, HRA and superannuation benefits.
 - b) FPA ranks for superannuation benefits. Superannuation benefits includes PF, Gratuity and Pension. Non inclusion of PQA and FPA components in determining the pension is a breach of Bipartite Agreement.

- II) PQA and FPA is included in last 12 months average substantive salary while calculating pension of 6th, 8th, 9th and 10th Bipartite retirees, therefore these components should also be included in substantive salary of 7th Bipartite retirees for determining eligible pension.
- III) The existing Pension of 7th bipartite retirees was sanctioned on 6th Bipartite Scales substantive salary which included PQA & FPA components.
- IV) Bank vide letter No CDO/PM/SM/16/SPL/208 dated 27th April 2015 sought GOI approval for realignment of pension of 7th Bipartite retirees in which the PQA & FPA were included in substantive salary for the purpose of fixation of pension.

Query : Does Bank provide arrear calculation sheet?

Clarification : Yes. Please approach pension-paying branch or your nearby branch and request the concerned officer / staff to provide the calculation sheets which has been loaded on "HRMS Portal" on link <https://hrms.onlinesbi.com/irj/portal>.

Query : What is the method to verifying correctness of arrears paid by Bank?

Clarification : Majority of 7th Bipartite retirees are VRS retirees (i.e. retired on 31.03.2001) Shri. R. SIVAGYANAM(Chennai)& Shri T.V.JAYAKRISHNAN Tiruchirapalli)prepared the calculation sheet to calculate arrears payable to those retired on 31.03. 2001. We are thankful to them for their hard work in preparing calculation sheet for the benefit of SBI Pensioners fraternity and providing it to us. Based on the calculation sheet provided by them, we prepared Adhoc Arrears Payment of 7th Bipartite Retirees (Officers)at a glance from April 2001 to July 2017 which is attached as 'Annexure'. The sheet gives Scale-wise, PQA-wise arrears payable to retirees from 1st April 2001 to July 2017. The retirees should verify Arrears received from the Bank with arrears payable shown in attached sheet and if both the amount tally then arrears paid by the Bank be treated as correct. Please note that the enclosed 'Annexure' is arrears calculation chart of only VRS retirees (officers)i.e. who retired on 31.03.2001 and receiving pension after completion of 30 years of pensionable service. For those who are receiving pension on pro rata pension, amount will vary.

Query : Why pension at the old rate received in the month of August 2017 though Arrears on account of revised pension received up to July 2017?

Clarification : As per the provisions of SBI Employees Pension Fund Regulations 2014, Pension is paid by Trustees of SBI Employees Pension Fund. The Revised pension cannot be paid till Pension Fund regulations are amended and notified in GAZETTE OF INDIA. This process has not been completed so far that's why the pension for the month of July has been paid at old method. However, during the hearing of Federation WP NO 1875/2013 on 22.08.2017 in Delhi High Court, the Bank & Government Counsels submitted that proposed amendment (based on Govt. appointed Committee)to the SBI Employees Pension Fund Regulations would be notified within next 10 to 15 days and therefore sought adjournment which was granted by the Hon'ble Court. As per this submission of Counsels to the court Pension Regulations will be amended by the 1st /2nd week of September2017 and if that happens then revised pension with arrears for August along with 10% withheld arrears will be paid in September 2017.

Query : Why there is no increase in pension for August 2017 (in some cases decrease) though there is an increase of D.A. of 9 slabs

Clarification : For some retirees Income Tax has been deducted. You may check your Pension Slip for the months of July 2017 and August 2017 to know the details.
