Counsel for the respondent Union of India and State Bank of India

state that notification amending the pension regulations was issued on 4<sup>th</sup> October, 2017. Copy of the said notification has been placed on record in W.P.(C) 1875/2013, *Federation of State Bank of India Pensioners Association and Ors. versus the Union of India and Ors.*

Counsel for the petitioners states that in view of the said notification, writ petitions are required to be amended. On oral prayer made by the counsel for the petitioners, we allow the petitioners to amend the writ petitions and challenge, if required, the amended regulations. Amended writ petitions would be filed within a period of fifteen days.

The respondents would file response to the amended writ petitions within three weeks from the date of service of the amended writ petitions. Rejoinder, if any, may be filed within fifteen days after service of the counter affidavit.

List before the Joint Registrar for completion of pleadings, etc. on 13<sup>th</sup> December, 2017.

It may not be possible for this Bench to hear these writ petitions as this is not the regular Bench and as a long date has to be given in view of the above developments and as pleadings have to be completed. In these circumstances, the matter would not be treated as part-heard before this Bench.
