

- * HRMS related issues of members solved at our Pensioners Office personally. Our dedicated committee members visit the residence of the needy members in emergency requirement.
- * CMC has approved the setting up a **Proposed Guest House at Solapur** for visit of pilgrims from various corners of Maharashtra and some part of India. Solapurians in particular and other members in general have contributed around **Rs. 50.00 lacs** as on date.
- * On Appeal from Federation, ZSC Pune have collected donation of Rs. 1.00 lacs and above, till date from members who have benefitted due to revision of pension from ceiling 40% to 50%.
- * A free eye check up program was arranged on 22nd April 2024 by ZSC Pune for the benefit of pensioners and their spouse at AGARWAL'S EYE HOSPITAL, PUNE, more than 86 members had enroled and benefitted at the camp.

Achievement and Events undertaken by Kolhapur Unit

- * The Kolhapur Unit of SBIPA has 834 members registered with it till date. The pensioners meet on 2nd & 4th Saturday of every month at SBI Kolhapur Treasury Branch. The problems, grievances of the pensioners are discussed & they are guided accordingly. In addition, the office bearers regulary visit RBO & some Branches for follow-up of the pending cases.
- * A team is formed to help pensioners & guide them to avail the reimbursement of medical expenses incurred under policy A / B. In case of need the team members visit the residence of the pensioners & help to submit the claim.
- * Last year a drive was initiated for the awareness about the activation of HRMS among the members. From August 23 till jan. 24, most of the pensioners got their HRMS activated. Most of them have got their ID cards ready. This helped enormously while renewing Health assist Policy B. Out of 184 policies to be renewed 182 policies were renewed; out of which 180 policies were renewed online. Only 2 policies were issued manually. A team was deployed at various branches/ centres—for this purpose. In addition 25 new policies were registered. We are constantly emphasizing the need of having policy B among the members.
- * The Samadhan Pakhwada is held regularly at RBO Kolhapur since June 2023. The constant follow up of the problems raised has helped to solve maximum no. of problems.
- * The AGM of Kolhapur Unit was held on 9^{th} October 2023 . About 225 members attended the meeting. Those members who had completed 75 / 80 years of their age during last year, were felicitated.
- * On the occasion of Makar Sankranti, a get together of the pensioners is held every year . This is coupled with the Haldi Kumkum ceremony of the ladies. This year about 130 members attended & enjoyed the cultural program presented by some members.

- * As a part of our duty towards the society, this year our unit contributed for providing Nutritional Diet to the patients suffering from TB. We took the responsibility to provide Nutritional Diet to 20 patients suffering from TB for a period of 6 months.
- * In addition, our members have donated about Rs 1,00,000/- (Rs. One lac) for the proposed guest house at Solapur.

HEALTH CARE POLICY -

(A) SBI Healthcare Policy A

(B) SBI Health Assist Policy B

It is very important for your family members to have the following information about the bank's medical policy.

The Bank has made two post retirement medical policies available to retired pensioners / family pensioners holders i.e. SBI Healthcare Policy A and SBI Health Assist Policy B.

(A) SBI Healthcare Policy A

This policy can be taken within 90 days of retirement or within 4th pension. This policy can be taken after completion of 58 years and 30 years of service in case of normal retirement or voluntary retirement. The premium of this policy has to be paid once and the policy continues for lifetime. Or till the policy amount is exhausted. This policy can be taken for Rs 7, 10, 15 or 20 lakhs and its premium is Rs 1, 2, 3, 3.75 lakh respectively.

Facility of Domiciliary Treatment is available under Policy A. Doctor Consultation Charges, Medicine and Pathological Test etc can be claimed under Domiciliary facility.

Both cashless claim and reimbursement claim facilities are available for hospitalization under Policy A.

For domiciliary treatment only Form "A" claim form has to be filled.

For Reimbursement Claim, A part of the claim form has to be filled by oneself and B part has to be filled by the Hospital.

(B) SBI Health Assist Policy B

The premium of this policy has to be paid within 15th of January every year, that is, this policy has to be renewed every year. In this policy, base policy can be taken for Rs 3 lakh or Rs 5 lakh. Bank pays an additional topup sub-premium of 6 lakhs on this base policy amount. A maximum policy of 25 or 30 lakhs can be taken by paying premium of super topup amount.

Online ordering of medicines under this policy is facilitated by Medibuddy, TATA 1mg, UrLife or PharmEasy. You can order medicines from the pharmacy which you have given while filling the application form of Policy B.

Also, the bank pays 2/3 of the remaining amount of the medicine bill and you have to pay 1/3 of the amount. In this way, you can buy medicines worth a maximum of Rs. 18,000 in a year. Out of this Rs.12 thousand is paid by the bank and Rs.6 thousand has to be paid by you. If you buy medicines worth Rs.18 thousand and above, you will get only 20% discount.

Both cashless claim and reimbursement claim facilities for hospitalization under Policy B are available like Policy A, but no domiciliary facility is available under policy B.

For Hospitalization, policy B should be used first, because policy B is renewed every year and due to this insurance policy is taken for this amount. That amount is available to you every year for sickness. Due to this it is necessary to keep the card of Policy B in a suitable place for emergency. Pensioners who have not taken Policy B can avail Policy A.

Pensioners or family pensioners, both Policy A and Policy B pensioners are available online through our HRMS portal.

Pensioners need to take both Policy A and Policy B after their retirement. This is because there is a limit / cap to the amount that can be obtained from the policy for the following eight diseases.

Procedure for getting admitted in Hospital:

Procedure to get admitted in bank panel hospital (cashless hospitalization).

a. Show your insurance policy card at the TPA Desk of the hospital. How much is the policy a) Show the insurance policy card taken by you at the TPA Desk of the Hospital. Policy holder should not tell the TPA Desk about the policy amount. If Policy A and Policy B are taking both rights, the card of Policy B should be shown. This is because we renew policy B every year so we have policy B income every year. As the premium of Policy A is paid only once, the reduced amount is not available.

- b) The number mentioned in the application form while taking Pensioner/Family Pensioner policy. The reason that the mobile phone should be near you or your relative while coming is that thto Hospital information about the service related to the claim is available on the mobile phone.
- c) After admission to , the hospital TPA Desk of the Hospital sends the initial estimate expenses to the Medi Assist TPA and thus the Medi Assist TPA Gives initial approval.
- d) Charge from Hoi Patel At this time the TPA Desk of Hoi Patel will send the final fee to your Medi Assist TPA.

(Final Bill) is sent. Medi Assist TPA communicates the final approval to the panel.

The difference between the Final Bill and Medi Assist (Final approval) of the Hospital is paid.

The fee must be paid to the payer. All the information (process) Pay Sender/Falk Pay Sender can be viewed on your registered mobile number.

The e-Pharmacy scheme for Policy Year 2024-25 has been re-structured. As per the revised structure of e-Pharmacy Scheme, retirees will have an option to select their preferred e-Pharmacy vendor from a list of four vendors which are as under:

The mobile applications will also have functionality of re-ordering the medicines, without the requirement of re- uploading the previous prescription.

Proportionate billing to members with "self-contribution" and "Bank's contribution" @1:2 ratio subject to maximum "Bank's contribution" during the policy year will be available for online purchase of medicines under the e-Pharmacy Scheme. Members joining SBI Health Assist (Policy 'B') midway during the policy year are eligible for pro-rata amount of "self-contribution" and "Bank's

contribution" based on residual period (in completed months) of the policy year.

- 3. The particulars of members, spouse and disabled child covered under SBI Health Assist policy, along with their Registered Mobile Number, address is being shared with e- Pharmacy vendor. The particulars about e-Pharmacy App is as under:
- (i) Logging into the App of the Service Providers will be based on Registered Mobile Number of the member as per the details available in enrolment data. Once, a member logs into the App, a One Time Password (OTP) will be generated and sent to the mobile number of the member as registered under SBI Health Assist. There is no provision in the App to use one Mobile Number for more than one PF Index Number.
- (ii) The address that has been provided to the Service Providers by the Bank will be displayed by default on the App of the Service Provider. The Apps of the Service Providers have a facility to deliver medicines at other addresses also, which can be recorded by the members in the App of the Service Provider.
- (iii) Any cases of mismatch in Registered Mobile Number, email ID and permanent address may be taken up through concerned Administrative Office with Corporate Centre for rectification only after the same has been rectified in HRMS portal. The e-pharmacy applications have provision of delivery of medicine on a temporary address.

- 6. Other provisions of the scheme will be as under:
 - i) The e-Pharmacy services will start with effect from 22nd January,2024 in respect of users who have registered online and from 26th January 2024 for offline users.
 - ii) In order to indent medicines, members shall have to upload a valid prescription as per the Drugs & Cosmetics Act and Pharmacy Practice Regulation, 2015 which should be clear and legible and must contain name of the retiree and / or spouse/ eligible disabled children (if any) and their age.
 - iii) Validity of a Doctor's prescription will be 180 days for chronic cases and 60 days for acute cases and older prescriptions shall not be entertained and in such a case, member will have to procure new prescription. The Service Providers also have a facility for consulting doctors online in case the prescription is not valid. The service may be used by the members free of cost.
 - iv) Service Provider will provide discount in price on eligible prescribed allopathic medicines @ 20% to members. This said discount will be applicable on MRP printed on the cover of the eligible medicines. The discount rate as above will not be applicable OTC/Consumables/Surgicals and will be different as per the policy of the Service Providers. However, such items are not covered under e-Pharmacy scheme and will be provided upon payment by members. The list of excluded medicines / Pharmaceutical items / Nutritional Supplements / Consumable items which are not covered under the scheme is mentioned in Annexure-I. Any such items, if prescribed and supplied by the Service Providers, will not be eligible for "Bank's **Contribution**" and a separate invoice has to be raised by the Service Providers.
 - v) After receipt of requisition from the member, Service Provider will arrange for a confirmation call to confirm the order and quantity of the medicines. Only after confirmation by the member, order shall be considered for further processing. There are several modes of ordering medicines and under certain modes of order, confirmation call may not be necessary as per the policy of the Service Provider.
 - vi) Payment options available are detailed in the user guide provided by Service Providers.

- vii) TAT for delivery of medicines is different for different PIN codes and will be monitored by the Bank for the Service Provider as per the arrangement with them. Standard TAT is 1- 3 days for certain PIN codes in Metro/Urban areas and 3 5 days for selected PIN Codes in Semi Urban/Rural areas. However, for some PIN codes, the TAT may be upto 10 days also. The list of PIN Codes with TAT and locations covered for delivery of refrigerated medicines are available on Pension Seva Portal. Accordingly, members are requested to order medicines well in advance.
- viii) Members will be allowed to purchase medicines even beyond the limit of Rs. 18,000/- by making full payment from their own sources and the Service Provider will allow applicable discounts on such purchases also.
- ix) Members shall have to show original prescription and valid identification proof during delivery of medicines.
- x) There shall be a provision of cancellation of order by the members. A member can cancel the order till the time status of the item purchased is not showing "Order dispatched" in the App. Cancellation after "Order dispatched" status will attract a penalty of Rs. 100/- (Rupees One Hundred only) which will be recovered from the member by the Service Provider.
- xi) No Service Charges, Fees or any additional expenses should be paid by the members in addition to the amount of the bill raised by the Service Provider.
- xii) Orders can be placed 24x7 i.e. any time during the day and on all 7 days of the week. A member will receive Prescription Validation Call to confirm the order within 4 hours of uploading the prescription on the App. If an order has been uploaded after the operating hours (i.e. after 6 PM), member will receive prescription validation call the next day.
- xiii) Under the e-Pharmacy Scheme, only allopathic medicines will be supplied to the members.
- xiv)Upon delivery of medicines, members should check if correct medicines have been delivered and in case of wrong product delivered, damaged packaging, damaged medicines, medicines expired/near expiry date etc. a complaint must be lodged immediately by email/phone or through the complaint management system in the app. Detailed conditions and process for such returns shall be applicable as mentioned by the Service Providers in their App.
- **XV)** Return of medicines will not be accepted after delivery.
- xvi)Minimum orders to be accepted for invoice value of **Rs.250** (net of applicable discount).
- xvii) The e-Pharmacy Service is being provided by Third Party Entities and

any issues/concerns related thereto need to be taken up with e-Pharmacy vendors. In case, resolution is not provided against the complaint an e-mail should be sent on dedicated email id epharmacy@sbi.co.in accompanied by Order no., Ticket No. or complaint no. provided by the vendor and PF Index.

ASSISTANCE TO RETIRED EMPLOYEES IN CASE OF <u>CRITICAL</u> ILLNESS UNDER STAFF WELFARE ACTIVITIES

{CIR.No. CDO/P&HRD -IR/107/2017-18 DT21.03.2018}

The Bank has introduced a welfare measure for the retired employees of the Bank in the form of assistance to them in meeting their medical expenses to a certain extent in respect of specified diseases

Coverage:

All employees of State bank of India on superannuation from the Bank or those who have taken VRS after attaining 58 years of age, their spouses and disabled children, if any, shall be covered under the scheme. The coverage shall also be extended to family pensioners. The employees who were discharged/dismissed/removed/compulsorily retired/terminated from service will not be covered.

The scheme will cover medical expenses incurred by the retired employees/ family pensioners on or after 1st April of the financial year for critical diseases.

Diseases Covered Medical expenses incurred on critical illness in respect of specified diseases as mentioned below shall be covered.

- 1 Cancer
- 2 Cardiac Surgery/ Serious Heart Ailments
- 3 Kidney/ Liver Transplant
- 4 Dialysis
- 5 Illness/ Accidents of serious nature involving major surgeries/ life support system

Expenses Covered

- In case of retired employees / family pensioners covered under 'Retired Employees Medical Benefit Scheme' / 'Mediclaim Policy for Retired Employees', the Bank Shall provide assistance to the extent of 50% of the medical expenses incurred above the amount payable under the medical scheme / insurance policy. The maximum amount of assistance shall be restricted to Rs. 5.00 lacs.
- ii) In case of retired employees / family pensioners not covered under 'Retired Employees Medical Benefit Scheme' / 'Mediclaim Policy for Retired Employees', the Bank shall provide assistance to the extent of 50 % of the medical expenses incurred above Rs. 3.00 lacs. The maximum amount of assistance shall be restricted to Rs. 5.00 lacs.
- iii) The assistance shall be provided on first come first serve basis, subject to availability of fund.
- iv) The facility can be availed for only one instance per retired employee / family pensioner in a year in respect of specified diseases, post facto.
- v) Any query / clarification shall be issued by the Chief General Manager (HR).

FAMILY PENSION: Family pension in our Bank, introduced from 01.01.1986 to provide relief to the family members of a deceased employee.

INCLUSION OF DISABLED SON / DAUGHTER AS FAMILY PENSION BENEFICIARY – During 1992, our Bank examined the issues having regard to provision for payment of family pension to the disabled children.

Introduction: Nomination

The nomination process for dependent differently abled children of pensioners is a crucial aspect of financial planning and ensuring the well-being of loved ones. Banks play a pivotal role in facilitating this process, providing guidelines, formalities, and necessary forms to make the nomination procedure seamless and efficient.

Understanding the Importance of Nominations:

Nominating dependents, especially differently abled children, ensures that in the unfortunate event of the pensioner's demise, financial support and benefits continue to reach those who need it the most. It provides a sense of security and stability for the dependents, alleviating financial uncertainties during challenging times.

Bank's Role in Facilitating Nominations:

Banks, as custodians of pension accounts, have established procedures and guidelines to assist pensioners in nominating their dependents. These guidelines are designed to streamline the nomination process, ensuring accuracy, legality, and transparency.

Eligibility Criteria:

To nominate a dependent differently abled child, certain eligibility criteria must be met, which may vary depending on the bank's policies. **Common criteria include proof of disability, dependency status, and age restrictions for the dependent child.**

It is observed that many of our members and their spouse are not aware about the inclusion of the disabled Child /children as family pension beneficiary.

Observation – Employees who do not have any disabled child / children are also nominating their spouses for receipt of family pension.

Clarification – Under SBI Family Pension Scheme, spouse of the employee always gets first priority in getting family pension in case of death of the employee while in service or after retirement (if he /she was getting pension) till her / his death or remarriage whichever is earlier.

Nomination of disabled children for the benefit of family pension before retirement.

Only those employees who are having disabled child / children need to nominate as disabled children for the benefit of family pension before retirement. Thereafter on death of spouse or remarriage, the family pension is given to the eldest surviving children in order of their birth. In case the beneficiary is an unmarried daughter, she will be benefitted until she attains 25 years of age or is married or is gainfully employed whoever occurs first.

The members are required to submit the following documents for inclusion of disabled son/daughter as family pension beneficiary.

- 1. Disability Certificate / Disability Identity Card issued by an Government Body like Medical Authority under Department of Empowerment of Persons with Disabilities (Govt. Of India).
- 2. Date of Disability certificate should be prior to date of retirement.
- 3. Disability Certificate from authority not below the rank of Civil Surgeon.
- 4. Certificate for ascertaining 'Inability to earn livelihood due to the disability from the competent authority and the certificate regarding marital status in case of disabled daughter.

After submission of the above documents, the disabled son/daughter will be referred to the Medical Board to ascertain the current status and extent of disability and the capacity to earn a livelihood of the ward. On receipt of the application with all above mandatory documents, the same will be forwarded to the Trustees for approval through the corporate centre.

Nomination of disabled children for the benefit of family pension even after the retirement / Death of pensioner.

We reproduce in brief, the summary of the recent letter dated 26th February 2024 issued by Mr. Dipak Kumar Basu, our beloved General Secretary of Federation of SBI Pensioners' Association to the Dy. Managing Director (HR) & CDO , SBI, Corporate Centre, Mumbai.

It is observed that, two important amendments introduced by the GOI to their family pension scheme vide OM No. 1.80/89 P & PW(C) dated 19.02.1990 and No.1/80/89 P &PW (C) dated 29.05.1991 have been overlooked by the bank while amending the rule 3 (c) of SBI Pension Scheme on the lines of Government of India's family Pension Scheme.

Both the above Office Memorandum of GOI emphasise that -"the condition of manifestation of disability of children before retirement or death in harness of the Governing Servant for grant of family pension for life been dispensed with".

The spirit behind the amendment is to offer humanitarian support and financial assistance to the less fortunate disabled children.

The unintentional omission on the part of the Bank has resulted in denial of opportunities to a good number of pensioner to nominate their eligible disabled children for the family pension.

He also urged upon the Bank to suitably amend the related regulation(s) so that even those ill fated wards of State Bank family, who become victim to physical or mental disability even after retirement of their parent get a chance to live with dignity with the financial provision by the employer of his / her Parent(s).

Hope this will be one more feather in the cap of SBIPA if implemented in true spirit.

BOOKING OF HOLIDAY HOME FROM HRMS: Standard Operating Procedure (SOP)

BANK'S HOLIDAY HOME ROLL OUT OF ONLINE BOOKING FACILITY

[e-circular No. CDO/P&HRD-IR/36/2022-23 dated 30.08.2022]

Revised guidelines for Bank's Holiday Homes. In this connection, we advise that the process of Holiday Home booking has now been automated. The Online booking facility which will enhance transparency in the booking process will be rolled out **w.e.f. 01.04.2023.** This facility will be available to our employees- both serving and retired through HRMS portal.

2. The salient features for Online booking of Bank's Holiday Homes are as under:

A. <u>Booking System:</u>

Date of effective occupancy, if prior to 120th day from 01.04.2023 – Manual (i.e. prior to 28.07.2023 or 28.07.2023)

Date of effective occupancy, if on or after 120th day from 01.04.2023 -- Online (i.e. 29.07.2023 or after 29.07.2023)

B. <u>Eligibility for Holiday Home:</u>

The following person(s) will be eligible for the Bank's Holiday Home Facility:

Serving	Employee & Dependants as per HRMS
Employees	Father, Mother, Son(s) & Daughter(s)
Retired employees	Retired employee & Dependants as per HRMS

C. <u>Maximum duration of stay:</u>

Booking will be automatically confirmed (subject to availability) for a maximum period of 4 days in one instance. In case of a longer period stay (beyond 4 days in an instance) the approval will be accorded by the CWC. In such cases double rent will be charged for the period beyond 4 days. Further, a total of 20 room days will be allowed to any employee retired/serving in a Financial Year.

D. Holiday Home Charges:

The charges for Holiday Home will continue to be as under:

E. Charges and Penalty for Cancellation of bookings:

The booking of Holiday Homes will open 120 days in advance from the date of effective occupancy. No show by the employees, i.e., who neither cancel their booking nor turn up on the effective date of occupancy, at the Holiday Home is one of the major issues. This leads to non-availability of rooms to other aspirants, and the rooms also go unoccupied. This causes resentment among the employees to whom the Holiday Home could not be allotted and gives rise to grievances. To disincentivize these events, following charges will be levied on the employees (both retired and serving) in respect of Holiday Homes:

Cancelled before 15 days of the proposed date of occupancy (Booking charges to be refunded)

- NIL

Cancelled less than 15 days of the proposed date of occupancy (Booking charges not to be refunded)

- NIL

Cancelled 1 day before proposed date of occupancy Rs. 200/-

(Booking charges not to be refunded)

Cancellation on the day or No show on proposed day of occupancy - $\mbox{Rs.}\,500/\mbox{-}$

(Booking charges not to be refunded)

G. Revised terms and conditions for Online Booking are as under:

- ➤ The required fields will have to be inputted in HRMS only, no need for filling any form and sending.
- ➤ Booking charges will be recovered upfront by debiting the salary/ pension account mentioned in HRMS. An OTP will be delivered on the mobile number

mentioned in HRMS and e-mail, which once inputted, will authorise the debit of account.

- ➤ Without submission of OTP (payment of booking charges), the booking of room will not be completed.
- ➤ After deduction of charges, an Auto generated mail on registered e-mail will be sent to the employee, confirming the booking.
- ➤ The upfront booking charges debited will be refunded if the booking is cancelled before 15 days of the proposed date of occupancy.
- ➤ Please note, under any circumstances, <u>booking charges will not be refunded</u> if the booking is cancelled with less than 15 days of the proposed date of occupancy.
- ➤ The booking page of HRMS also include undertaking/ authorisation to debit the account of the employee in case of No Show on the date of booking.
- ➤ The penalty, in case of a No Show will be recovered by CWC. The amount recovered should be <u>credited to 'Holiday-cum-Convalescent Home'</u> of the Circle. Proper record of the same will be maintained for verification and audit purpose.

सोलापूर गेस्ट हाऊस

१२ व्या शतकात सोलापुरात श्री सिद्धेश्वर हे थोर संत होऊन गेले. त्यांचा पदस्पर्शाने पावन झालेली भूमी ही सोलापूरची. सर्व देश ब्रिटिशांच्या ताब्यात असताना त्या पारतंत्र्याच्या काळात दि. ९, १० व ११ मे १९३० असे तीन दिवस स्वातंत्र्य भोगले या सोलापूरच्या भूमीने. त्याची किंमत सोलपूरला पुढे भोगावी लागली. शहरातील चार तरुण स्वातंत्र्र्ययोद्धयांना फाशीची सजा झाली व या शहराला हतात्म्यांचे शहर हि नवी ओळख मिळाली.

बहामनी शासकांच्या काळात १४ व्या शतकात येथील भुईकोट किल्ला बांधला गेला. औरंगजेब व पेशवे यांच्याही ताब्यात हा किल्ला असल्याचे इतिहासातील नोंदी आपणास सांगतात. सोळा गावे मिळून एकत्रितपणे हे सोळापूर जन्माला आले कालौघात ते सोलापूर झाले.

महाराष्ट्रातील प्रमुख शहरापैकी एक म्हणजे सोलापूर. दक्षिण भारतात प्रवेश करण्याचे द्वार हे सोलापूर होय. श्री सिद्धरामेश्वरांची कर्मभूमी असलेले हे शहर चादर व टॉवेल साठी देशभरात नावलौकिक या शहराचा आहे.

महाराष्ट्रात सर्वाधिक साखर कारखाने असलेला जिल्हा ही पण एक ओळख सोलापूरची आहे. सोलापूर जिल्ह्यातील मंगळवेढा हे संत दामाजीपंतांचे स्थान म्हणून जसे प्रसिद्ध आहे तसेच ते ज्वारीसाठीही प्रसिद्ध आहे.

सोलापूर हे मुंबई, बेंगलोर, चेन्नई , हैदराबाद या मध्य रेल्वेच्या मार्गावर वसलेले शहर होय. एकेकाळी मुंबईखालोखाल सोलापुरातील ५ कापड गिरण्या सुप्रसिद्ध होत्या.

धार्मिक व ऐतिहासिक पर्यटनासाठी सोईचे ठिकाण म्हणजे सोलापूर शहर होय.

REVISED SCHEME FOR COMPASSIONATE APPOINTMENT

[Please refer to our e-Circular Nos. CDO/ P&HRD-PM/ 20/ 2011-12 dated 13th May, 2011 & CDO/ P&HRD-PM/ 65/ 2014-15 dated 27th December 2014].

- 2. We advise that the Central Board in its meeting held on 24th February, 2021 has approved the "Revised Scheme for Compassionate Appointment". The scheme will be applicable to a dependent family member of confirmed regular permanent employee of State Bank of India, who; (i) dies while in service (including death by suicide) or (ii) is retired on medical grounds due to incapacitation before reaching the age of 55 years. (incapacitation is to be certified by a duly appointed Medical Board in a Government Medical College/Government District Head Quarters Hospitals/Panel of Doctors nominated by the Bank for the purpose).
- 3. Recently, the Bank has revised the Ex-gratia scheme effective from 01st April, 2020 vide our e-Circular No. CDO/P&HRD-PM/33/2020 21 dated 04th September, 2020. The dependents of the deceased employee can exercise option to choose between "Revised Scheme for Compassionate Appointment" or "Scheme for payment of Exgratia in lieu of Compassionate Appointment" at their choice subject to fulfilling the prescribed eligibility criteria.
- 4. The "Revised Scheme for Compassionate Appointment" will be effective from the date of this Circular. However, the scheme will also cover the death due to COVID-19 with retrospective effect from 24.03.2020 (i.e. the date of announcement of first nationwide lockdown) and the benefit of retrospective implementation will be extended only to the dependents of employees who expired due to COVID-19. During this period, the dependent family members of some of the deceased employees who died due to COVID-19, on or after 24.03.2020 have received Ex-gratia under "Scheme for payment of Exgratia in lieu of Compassionate Appointment". In such cases, the dependent family member, if opts for the "Revised Scheme for Compassionate Appointment", will have to refund the entire amount so received under "Scheme for payment of Ex-gratia in lieu of Compassionate Appointment", subject to his / her application for appointment is approved under the "Revised Scheme for Compassionate Appointment".
- 5. In case an application for compassionate appointment is rejected under the "Revised Scheme for Compassionate Appointment", the same may be considered under the "Scheme for payment of Ex-gratia in lieu of Compassionate Appointment".
- 6. Application for employment under the scheme in respect of eligible cases of death shall be obtained by the branch/office where the deceased employee had last worked. The concerned branch/office shall immediately contact the family of the deceased employee and provide them prescribed applications and complete all necessary formalities in this regard.

7. SBI Scheme for Compassionate Appointment in Exceptional Circumstances & ii) SBI Scheme for Payment of Ex-gratia Lump sum in lieu of Compassionate Appointment (P&HRD/PM/65/2014 -15 dt 27.12.2014 & P&HRD/PM/16/2016-17 dt 06.05.2017) The Scheme for Compassionate Appointment has been further changed Vide Circular No. CDO/Per& HRD-PM/902020-2021 dt 16.03.2021.

Now Compassionate appointment can be sanctioned by the Appropriate Authority in case (i) the employee dies while in Service or (ii) is retired on Medical Grounds due to incapacitation before reaching the age of 55 years.

ii) ex-gratia lump sum: is applicable who died in service and are not eligible for compassionate appointment and employees who retired prematurely before the age of 55 years on medical grounds. The amount of ex-gratia depends on the penury nonns. However, a minimum of 50% of the ex-gratia amount will be paid to dependent family members/retired employees.

PENSION REVISION- REMOVAL OF 40% CAP

On 26^{th} March 2024, Bank issued a circular removing the 40% cap on pay components which is considered for Pension calculation. Though our demand is to give retrospective effect, it is effective from 10.11.2023. Our association too has decided to fight for the retrospective effect. Let us hope that justice prevails soon.

As per earlier rules, there were two caps on pay components for pension calculation.

i)Those whose pay component at the time of retirement was upto a certain amount (it was different for different bipartite periods), were eligible for maximum 50% of pension of their basic pay component.

ii)For those whose pay component was above the limit as mentioned above (detailed in the table below); the maximum admissible pension available was the higher of 50% of the limit as mentioned in the table & 40% of the pay component.

As a result Officers from Scale II onwards were drawing pension at the same rate as that received by a JMGS I Officer who had reached last pay scale in his grade. This provision was for SBI Officers only & they were put to a loss. Bank has revised the pension rules effective from 10.11.2023 & paid the revised pension with arrears in the pension for March 2024. Those who were eligible but did not receive it (due to some technical glitch), received it in April 2024.

However there are various queries & some confusion among the pensioners. The main questions raised are; Why I did not receive the arrears?, Is my new pension correct?, I received less pension than which is due, etc.

The Clerical & Subordinate staff were already getting maximum admissible pension at 50% of their pay component. Similarly JMGS I officers too were getting the maximum admissible pension at 50% of their last pay component. So there was no revision & no arrears.

In case of the Officers whose last basic pay was above the limit mentioned in the table above; they received the revised arrears & revised pension based on the data of their last drawn salary with PPG department.

However the X th & XI th Bipartite retirees need to have a look at the following.

In Xth bipartite an additional increment was given to all officers , notionally from 01.11.2012 but the monetary effect was to be paid from 01.05.2015. So those officers, esp. those who retired within the period 01.11.2012 to 30.04.2015 , should check whether they were eligible for notional benefit of additional increment & apply to PPG through their last Branch & controllers for revising the pension.

e.g. A Scale III Officer retired on 30.04.2015. He had received his 4th stagnation pay on 01.08.2012. So he is eligible for 5th stagnation pay from 01.08.2014 notionally. After removing the 40% cap, he is eligible to draw pension considering 5 th stagnation pay from 01.08.2014 to 30.04.2015. As this data is not with PPG, he has to apply to PPG enclosing a revised statement of Substantive salary for last 12 months.

As per the XI th bipartite, the earlier drawn stagnation increments are to be readjusted with a frequency of 2 years from the date of reaching maximum and the notional effect as on 01.11.2017 is to be arrived at. Notional effect of such readjusted stagnation pay is to be considered for calculation of pension. In case of the Officers who retired within 01.11.2017 & 31.10.2020, though they were eligible for additional notional increment; they did not get their pay readjusted due to 40% cap. In such cases PPG does not have the data of readjusted pay.

Such Officers should check whether they would get the benefit of such readjusted pay & submit the Readjustment Form & the revised statement of Substantive salary for last 12 months to PPG department through their last branch & Controller.

The seventh bipartite retirees are the worst sufferers. The component PQP & increment component of FPP is not considered for pension calculation. The revised circular has mentioned the inclusion of these components for pension calculation. It is learnt that due to some technical reasons , PPG has sought for sanction from Corporate Centre in this regard & will process accordingly after getting it.

Comrades, all are happy after removal of this 40% cap, but let us not forget those who initiated the movement, fought for the cause & left for heavenly abode during this period. Let us unite & fight for the retrospective effect.
