- 1. On behalf of the Managing Committee, I am glad to place before you the Annual Report of the Association for the year ended 31st March 2025.

The Circle Managing Committee is very much thankful to those Office Bearers who have put in sincere efforts to enrol 1248 new members during the year 2024-2025. At present our total membership as on 31-03-2025 is 19124 excluding Associate Members, and with Associate Members, it is 32940. In addition to this, there are 198 pensioners from other Circles/States who are only subscribers of "Samvad . We are sorry to state that during the period under review in all 213 pensioners have left for heavenly abode. As on 31.03.2025 the percentage of our membership to total Bank pensioners is approximately 70%.

The General Secretary stated that more efforts need to be made to achieve the target of at least 75% membership. While taking review of efforts made for enrolling new members during the year, it is pertinent to mention that Shri. Pravin Kulkarni, Circle Secretary and Shri Rajkumar Chhabria, Secretary, Navi Mumbai, have been regularly securing Branch wise lists of would-be retirees quarterly from PPG Department, in advance, these lists are helping the respective ZSCs to enrol new members. All such efforts made by all the Zonal Sub-Centres resulted in enrolling maximum number of retirees as our members. We also appeal to each Member of the Association to enrol at least one new member and help us to achieve the target of 75% of total Bank pensioners.

3. Resources:

Following are the resources for the Association and it is our constant endeavour to meet the expenses from these resources.

- a. Membership Subscription and Admission fee;
- b. Interest earned on Deposits;
- c. Donations under various heads, received from the Members;
- d. Dividend on investments in Shares:
- e. Advertisement income for "Samvad".
- f. Guest House Charges recovered from Guests.
- I. Membership subscriptions are retained as "Trust Fund and are being invested mainly in "Trustee Securities such as Bank Deposits. Our "Corpus has increased by Rs.48,000/- taking the amount of the Trust Fund to Rs.29,80,000/-. Admission Fee of Rs.29,730/-/-.
- ii. The Association has received interest on Bank Deposits (T.D.R. and S. B. Accounts) to the tune of Rs. 31,42,564/-.
- iii. The Members have given aggregate Donations of Rs. 60,95,610 /-, during the year for various purposes.
 - iv. Dividend received is Rs. 37,127/- from investments in SBI shares.
 - v. The receipts under Advertisements for "Samvad" are Rs 9,05,400/-.
 - vi. Guest House charges recovered from Guests are Rs. 7,44,032/-.

4. Donations:

We have been receiving donations under the following heads and the amounts received during the year 2024-25 have been mentioned against these heads.

- (a) "Samvad Donation / Contribution (Rs. 800000/-).
- (b) Misc. Donations (Rs. 6095610/-).

Donations received specially on Federation appeal, against the sanction of 50% pension to all Officers above MM-II and ex-gratia sanctioned against pension updation. The majority donations consists of donations mobilised from members for acquiring Guest House property at Solapur.

5. Meetings of the Circle Managing Committee:

In all 3 Managing Committee Meetings were held during 2024-2025, of which First held at Pune on 9.06.2024, Second meeting held at Mumbai on 19.12.2024 and third one held at Akola on 29.03.2025. Each Meeting starts by paying homage to our deceased Members by observing two minutes silence.

In the first meeting of CMC, during the year 2024-25, which was held in Pune, on 9.06.2024 was held at SBILD, PUNE. The meeting discussed various issues as per agenda items. Solapur Guest House donations mobilised by SBIPA ZSC Pune under the leadership of Shri Suhas Gandi, Secretary was Rs. 48.50 lacs and an additional sum of Rs. 7.50 lacs was sanctioned by Pune ZSC for completion of the project. The progress was satisfactory. There was a good response to the Appeal of Circle Association for donation of one instalment of Ex gratia and Rs. 2000/- per member towards. The date of Golden AGM at Pune was decided as 25/09/2024 and budgeted expense of Rs. 10,00,000/- was also approved by CMC. The name of Shri V.V.Gandhe was unanimously approved for Late Shri L.N.Pabalkar Gold Medal and Shri Shri P.H.Chate and Shri Baviskar of Jalgaon was considered for Late Shri V.V.Gandhe andSmt. Umatai Gandhe Award for the year 2024-25.A special felicitation of Members who have completed 90 years of age was approved by the house. It was decided to present a Shawl, Bouquet and a memento to deliver at his residence.

The Second Meeting was held at M.S.Patel Guest House, Nerul, Navi Mumbai on 19/12/2024. This CMC Meeting happened after the successful Gold Jubilee AGM on 25/09/2024 at Pune. All the members appreciated the efforts of all Pune volunteers under the dynamic leadership of Shri Suhas Gandi. The members also appreciated the smooth and successful conduct of Federation AGM and General Body Meeting in Pune on 24/9/2024 under the leadership of our General Secretary. CMC Members also congratulated.

The house unanimously passed the additional expenses incurred on the Golden Jubilee AGM beyond Rs. 10 lacs already sanctioned. Shri Vishnu Mukim, Circle Treasurer for following up the long pending issue of Income Tax Case pending with the IT Tribunal and getting a refund of Rs. 14.25 lacs as one time settlement. The General Secretary also informed the house regarding remittance of Rs.11.00 lacs to Federation towards our donation. The house also discussed the issue of forming a separate Circle Association for Mumbai Metro Circle instead of Zonal Sub Centre. The General Secretary upheld the feelings and emotions of Mumbai Metro Centre Members and mentioned that we may consider the issue as Agenda item in the next CMC Meeting. A small committee was formed to examine the process of formation and decide on the proposed actions to form a separate Circle Association.

The Third meeting was held at SBLD, Akola on 29/03/2025. Akola unit Office bearers took special efforts to convene the CMC Meeting at SBILD Akola And Shri Deshpande, President conveyed them congratulations for the good job. The meeting in detail discussed the progress and process of Bifurcation of Circle Association and formation of new Circle Association in the name of Mumbai Metro Circle. All the ZSCs put forward their opinions and views. The proposal to form a Mumbai Metro Circle Association was adopted by the house with majority vote. 13 votes were in favour of the said proposal and 5 were against and one ZSC remained absent in the meeting .

The CMC has unanimously accepted a proposal moved by the General Secretary to stop sending birthday greeting cards to members . The voting right of spouse i.e. Associates who are SBI Pensioners

may be permitted and a declaration form has been devised and after getting the said declaration form as approved by the CMC the voting right of the Associate Member (SBI Pensioner) can be restored.

6. 50th Annual General Meeting at Mahalaxmi Lawns, Karvenagar, Pune

- i. The 50th Annual General Meeting of the Circle Association was held on 25th September, 2024 at Mahalaxmi Lawns, Karvenagar, Pune. The meeting was attended by over 2000 members, and it was a Grand Success. The meeting was conducted in a smooth and perfectly disciplined way, and it was a well-managed AGM. Many members appreciated the smooth conduct of the meeting and especially adhering to the time schedule.
- ii. Shri V. V. Gandhe of Pune, was awarded, Late Shri. L. N. Pabalkar Memorial Gold Medal for the year 2023-2024, for his invaluable contribution to the Association. "Late Shri Vasudeo Vithal Gandhe and Late Smt. Umabai Vasudeo Gandhe" Puraskar were awarded to Shri P. H. Chate of Pune and Shri V. R. Baviskar of Jalgaon.

7) Structured Meeting with the Management:

A structured meeting was organised by both the Circles. Mumbai Metro Circle Structured Meeting was organised on 19-03-2025. Shri Amit Jog, DGM & CDO, Shri Sahare, AGM (PPG) and AGM HR and other Officials of (PPG) Department of Mumbai Metro Circle attended the Meeting. All the issues were discussed in detail and the respected DGM & CDO instructed the concerned officers to solve the issues of pensioners on priority. The meeting was a grand success.

A Structured Meeting was also organised for Maharashtra Circle on 10th December 2024. This meeting was inaugurated by Shri Arvind Kumar Singh, DMD and other functionaries like Shri Harish Kumar Rajpal, DGM & CDO, Shri Sandip Kota, AGM PPG and other officials of PPG & HR Department attended the meeting. All the principal office bearers of all zonal sub centres attended the Structured Meeting and the meeting was successful.

8) Legal Requirements:

We have complied with all the requirements of the Assistant Charity Commissioner; Pune and the Changed Reports have been submitted and approved up to the year 2024. We have also complied with the Income Tax Requirement and filed the Return UpToDate.

9) Special Activities:

a. House Magazine "Samvad : - a) We have been publishing our house magazine "Samvad on a monthly basis and sending it to all the Members by post. The magazine is so popular that some of the pensioners from states like Karnataka, Madhya Pradesh, Delhi, Tamil Nadu, U.P., Bihar, etc. have also become subscribers. We are also sending, "Samvad" to all the Office-Bearers and Governing Body Members of our Federation, all the Circle Associations, Office-Bearers of serving staff Federations, Banks, all the Senior Executives at Corporate Centre and at Mumbai LHO for their information.

"SAMVAD is well accepted by Bank's functionaries and other Circle Associations' Office-Bearers as well. "Samvad contains latest news on Federation/Association front, Bank's latest circular instructions relating to pension matters, reports on organisational activities undertaken by our Zonal Sub-Centres and District units, literary works of our members like thought-provoking articles on special subjects/ occasions, narration of self-experiences while in service, small stories, poems, jokes, cartoons etc. We request our members to preserve copies of "Samvad containing important information for their future guidance. The Editorial Committee is also arranging a "Writing Competition for Members and prizes are being awarded at the hands of our Circle President during the Annual General Meeting. From the

interest earned on the donation of Rs.30,000/- given by Shri A. D. Butala, Office Bearer, of Mumbai ZSC, in the year 2015.2016, the prizes for the "Samvad Competition" to the winners are distributed in the name of his mother late Smt. Prabhavati Butala. The Editorial Committee comprising Sarvashri Tarachand Walhe, Sharad Shingvekar, Vasant Dhupkar, Subhash Dharankar, manages the work of editing and publishing the Marathi section of "Samvad every month.

Shri Sharad Sheth, Shri Avinash Deshpande and Shri Vijay Joglekar look after the data entry of all the applications, dispatch of "Samvad", recording change of addresses of the Members and attending to all the complaints relating to non- receipt of "Samvad" etc. We appreciate the dedication of Sarvashri Deshpande, Sheth and Joglekar.

b. Family Floater Group Health Insurance Scheme (Mediclaim) :

SBI Health Assist Policy "A" and "B" have become popular amongst members and the members are opting for online registration of Policy "B" through HRMS. Medical claims during the year 2024-25, have been settled immediately and services of Representative of TPAs and M/s Anand Rathi were exemplary, at all Zonal Sub Centres, and there are no major complaints in this area.

c. E-Pharmacy

The Bank has given an option to our members to select any one of the Pharmacy Vendors, out of four identified for the purpose. We are happy to note that there are very few complaints regarding E-Pharmacy vendors related issues. However availability of all medicine is still a major issue which we have urged the Federation to take up with the Management. The E-Pharmacy service to the pensioners is stabilised to a large extent and the complaints in this area are minimum.

10) Audit of our Financial Accounts as on 31st March 2025:

It is worth mentioning here that the audit of the "Financial Accounts" as on 31.3.25 was completed well in time. This was possible because of strenuous efforts taken by Shri Vishnu Mukim, Treasurer to collect the "Receipts and Payments Statements, other necessary papers/certificates/particulars, in time from the branches where our accounts are maintained and all the ZSCs and getting the same audited from M/s A. R. Sulakhe & Company, Chartered Accountants. The Chartered Accountants have also done the audit in time. Mrs. Swati Rajurkar is helping us to maintain the financial accounts in "Tally with the aid of a computer programme. For this timely work Shri. Shri Sandip Pawaskar, Treasurer, (Mumbai), Shri. Srikant Deshpande, Treasurer, (Pune), Shri. Ashok Nikhar, Treasurer, (Nagpur), Shri Dattaram Shetgaonkar Treasurer, (Panaji-Goa), Shri. Kamalakar Pathak, Treasurer, (Sambhajinagar) & Shri. Sudhakar Ashtewar, Treasurer, (Amravati), Sudhakar Chavan, (Nashik ZSC), Umesh Vyahare, (Nanded ZSC) deserves compliments for their cooperation in the matter. We have implemented a computerised accounting system to replace manual registers on the pilot basis with effect from 1st Jan 2025 and started full-fledged computarised operations from 1st april 2025. Shri Devendra Rajurkar, our System vendor had successfully developed a special accounting software for the purpose. We extend special thanks to him, for the purpose. Accounts of the Association are being maintained in a meticulous, perfect and efficient manner. We therefore, appreciate the efforts taken by Shri Mukim for keeping the books of accounts up to date.

11. Reports from Zonal Sub-Centres: -

- I) Amravati Zonal Sub-Centre: -
- 1. Annual General Meeting & Biennial Elections

The Annual General Meeting was held on 19.06.2024 at Mahendra Lawn, Badnera Road, Amravati, with enthusiastic participation of nearly 300 members. The biennial elections were conducted smoothly, resulting in the formation of a new team of office-bearers, backed by strong member support.

2. Contribution to Souvenir Advertisement Drive

Our ZSC actively participated in the souvenir advertisement campaign initiated by the Circle. Through local efforts, we successfully mobilized a sum of ¹ 36,000/-, contributing to the Circle's fundraising initiatives.

Meetings were organized at all district headquarters to understand member issues and promote awareness of pensioner entitlements.

The Amravati unit held frequent local meetings, ensuring proactive communication with members.

During the year (2024-25) we have been successful in enrolling 666 new members

Healthy Eyes

We have successfully arranged 8 Eye Checkup Camps throughout the Mumbai Zonal Sub Center with the help of Agrawal Eye Hospitals. 234 pensioners/family pensioners took advantage of these camps.

Health First

We had arranged 2 medical checkup camps through Kokilaben Hospitals.

More than 400 pensioners/family pensioners took benefit of these camps.

Donations

We are very much grateful to our pensioners and family pensioners for giving generous donation to the Association. In all 80 members donated an amount of Rs.5,53,070/-.

Transition Training

Bank arranges 2 days training for all categories of staff retiring within next 3 months. The bank invites us for these programmes and allot us two sessions for participation with the participants. We are very much thankful to the bank authorities for acceding to our request to invite spouses also to participate in the programme We discuss with them on various issues including HRMS and insurance policies.

The bank has conducted 14 such session during the period under review and 286 retiring staff took benefit of these training programmes.

DGM Connect

We regularly inform all the pensioners/family pensioners well in advance about this programme which is held on 1st and 3rd Saturdays of each month so that they can present their grievances and get them redressed at the earliest.

Samadhan Pakhwada

The bank arranges these programmes every quarter at all the RBOs/AOs and LHO. We advise all the pensioners/family pensioners the programme details for every quarter well in advance so that they can approach the bank in time to redress their grievance. One of our Managing Committee Members remains present at all the RBOs/AOs and LHO.

Association Office

As you are aware the bank has allotted office space to our Association at LHO at BKC. We are available at the office on Mondays, Wednesdays & Fridays between 11.30 am and 3.30 pm to support our pensioners/family pensioners to attend and sort out any problem faced by them. We also help them in HRMS including preparation of Digital-I-Card.

IV) Nagpur Zonal Sub-Centre:-

During the year the unit has undertaken the following activities.

- 1) Case of adding name of dependent children of Shri Suresh Naidu were represented and finally they were settled and their names have been added in the HRMS.
- 2) Health check camp arranged by Association at Zonal Office with Medi Assist and Anand Rathi Broker in the Month of August 2024.
- 3) Renovation of Dispensary situated at VNIT Branch and providing Refrigerator and sitting chairs. It was also ensured that adequate stock of medicines is also maintained in the dispensaries and also some new medicines were insisted on.
 - 4) Visit to Chandrapur and Bhandara for membership drive and to mobilize members.
 - 5) Payment of Stagnation increments on account of Salary revision to around 10 members.
 - 6) Arrears Payment of Leave encashment to Mrs. Geetha Upalap and Shri Shishir Ninawe.
- 7) Attended Samadhan Pakhwada Meeting at Zonal Office and strongly advocated our problems before the Management and followed up the same.
- 8) Nagpur Pensioners Guest House occupancy rate is around 60%. We are making all out efforts to popularise the Guest House. The Guest House is maintained neat and clean and the guests were happy about the same.

V) Nanded Zonal Sub Centre

Activities in the Nanded Sub-Centre began with the 1st Annual General Meeting for the year 2023-24, arranged at Hotel Visava on 19th April 2024. The meeting was presided over by our General Secretary, Shri Sudhir Pawar. Our Circle Treasurer, Shri Vishnu Mukim, along with our special guests Mr. Ramesh Agrawal and Shri Anil Wadekar from Mumbai, participated in the meeting. Members and office bearers from Nanded, Latur, Parbhani, and Dharashiv regions were present, including members from the Hingoli District.

Regional Manager, Nanded Region, Shri P. Kalidasu, was the Chief Guest of the meeting. Insurance Representative Ms. Rupali Gaikwad, Pharmacist Shri Balraj Lonkar, and Dr. Anil Toshniwal were present at the meeting. Mr. Nikhate, CM (HR), also attended.

Senior citizens above the age of 75 were also felicitated by our General Secretary. Elections were held for the office bearers of the Nanded Zonal Sub Centre for the year 2024-2026 under the supervision of Election officer Mr. N.R. Malu, who declared all office bearers unanimously elected unopposed.

During the year, visits were made to Parbhani and Latur, and meetings were attended. In the Latur meeting, our Shri Sudhir Pawar, General Secretary presided over the meeting. Shri Anil Wadekar was also present to guide participants in respect of HRMS.

Donations by way of advertisements for our Golden Jubilee year Souvenir were collected from our local prominent doctors and industrialists and sent to the Pune office.

On 9th January, the SBI Health Assist / Policy 'B' SBI Healthcare/REMBS renewal camp for 2025-26 was conducted to ensure maximum coverage of members under the health policy. Mrs. Mangai Raju Konar, CM HR (Welfare) LHO, presided over the camp along with CM (HR) Nanded A.O., Manager HR Nanded RBO, and other officials. Pensioners attended in large numbers. This motivated pensioners to opt for the 'B' Policy to protect their health. Our office bearers in Latur, Dharashiv, and Parbhani regions arranged special camps, and an overwhelming response was received at all centres.

In January 2025, a camp was again arranged for Shri Ramesh Agrawal and Shri Anil Wadekar for preparing claims of stagnation increments and updating HRMS for eligible pensioners. This two-day camp was held on 15th & 16th January 2025, where over 100 participants from Nanded, Parbhani, Hingoli, and Basmat placed their claims and then properly prepared for submission. This resulted in pension revisions and considerable arrears being received by some members later.

On 18th January 2025, a historic milestone was achieved by the Nanded Zonal Sub Centre with the inauguration of its beautiful new office accommodation. Our respected General Manager, Net-2, Shri Anirudh Kumar Choudhary, inaugurated the office virtually through the Regional Manager Shri P. Kalidasu, in the esteemed presence of DGM (B&O) Shri Priyakumar Sarigala. The event was also joined virtually by our General Secretary Shri Sudhir Pawar, President Shri Pradeep Deshpande, and Circle Secretary Shri Pravin Kulkarni. In the presence of landlord, Shri Subhash Kadam, Chief Manager Shri Rajiv Kadam, all pensioners, and office bearers from all four regions, along with the working staff of the Nanded region. Office bearers of the Officers' Association, Samadhan Pakwada meetings were conducted regularly every quarter at the centre with local unit members and representatives from other regions. Meetings in Parbhani, Latur, and Dharashiv were organized and attended at least once every quarter. All meetings arranged by A membership drive undertaken during the financial year and added approximately 50 new members to our rolls. The arrears received by members under the 50% pension revision and ex-gratia payments were shared, as per prescribed norms, and promptly contributed to the association's account.

The utilization of our dispensaries has increased significantly. Members from Nanded city and nearby regions are now benefiting in large numbers. Insurance claims are being settled promptly, thanks to the proactive follow-up by our office bearers. Our technical team has been working diligently to assist members with HRMS updates, identity card preparation, submission of life certificates, filing of income tax returns, and even general services like replacing High-Security Number Plates on vehicles.

The felicitation of members for their personal achievements and upon attaining the age of 75 years or more, as well as birthday celebrations, have become regular features of our association's community engagement.

Lastly, to further improve medical accessibility, proposals for new dispensaries at the regional level-specifically in Latur, Dharashiv, and Parbhani have been submitted to the Bank. We are hopeful that these will be sanctioned in the near future.

VI) Nashik Zonal Sub Centre

The second Annual General Meeting of Nashik Zonal Sub Centre was conducted on 06th June 2024 in presence of the General Secretary Shri Sudhir Pawar and other Circle Managing Committee members. Shri Ramesh Agrawal & Shri Anil Wadekar also responded positively to our request and attended the meeting. Around three hundred members of our Association participated in the meeting.

The year 2024-25 was remarkable, exciting and packed with major events.

All the District Units organized Annual Conferences with overwhelming response from the members. During the year under report, all district units under Nashik Zone focused on two key areas:

- 1. A robust membership drive and
- 2. proactive, well-coordinated participation in the quarterly 'Samadhan Pakhwada' at Regional Office /A.O. level.

Samadhan Pakhwada – The General Manager (NW II), Circle DGM & CDO, DGM (B & O) Nashik, All District Regional Managers, Chief Manager (HR & Admin.), Manager (HR) participated in Samadhan Pakhwada held at Nashik Administrative Office.

Major issues were discussed at length is the meeting Majority of the issues were resolved within a months' time.

SBI Health Assist Policy (Policy'B') – All district units arranged special campaign in the respective district's main branch premises, for enrollment/renewal of policy 'B'. Active participation of our office bearers was highly praised by the Bank Management. During the year under report, total 1117 policies were issued / renewed in Nashik Zone.

Organized 'Basant Bahar' - a musical concert by our own members.

Felicitated super senior colleagues who have completed 90 years of age.

Propagated our tie up arrangements with 'Metropolis'. Total 342 members of our Association took advantage of this tie up arrangement.

Our office bearers voluntarily involved in maintenance of patient's record, record of medicines/expired medicines etc. at Bank's dispensary.

Resolution of e-wallet problems by keeping excellent liaison with Apollo Pharmacy outlets.

Regular attendance – The office bearers of Nashik District Unit and Managing Committee Members of Zonal Sub Centre regularly attend the Association's Office thrice a week for three hours at Nashik Main Branch.



III) Fixed Assets

The fixed assets are stated at their written down value.

IV) Depreciation

Depreciation is provided as per the rates specified by the Income Tax Act, 1961, on written down value method.

V) Investments

All Investments are long term and non current in nature and are stated at cost.

VI) Impairment

The carrying amounts of assets are reviewed at each balance sheet date for any indication of impairment based on internal/external factors. Where the carrying value exceeds the estimated recoverable amount, provision for impairment is made to adjust the carrying value to the recoverable amount. The recoverable amount is the greater of the asset estimated net realizable value and value in use. The value in use is assessed on the basis of the reasonable estimate.
